Report on Race Meeting held at the Penola Racecourse

RACE 1 : KATNOOK ESTATE / SABOIS MAIDEN PLATE - 1100 metres

Shortly after the start DEMARUGA STAR (A. Herrmann) bucked for a short distance and as a consequence lost considerable ground. DEMARUGA STAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. D. O'Leary, the Trainer of DEMARUGA STAR, was advised the filly would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race.

RACE 2 : COOPERS BREWERY / SABOIS MAIDEN PLATE - 1700 metres

SKYE LAIRD (P. Marks) and DHARMA QUEEN (H. McKechnie) were slow to begin.

In the vicinity of the 1400 metres SKYE LAIRD (P. Marks) had to be restrained off the heels of ODYSSEO (S. Cahill), which eased momentarily.

NULLARBOR (M. Neilson) raced ungenerously in the early and middle stages of the event.

From the vicinity of the 600 metres to the vicinity of the 200 metres NULLARBOR (M. Neilson) was held up for clear running on the heels of a number of runners. M. Neilson explained he was disappointed for a run from the vicinity of the 600 metres to approaching the 200 metres and it was his opinion he had no other option than to shift to the outside of runners and was from that point able to finish the race off strongly.

RACE 3 : PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1400 metres

Acting on confirmed telephone advice from Mr. A. Peterson, the Trainer of WHAT A SAGA, that his float had mechanical issues en route to the course and he would be unable to arrive by the required time, Stewards withdrew WHAT A SAGA at 12.32 pm.

DELAGO JACK (C. Jones) was slow to begin.

TERRENBELLE (M. Neilson) jumped away awkwardly and shifted in, brushing DANCER'S DREAM (P. Marks).

RACE 3 : PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1400 metres (Cont'd)

In the vicinity of the 1100 metres GINGA GAL (NZ) (H. McKechnie) had to be checked off the heels of DANCER'S DREAM (P. Marks), which shifted in. As a result CHILLICONI (J. Holder), VIDEO GAMES (NZ) (S. Noble) and TERRENBELLE (M. Neilson) were inconvenienced when taken wider on the track. P. Marks pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 27 January and to conclude at midnight on Wednesday, 5 February 2014; a period of four (4) meetings.

DANCER'S DREAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : PRINCE OF WALES HOTEL RATING 0-68 HANDICAP - 1100 metres

MEXICAN MARACAS (S. Cahill) jumped away awkwardly.

P. Marks, the rider of JESSIE CANGO, reported the mare felt uncomfortable in its action over the concluding stages. JESSIE CANGO was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Ms. S. Murphy, the Trainer of JESSIE CANGO, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 5 : PENOLA HARDWARE BENCHMARK 80 HANDICAP - 1300 metres

STRIKER BREAKER (D. Tourneur) knuckled on jumping away.

RACE 6 : SA LIVESTOCK RATING 0-68 HANDICAP - 2100 metres

GIMME SOME SAVINGS (D. Evans) was slow to begin.

BERNIE'S BOY (H. McKechnie) jumped away awkwardly and shifted out, inconveniencing CUTLER (L. Hopwood).

MUSEE D'MODEL (C. Jones) raced ungenerously in the early and middle stages of the event.

GIMME SOME SAVINGS (D. Evans) laid in under pressure in the straight.

RACE 7 : GABRIEL ELECTRICAL CONTRACTORS RATING 0-62 HANDICAP - 1400 metres

JACK'S A TIGER TOO (D. Evans) raced ungenerously for a short distance shortly after the start.

JESTA TIGER (C. Lindop) jumped away awkwardly and shifted in.

DISCO TILLATE (S. Noble) jumped away awkwardly and shifted out, inconveniencing MOST AWESOME (M. Neilson).

JACK'S A TIGER TOO (D. Evans) raced wide without cover throughout the event.

In the vicinity of the 150 metres JACK'S A TIGER TOO (D. Evans) shifted out under pressure, bumping MOST AWESOME (M. Neilson).

DISCO TILLATE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
