Report on Race Meeting held at Ceduna Racecourse
by the Ceduna Racing Club on Saturday, 18 January 2014

RACE 1 : CEDUNA MEAT SERVICE / BANK SA / CEDUNA FOOD & MILK / SABOIS
MAIDEN PLATE - 1000 metres

The start of this race was delayed approximately five minutes to allow PAPAJET to be returned to the tie up stalls and re-saddled following the gelding being presented in the mounting yard without stirrup leathers and irons attached to the saddle. D. Evans pleaded guilty to a charge under AR175(k) in that he was negligent when presenting his saddle to the stable representative without the stirrup irons and leathers he had weighed out with. D. Evans was fined \$100.

WHERE HEARTS LIE (D. Dunn) which was fractious in the barriers, jumped away awkwardly and shifted in and hampered EXALTED OMEGA (K. Brooks).

W. Kerford the rider of DAKOTA CHARLIE which was beaten 25 lengths stated that his mount resented the kick back and in his opinion was disappointing. DAKOTA CHARLIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr D. Carrison, the trainer of DAKOTA CHARLIE, reported that the gelding will be retired.

RACE 2 : MARRIOTT MEATS RATING 0-58 HANDICAP - 1000 metres

EXALTED FLING (D. Dunn) jumped away awkwardly and shifted in, inconveniencing SWEET NEVER (K. Brooks).

Inside the 100 metres BUSTERWABBIT (M. Henderson) shied in away from NO VACANCY (D. Evans).

EXALTED FLING (D. Dunn) was inclined to lay in the straight.

RACE 3 : TOYOTA AUSTRALIA RATING 0-72 HANDICAP - 1200 metres

After weighing out it was established that apprentice K. Brooks had only claimed two of her three kilo allowance. K. Brooks was required to re-weigh and to claim her full three kg allowance. K. Brooks was severely reprimanded under AR92 (12) for failing to claim her full allowance and was told to ensure that she is aware of the weight she is required to weigh out at.

COSTLY ARGUMENT (A. Doyle) jumped away awkwardly and raced greenly in the early and middle stages.

RACE 4 : CEDUNA FORESHORE HOTEL CEDUNA CUP - 1600 metres

THE BIG RED VEE (M. Henderson) was slow into stride and taken wider on the track by its rider. M Henderson stated that his mount had no early pace and directed it to the outside of the track to avoid the kick back. He further stated that in his opinion the gelding was not suited to dirt track racing.

W. Kerford, the rider of YARTERBERY reported that his mount was off the bit throughout the event and didn't travel well at any stage. He added in his opinion the horse felt sound. YARTERBERY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer Mr D.Carrison reported that it was the stable's intention to retire the gelding.

RACE 5 : WCT RURAL RATING 0-58 HANDICAP - 1400 metres

On arrival on course ROAD TO DANTREE was examined by the Club's Veterinary Surgeon who reported the gelding had superficial abrasions to the hind legs and was ruled fit to start.

MILLIGANS (K. Brooks) stuck the gate when leaving the mounting yard and was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to start.

SHE'SMISUNDERSTOOD (W. Kerford) which was fractious in the barriers reared up, became cast and was declared a late scratching at 4:14 pm. Prior to the declaration of Correct Wight, Stewards ordered all bets to be subject to the following deductions: 31 cents in the dollar for the win and 21 cents in the dollar for a place.

RUBY'S ANGEL (C. Forest) and DANCING MARY (D.Evans) which were in the adjacent barrier stalls were both examined by the Club's Veterinary Surgeon and ruled fit to start.

Mr M White, the trainer of SHE'S MISUNDERSTOOD was advised that the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to racing again. Mr White was also advised that a veterinary certificate of fitness would be required prior to presenting the mare for a future race or trial.
