**RACE 1 : AUSTRALIA DAY RACES HANDICAP - 1550 metres**

TRUE SASSO (J. Toeroek) was slow to begin.

Correct Weight for this event was delayed to allow C. Lindop, the rider of the second placegetter WHITE ROE, to view the official footage over the final 100 metres.

WHITE ROE and WHISTLEONBY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : SCHWEPPE'S HANDICAP - 1250 metres**

On arrival on course WISE AND HAPPY was examined by the Club's Veterinary Surgeon who reported swelling over the near fore knee and ruled the gelding unfit. Acting on that advice, Stewards withdrew WISE AND HAPPY at 12.18 pm.

The start of this race was delayed approximately two minutes owing to HEART REEF, which reared and struck its head in its barrier stall after being loaded, being examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

HEART REEF (T. Pannell) shifted out on jumping away and contacted FIGHT TO THE LINE (D. Tourneur), which was tightened onto MARBLE RYE (A. Herrmann), resulting in FIGHT TO THE LINE being hampered and MARBLE RYE being taken wider. Shortly thereafter, FIGHT TO THE LINE shifted in and inconvenienced GRAND GROUP (O. Ay), which had to be steadied. D. Tourneur was reminded of his obligations when shifting ground in future.

TIMELY TRUCE (P. Gatt) hung out from in the vicinity of the 1000 metres and made the turn near the 900 metres very awkwardly. TIMELY TRUCE continued to hang out throughout the event. TIMELY TRUCE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. R. Maund, the Trainer of TIMELY TRUCE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

MARBLE RYE (A. Herrmann) laid in from in the vicinity of the 150 metres.

## **RACE 2 : SCHWEPPE HANDICAP - 1250 metres (Cont'd)**

In the vicinity of the 100 metres NIMASAEL (L. Hopwood), which improved into a run between HEART REEF (T. Pannell) and FIGHT TO THE LINE (D. Tourneur), was momentarily inconvenienced and obliged to steady as FIGHT TO THE LINE shifted in under riding. D. Tourneur was reminded of his obligations when his mounts commence to shift ground.

HEART REEF (T. Pannell) laid out under pressure over the concluding stages.

A. Herrmann, the rider of MARBLE RYE, was accidentally struck on the arm on two occasions by the whip of D. Tourneur, the rider of FIGHT TO THE LINE, over the concluding stages.

FIGHT TO THE LINE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : SPORTINGBET HANDICAP - 1250 metres**

The start of this race was delayed approximately two minutes owing to GOLDEN DANE, which lost its near fore plate en route to the barriers, requiring farrier attention. GOLDEN DANE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

Subsequent to the event GOLDEN DANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 4 : MEETINGS & EVENTS AUST TWO YEAR-OLD PLATE - 1000 metres**

On arrival at the barriers UNCLE KEITHY required resaddling.

Shortly after the start the saddle on UNCLE KEITHY (J. Maund) shifted back.

SILENT WHISPER (J. Bowditch) jumped away awkwardly, shifted in and contacted MAGIC BOY (S. Westover).

ALBORBROWN (J. Holder) was tightened on jumping away between SILVERSANDS (J. Toeroek) and WINESEARCH (B. Claridge), which both shifted ground, and was inconvenienced.

Approaching the 600 metres SILENT WHISPER (J. Bowditch), which raced in restricted room to the inside of ALPHA MATE (H. McKechnie) which shifted in, commenced to lay out when being restrained and was obliged to be steadied off the heels of ALPHA MATE.

SILVERSANDS lost its near hind plate during the event.

SILVERSANDS was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. R. Jolly, the Trainer of SILVERSANDS, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

PIACENZA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 5 : ADELAIDE GALVANISING HANDICAP - 1950 metres**

On arrival at the barriers ELLDAMI required resaddling.

ELLDAMI (D. Tourneur), TEXAN WARNEY (H. McKechnie) and LITTLE ADAM (J. Frew) were tightened on jumping away between SOUTHERN INVASION (O. Ay) and CATON (L. Hopwood), which both shifted ground, resulting in LITTLE ADAM losing its position.

LITTLE ADAM (J. Frew) hung out from in the vicinity of the 500 metres. LITTLE ADAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : BOAG'S DRAUGHT HANDICAP - 1400 metres**

KELLY ROYALE (K. Bishop) was held up for clear running for a short distance shortly after entering the straight.

In the vicinity of the 100 metres KELLY ROYALE (K. Bishop) shifted out, taking KING KEV (J. Toeroek) wider on the track.

BOBCAT (D. Tourneur) shifted out under pressure over the concluding stages, taking SET ON STONE (J. Maund) wider on the track.

DONTMENTIONTHEWAR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. First Aid was administered. Mr. T. McEvoy, the Trainer of DONTMENTIONTHEWAR, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

BOBCAT was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

### **RACE 7 : PAULS HANDICAP - 1000 metres**

Acting on confirmed advice from Mr. P. Stokes, the Trainer of TOO DISCREET, that the filly was lame in the off hind leg and unfit to race, Stewards withdrew TOO DISCREET at 8.20 am.

Mr. R. Jolly, the Trainer of TYPHOON, advised Stewards he would instruct Apprentice J. Toeroek to attempt to obtain a position forward of mid-field with cover.

CASINO WIZARD (C. Lindop) jumped away awkwardly.

Racing between the 900 metres and the 800 metres CASINO WIZARD (C. Lindop) raced in restricted room to the inside of BLUE MAGNATE (A. Herrmann), which shifted in slightly. A. Herrmann was reminded of her obligations when shifting ground in future.

Inside the 800 metres TYPHOON (J. Toeroek) raced in restricted room between SHIP'S CAPTAIN (J. Bowditch), which rolled out, and CASINO WIZARD (C. Lindop), which continued to race in restricted room to the inside of BLUE MAGNATE (A. Herrmann), and was unable to maintain its position.

M. Neilson, the rider of CALIANCO, reported his mount hung out during the event and felt short in its action on pulling up. CALIANCO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CRABBING was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. J. O'Connor, the Trainer of CRABBING, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 7 : PAULS HANDICAP - 1000 metres (Cont'd)**

TYPHOON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : TATSBET HANDICAP- 1000 metres**

SORISAM (J. Holder) jumped away awkwardly and shifted out onto DEBEERSONUS (S. Price), which was taken out onto ALPHA MAN (H. McKechnie), which was taken out onto the heels of AZZCOOL (P. Gatt). As a consequence ALPHA MAN had to be restrained and lost its position.

NORTH BEACH (S. Westover) pulled hard in the early stages of the event and in the vicinity of the 700 metres shifted out and brushed with AZZCOOL (P. Gatt), which was taken wider.

In the vicinity of the 50 metres DEBEERSONUS (S. Price) shifted out and away from ALPHA MAN (H. McKechnie). As a result SORISAM (J. Holder) shifted out and away from DEBEERSONUS and brushed with AZZCOOL (P. Gatt).

SORISAM lost its off hind plate during the event.

J. Holder, the rider of SORISAM, reported the gelding jarred up during the event. SORISAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

H. McKechnie, the rider of ALPHA MAN, reported she had intended to take up a more forward position in running but was unable to do so due to the interference suffered at the start.
