**STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Kingscote Racecourse**  
**by Kangaroo Island Racing Club on Saturday, 25 January 2014**

**TRACK: Good 3**

**WEATHER: Fine**

**Rail: True**

**RACE 1: COOPERS RATING 0-68 HANDICAP - 1215 metres**

MILD MANNERED (D. Tootell) and PELL MELL (C. Forrest) was slow to begin.

From the vicinity of the 800 metres PALLADINO (M. Henderson) was inclined to lay out under pressure.

In the vicinity of the 100 metres PALLADINO (M. Henderson) laid out under pressure and KANGAROO JACK (W. Kerford) laid in under pressure and as a result KANGAROO JACK and PALLADINO made heavy contact resulting in PALLADINO becoming unbalanced for a short distance.

**RACE 2: KILDEA PHARMACHY RATING 0-58 HANDICAP – 1008 metres**

SUBLEE (T. Zanker) was slow to begin.

CALIBRIUM (P. Gallagher) was inclined to lay in under pressure in the straight.

T. Zanker, the rider of SUBLEE reported the mare was inclined to race greenly throughout. SUBLEE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Miss D. Wilson, the trainer of SUBLEE was advised that a veterinary certificate of fitness would be required prior to presenting for a future trial or race.

**RACE 3: SEALINK / SABOIS MAIDEN PLATE - 1008 metres**

GEE I'M GOOD (M. Henderson) was slow to begin.

In the vicinity of the 100 metres WILLSKI (W. Kerford) had to momentarily steady when SUNNY STORY (K. Brooks) shifted in under pressure. K. Brooks was reprimanded and advised to ensure she was clear prior to commencing to shift ground in future.

**RACE 4: INGRAM'S HOME HARDWARE RATING 0-62 HANDICAP - 1750 metres**

ELEGIDO (M. Henderson) jumped away awkwardly.

In the vicinity of the 1500 metres AMICI MIEI (W Kerford) had to momentarily steady and lose its position when ELEGIDO (M. Henderson) hung out marginally and MONSTARHIT (K. Brooks) hung in marginally.

**RACE 5: KANGAROO ISLAND FOOD & WINE ASSOCIATION HANDICAP –  
1360 metres**

PRIME CONTENDER (T. Zanker) which had not had a start for a period greater than 12 months was examined by the Club's Veterinary Surgeon on arrival on-course and was passed fit to race.

The start of the race was delayed approximately four minutes owing to the on-course First Care Ambulance having to attend to an injured stable employee.

EPONA REBEL (D Tootell) was slow to begin.

SCOUSE (K. Forrest) raced ungenerously in the early and middle stages.

**RACE 6: CENTURY 21 KANGAROO ISLAND RATING 0-58 HANDICAP - 1360 metres**

COME ON KAROL (D.Dunn) and CHARTREUSE DAISY (A. Doyle) were slow to begin.

Shortly after the start TIMELYINTERRUPTION (R. Mayers) bucked for a short distance and as a consequence lost ground. Mr J. MacMillian, the trainer of TIMELYINTERRUPTION was advised the mare would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race.

In the vicinity of the 900 metres TIMELYINTERRUPTION (R. Mayers) was inclined to race keenly and shifted into a tight run between NOTHING BY HALF (W. Kerford) and DUKE OF THE CASTLE (M. Henderson). As a result NOTHING BY HALF was severely hampered and lost its position.
