Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 5 February 2014

RACE 1 : THE TERRACE / SABOIS MAIDEN PLATE – 1711 metres

The start of this race was delayed approximately two minutes owing to a mechanical issue with the photo finish operating system.

WILL'S CONQUEROR (NZ) (S. Cahill) and CHARTREUSE DAISY (J. Maund) were slow to begin.

DARK FANTASY (C. Lindop) raced keenly in the early and middle stages.

In the vicinity of the 200 metres FLOW METER (J. Frew) shifted out under pressure brushing STYRIA'S DELIGHT (C. Forrest).

BRIT'S DAUGHTER which performed poorly was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr G Searle the trainer of BRIT'S DAUGHTER was advised the filly must perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

On return to Scale jockey C. Lindop indicated that she would be unable to fulfil her remaining engagements for this meeting due to an injury.

**RACE 2 : GAWLER SOUTH BAKERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE-
1211 metres**

WINSKI (K. Bishop) jumped away awkwardly and shifted out bumping BIAN BRAVE (W. Kerford).

PLANETARY (J. Bowditch) jumped away awkwardly and shifted out bumping MAGIC STING (L. Hopwood) which was taken out. As a result MOLASMO JET (P. Gatt) was momentarily inconvenienced.

**RACE 2 : GAWLER SOUTH BAKERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE-
1211 metres – cont'd**

In the vicinity of the 800 metres TITANIC THOMO (J. Holder) had to check and lose its position when WANA DECISION (T. Pannell) shifted in at the same time as WINSKI (K. Bishop) which was racing ungenerously to the inside of MAGIC STING (L. Hopwood), rolled out marginally. T. Pannell was severely reprimanded and advised in future to take greater care when shifting ground.

Racing to the 700 metres MOLASMO JET (P. Gatt) which was racing ungenerously shifted out and away from the heels of BIAN BRAVE (W. Kerford) and as a result COPPER COAST RAIDA (D. Tourneur) had to steady and lose its position when racing tight between MOLASMO JET (P. Gatt) and LADY SILHOUETTE (S. Price).

WINSKI (K. Bishop) was inclined to lay out throughout the event. WINSKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FACELING which performed poorly was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr G. Searle trainer of FACELING was advised that the filly must perform satisfactorily in an Official Barrier Trial before being presented for a future race.

RACE 3 : MITAVITE/SANDERS BROS / SABOIS MAIDEN PLATE - 1111 metres

On arrival at the barriers CHARLIE'S PRINCESS (D. Evans) required re-saddling.

CHARLIE'S PRINCESS (D. Evans) jumped away awkwardly and shifted in momentarily inconveniencing ROAMING (J. Toeroek).

DISTINCTIVE FLYER (J. Holder) jumped away awkwardly and shifted in bumping STRAVINSKA (J. Maund).

MONICA'S MACHINE (D. Tourneur) jumped away awkwardly and shifted out bumping MAGISUE (O. Ridge) and as a result MONICA'S MACHINE was inconvenienced for a short distance.

From the vicinity of the 400 metres to the entrance to the straight DISTINCTIVE FLYER (J. Holder) was held up for clear running when racing on the heels of CHARLIE'S PRINCESS (D. Evans).

In the vicinity of the 300 metres RAIN ATTACK (S. Price) was momentarily inconvenienced when STRAVINSKA (J. Maund) was taken out by DISTINCTIVE FLYER (J. Holder) which was improving to the outside of CHARLIE'S PRINCESS (D. Evans). J. Holder was reminded of his obligations when shifting ground in future.

On return to Scale J. Toeroek the rider of ROAMING reported his mount was inclined to hang out throughout the event. ROAMING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DON'T CALL ME MISS was examined by the Club's Veterinary Surgeon who reported signs of mild heat stress. First Aid was administered.

RACE 4 : JARVIS ISUZU FOUR-YEARS-OLD & OVER RATING 0-62 HANDICAP - 2122 metres

Shortly after the start STAKHANOVITE (L. Hopwood) was inconvenienced when racing tight between RAND AL THOR (S. Price), which shifted out and away from SONG OF THE SANDS (J. Maund) and FLASH MICK (B. Hoppo) which shifted in marginally.

In the vicinity of the 900 metres FLASH MICK (B. Hoppo) hung in momentarily and had to steady off the heels of KELLERMAN (J. Holder).

In the vicinity of the 700 metres SOUTHERN INVASION (O. Ay) raced ungenerously for a short distance and improved onto the heels of JANICE MAY (P. Gatt) and as a result shifted wider on the track inconveniencing STAKHANOVITE (L. Hopwood) and FLASH MICK (B. Hoppo) which were taken wider.

ENDURO (NZ) lost its off fore plate during the event.

ROYAL BUTLER lost its off hind plate during the event.

RACE 5 : KINGSFORD HOTEL RATING 0 – 62 HANDICAP - 1111 metres

On the arrival at the barriers BELLE DIVA was examined by the Club's Veterinary Surgeon who reported the mare to be short behind. Acting on that advice Stewards withdrew BELLE DIVA at 2:58 pm.

SECRETMENSBUSINESS (T. Pannell) was slow to begin.

GENERAL ORDERS (J. Bowditch) over-raced in the early stages when the gelding was being restrained.

RACE 6 : SPORTSBET.CO.AU TOP TOTE PLUS CLASS 2 HANDICAP - 1211 metres

The start of this race was delayed approximately three minutes when ATHLETICISM proved difficult to load. Mr B. Smith, representing Mr. J. Smith, the trainer of ATHLETICISM was advised a warning had been placed on the gelding in regards to its loading manners.

On arrival at the barriers HIGHLAND HENRY required re-saddling.

HIGHLAND HENRY (C. Forrest) jumped away awkwardly and shifted in bumping HAPPY SYMBOL (J. Frew).

In the vicinity of the 300 metres to the vicinity of 100 metres ATHLETICISM (J. Holder) was held up for clear running when racing on the heels of HAPPY SYMBOL (J. Frew) and to the inside of MIME (K. Brooks).

Shortly after HELLO DUBAI (J. Maund) had to steady and lose its position when ATHLETICISM (J. Holder) shifted in to improve to the inside of HAPPY SYMBOL (J. Frew) at the same time as BURN SO BRIGHT (NZ) (A. Herrmann) was inclined to shift out marginally under pressure. Shortly after BURN SO BRIGHT (NZ) had to ease and lose its position when ATHLETICISM (J. Holder) continued to shift ground inwards. As a result FOREST ELBOW (T. Pannell) which was racing to the inside of BURN SO BRIGHT (NZ) (A. Herrmann) was momentarily inconvenienced. J. Holder was severely reprimanded and advised in future to take greater care when shifting ground.

In the vicinity of the 100 metres A. Herrmann the rider of BURN SO BRIGHT (NZ) accidentally dropped her whip. A. Herrmann was reprimanded under AR137(a) for carelessness.

RACE 7 : JACOBS CREEK RATING 0 – 62 HANDICAP - 1711 metres

BEGOR I'M SURE (M. Neilson) raced three wide without cover in the middle stages.

On return to Scale M. Neilson the rider of BEGOR I'M SURE reported that in his opinion the gelding resented the tongue tie. BEGOR I'M SURE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : COOPERS / SABOIS FILLIES & MARES RATING 0 – 68 HANDICAP – 1511 metres

On arrival at the barriers ABBA which kicked the running rail was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

CHOISELLE (A. Herrmann) was slow to begin and raced ungenerously in the early stages.

TRUE SASSO (K. Brooks) pulled hard in the early and middle stages.
