**RACE 1 : COATES HIRE / SABOIS TWO-YEAR-OLD HANDICAP - 1000 metres**

On arrival at the barriers FLIGHT OF TERROR was examined by the Club's Veterinary Surgeon who passed the gelding fit to start.

ORIDANE (S. Westover) and FLIGHT OF TERROR (K. Bishop) brushed on jumping away.

BLUESWAY (M. Henderson) began extremely awkwardly and lost ground.

ORIDANE (S. Westover) raced keenly in the early and middle stages.

For some distance from the 850 metres RUBY AMOUR (K. Brooks) was hampered when racing inside ORIDANE (S. Westover) as S. Westover attempted to move that runner towards the fence. S. Westover was advised against this practice.

ARTFUL FRANCYL (P. Roff) raced greenly under pressure in the straight.

Inside the 300 metres ARTFUL MONTY (L. Hopwood) laid in under pressure, was obliged to be steadied off the heels of ARTFUL FRANCYL and raced greenly for some distance.

M. Henderson, rider of BLUESWAY stated that his mount began very awkwardly and raced very greenly throughout the event.

BLUESWAY which was beaten approximately 30 lengths was examined by the Club's Veterinary Surgeon who reported the filly to have sustained bruising and mild lacerations to the inside of its mouth. Ms A. Morrison, the trainer of BLUESWAY was advised that the filly must perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

**RACE 2 : SHARP SHOOTING PHOTOGRAPHY / SABOIS MAIDEN PLATE - 1200 metres**

On arrival on-course WESTERN BOY was examined by the Club's Veterinary Surgeon who ruled the gelding fit to start.

**RACE 2 : SHARP SHOOTING PHOTOGRAPHY / SABOIS MAIDEN PLATE - 1200 metres – Cont'd**

SOCIAL SET (P. Roff) began awkwardly and lost ground.

NASTRADA (D. Tourneur) dipped for no apparent reason shortly after the start and raced ungenerously for a number of strides.

WESTERN BOY (M. Neilson) raced ungenerously in the early stages.

O. Ay, the rider of MISS BELLARAE reported that with blinkers on for the first time, he anticipated his mount would settle closer than had eventuated and after testing his mount on straightening, he was of the opinion that the mare may have gone amiss and did not ride his mount along from that point. MISS BELLARAE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : COMPLETE BUSINESS & ACCOUNTING SERVICES RATING 0-68 HANDICAP - 1360 metres**

SNIP IN TIME (T. Pannell) was hampered on jumping away when ARTIE'S ANGEL (L. Hopwood) shifted in and tightened that runner onto EXTREME VALUE (R. Roff).

ARTIE'S ANGEL (L. Hopwood) raced greenly in the early and middle stages.

HEZA HUSSLER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Ms A. Morrison, the trainer of HEZA HUSSLER was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 4 : MIKE RALEIGH MOTORS RATING 0-62 HANDICAP - 1200 metres**

After being loaded into the barrier stalls, DESTONY HAWK became fractious, reared up and kicked out severely. DESTONY HAWK was declared a late scratching at 4:59 pm on veterinary advice. Ms J. Branford, the trainer of DESTONY HAWK was advised that the mare must load satisfactorily and prove tractable in either an Official Barrier Trial or an Approval to Race Jump Out prior to accepting for a future event. DAZZLING LILLY which was in the barrier stall adjacent to DESTONY HAWK was examined by the Club's Veterinary Surgeon who ruled the mare fit to start.

DAZZLING LILLY (S. Price) rolled out rounding the home turn and brushed MORE READY (M. Henderson).

M. Henderson, the rider of MORE READY reported that after receiving a brush on the home turn his mount rolled out and took some time to re-balance.

HAPPYENDO was examined by the Club's Veterinary Surgeon who reported the gelding to be displaying an irregular heart beat and abnormal gait. Mr T. Montgomerie, trainer of HAPPYENDO, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing to the satisfaction of Stewards in an Official Barrier Trial, after which it is to be auscultated by a Veterinary Surgeon.

ROULETTE PRINCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : VAL HANCHANT MEMORIAL BENCHMARK 80 HANDICAP - 1200 metres**

PROPSHAFT (W. Kerford) was slow to begin.

BLACK BARRA (D. Dunn) over-raced in the early and middle stages of the event.

HANK'S NEPHEW (K. Brooks) hung out making the home turn.

**RACE 6 : DELACOLLINE ESTATE WINES RATING 0-68 HANDICAP - 1000 metres**

THE HEADLINER was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to start.

SON OF A GUN (P. Roff) and SUTANOC (A. Herrmann) were tightened on jumping between AFTONLAND (S. Westover) and GOOD CONDUCT (L. Hopwood) which both shifted ground.

Inside the 900 metres SOUND OF VICTORY (W. Kerford) shifted out taking KOODA WONDER (K. Bishop) out onto SUTANOC (A. Herrmann) which became awkwardly placed on the heels of GOOD CONDUCT (L. Hopwood). Shortly thereafter GOOD CONDUCT shifted in towards TINTAGEL ROCKER (M. Neilson) and as a result GOOD CONDUCT got its head up and raced ungenerously.

**RACE 7 : DEL GIORNO'S CAFÉ & RESTAURANT BENCHMARK 80 HANDICAP  
- 1750 metres**

PRIMAL INSTINCT (A. Herrmann) bounded on jumping away and as a result A. Herrmann became unbalanced.

Shortly after the start CORDUROY (S. Price) shifted in despite the efforts of its rider, taking EBONY ROCK (S. Cahill) in.

ARTFUL TERRA (L. Hopwood) over-raced while being restrained in the early stages.

Inside the 1000 metres EBONY ROCK (S. Cahill) brushed the running rail and as a result its saddle shifted back slightly.

M. Pegus, the rider of HASTEIN (NZ) reported from the wide barrier and with genuine speed in the race he elected to take a position at the rear of the field. M. Pegus further stated that as the gelding was stepping up to 1750 metres for the first time this preparation, it should derive benefit from the run. HASTEIN (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : MARCHSPREADERSALES.COM.AU RATING 0-62 HANDICAP - 1750 metres**

MEMORY COVE (O. Ay) and MONTALTO (P. Roff) both shifted ground at the start tightening VOODOO BLACK MAGIC (M. Henderson) and SAREM (W. Kerford).

In the vicinity of the 1000 metres MONTALTO (P. Roff) changed stride and shifted in momentarily taking LAMU LAD (S. Westover) in onto CAPTAIN PERCY (L. Hopwood). As a result CAPTAIN PERCY was obliged to be checked and lost its position.
