Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Wednesday, 26 February 2014

<u>RACE 1 : GAWLER SOUTH BAKERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE</u> – 1514 metres

In the vicinity of the 200 metres LONCAVA (NZ) (B. Claridge) shifted in under riding when insufficiently clear of YOU AND ME (D. Dunn) resulting in that rider having to take hold when tightened onto ATOMIC HERO (S. Cahill). B. Claridge was found guilty of a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday 1 March and to conclude at midnight Saturday 8 March 2014; a period of four (4) meetings.

BUSINESS DECISION was examined by the Club's Veterinary Surgeon who reported the colt to be lame in the near fore leg. Mr B. Smith, representing Mr J. Smith, the trainer of BUSINESS DECISION was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : FAMILY SUNDAY - MARCH 30 / SABOIS MAIDEN PLATE- 1716 metres

The start of this event was delayed approximately one minute owing to STYRIA'S DELIGHT having to be re-saddled on arrival at the barriers.

SON OF BAM (L. Hopwood) was inclined to over-race in the early and middle stages of the event.

DUKE OF THE CASTLE (S. Westover) hung out severely from the vicinity of the 500 metres. DUKE OF THE CASTLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : JARVIS ISUZU MAIDEN PLATE - 1214 metres

In the vicinity of the 150 metres RODNEY ROADKILL (A. Herrmann) shifted in and inconvenienced ROUSSANNE (S. Price) which commenced to give ground.

J. Toeroek, the rider of ASCENDING NIMA, reported his mount raced greenly under pressure in the straight.

RACE 4 : COOPERS / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1114 metres

The start of this event was delayed approximately four minutes owing to ROWDY RICHARD requiring farrier attention on arrival at the barriers.

STRAVINSKA (J. Maund) jumped away awkwardly and shifted in onto ROCK OUT (A. Herrmann) which was taken in, contacting THIS BLOKE (S. Cahill).

ZANONI (L. Hopwood) jumped away awkwardly.

ROWDY RICHARD (T. Pannell) was slow to begin.

At the entrance to the straight THIS BLOKE (S. Cahill) shifted out to improve onto DALRYMPLE STAR (S. Westover) which shifted out and away onto PURE QUARTZ (O. Ay) which was forced to steady. S. Cahill was reminded of his obligations when shifting ground in future.

ROCK OUT (A. Herrmann) raced keenly in the early and middle stages of the event.

ROCK OUT (A. Herrmann) was inclined to shift about in the straight and in the vicinity of the 200 metres got its head up and raced awkwardly for a short distance.

Inside the 100 metres ROCK OUT (A. Herrmann) resented racing between other runners. ROCK OUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : MATTISKE FUNERALS MARES RATING 0-68 HANDICAP - 1114 metres

ODETTE (A. Herrmann) over-raced in the early and middle stages.

C. Forrest, the rider of ZIRCONI ASPEN, reported her mount raced greenly throughout the event and was inclined to shift about. ZIRCONI ASPEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : THE TERRACE RATING 0-68 HANDICAP - 1716 metres

CIRCLE OF TRUST (K. Brooks) was held up for clear running approaching the 400 metres until approaching the 200 metres.

Inside the 200 metres BELLCHUCA (J. Potter) shifted out and away from DARK ASSASSIN (S. Price) onto MAJOR DE (T. Baker) which shifted in, resulting in these two runners making heavy contact and J. Potter becoming unbalanced and losing his off side iron. J. Potter, in attempting to regain his iron, shifted in onto DARK ASSASSIN which was taken in, contacting MEADOWS BOO (K. Bishop) which was taken in across the running of NEHRU (S. Cahill) which was forced to check. As a consequence CIRCLE OF TRUST (K. Brooks) which was attempting a run between DARK ASSASSIN and MEADOWS BOO was forced to check. NEHRU was examined by the Club's Veterinary Surgeon who reported the gelding lame in the off fore leg. First Aid was administered. Mr K. Frew, the co-trainer of that gelding was advised that a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Correct Weight for this event was delayed to allow K. Bishop, the rider of the fourth placegetter, MEADOWS BOO, Ms K. Byrnes, the trainer of the mare and Mr & Mrs K. Smith the part owners, to view the Official footage in the straight.

RACE 7 : SPORTSBET.COM TOP TOTE PLUS RATING 0-68 HANDICAP - 1214 metres

SPOILSPOT (K. Bishop) jumped away awkwardly and shifted in, inconveniencing GOODNIGHT JOSS (J. Bowditch).

UMA WAVE (R. Mayers) jumped away awkwardly and shifted in making heavy contact with SIR TRENTIN (J. Potter).

In the vicinity of the 200 metres SARCASM (S. Price) commenced to shift in under riding taking TOKEN ONE (D. Tootell) in onto SPOILSPOT (K. Bishop) which was tightened onto the hindquarters of REWIND TIME (D. Dunn) turning that gelding out. Shortly after SARCASM continued in onto TOKEN ONE which was taken across the running of SPOILSPOT which was forced to take hold and clipped the heels of TOKEN ONE. S. Price pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday 2 March and to conclude at midnight on Saturday 8 March 2014; a period of three (3) meetings.

UMA WAVE which performed poorly was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off fore leg. Mrs S. Ratsch, the trainer of UMA WAVE, was advised that a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : ANZAC DAY AT GAWLER CLASS 1 HANDICAP – 1514 metres

Acting on confirmed advice from Mr J. MacMillian, the trainer of TIMELYINTERRUPTION that the mare had become cast in its yard and was unfit to race, Stewards withdrew the mare at 9:15 am.

Mr D. Aldridge, the trainer of BELIEVE IN HARMONY, advised Stewards that he would instruct Apprentice J. Toeroek to attempt to obtain a more forward position than at its previous start.

PETIT SOEUR (L. Hopwood) was slow to begin.

In the vicinity of the 800 metres BEGOR I'M SURE (D. Tourneur) was awkwardly placed on the heels of TRULY NORTH (M. Neilson) for a number of strides and had to be restrained.

PETIT SOEUR (L. Hopwood) had difficulty obtaining clear ground in the straight.

BEGOR I'M SURE and TRULY NORTH which both performed below expectations were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : SPORTSBET.COM TOP TOTE PLUS RATING 0-68 HANDICAP – 1214 metres

Mr F. Meuring, the trainer of SPOILSPOT, reported to Stewards on Thursday, 27 February 2014 that on return to his stable the gelding had an abrasion to the lower off hind leg as well as swelling and bruising to the area.

RACE 5 : TATTSBET ADELAIDE CUP 10TH MARCH HANDICAP - 1000 metres

Ms L. Conlon, the trainer of JUST DEMANDING, reported to Stewards on Thursday 27 February 2014 that on return to her stable the filly was showing signs of shin soreness. Ms Conlon advised that the filly will now be spelled.
