RACE 1 : PATRONS OF THE NRC / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1100 metres

SANDHILL FLYER (D. Tourneur) was slow into stride.

At the entrance to the straight LOVE MOSCHINO (S. Westover) rolled in resulting in SANDHILL FLYER (D. Tourneur) being momentarily tightened.

In the vicinity of the 150 metres INSTANCE (C. Jones) shifted out onto TO TURN AROUND (W. Kerford) which was obliged to steady.

MOORE ALPHA (J. Toeroek) was inclined to lay in under pressure in the straight.

- J. Toeroek, the rider of MOORE ALPHA reported that his mount was inclined to hang in throughout the event.
- C. Jones, the rider of INSTANCE, reported that her mount was inclined to hang out from the vicinity of the 300 metres.
- S. Westover, the rider of LOVE MOSCHINO, reported that his mount hung in from the 500 metres.
- W. Kerford, the rider of TO TURN AROUND, reported that his mount never travelled throughout the event. TO TURN AROUND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : EGREMONT PASTORAL RATING 0-68 HANDICAP - 1000 metres

Shortly after the start PIXIU (R. Mayers) and PARIS SCENE (C. Jones) came together and bumped.

PRESIDIUM which performed below expectations was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: OGILVIE GROUP BENCHMARK 80 HANDICAP - 1200 metres

On jumping away DONNIDI SULINA (NZ) (K. Walters) shifted in taking FRAANIKOVA (R. Mayers) in onto EXALTED LADY (D. Tourneur) resulting in FRAANIKOVA being tightened and losing its position.

RACE 4: PARINGA PROPS / SABOIS MAIDEN PLATE - 1430 metres

GENEROUS MISS (H. McKechnie) and MERRY YEOMAN (A. Herrmann) were slow to begin.

In the vicinity of the 600 metres MOSCHATEL (S. Westover) began to weaken and bumped with GENEROUS MISS (H. McKechnie) as that mare improved to the inside.

From the vicinity of the 500 metres MOSCHATEL (S. Westover) was eased out of the event.

S. Westover, the rider of MOSCHATEL, explained that when he put the gelding under pressure in the vicinity of the 900 metres, it was reluctant to race and for this reason he did not ride MOSCHATEL out in his normal manner. MOSCHATEL was examined by the Club's Veterinary Surgeon who reported some minor abrasions to its near hind leg. Mr R. Gilcrist, the trainer of MOSCHATEL, was advised that the gelding would be required to perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

MERRY YEOMAN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off fore leg. Mr J. McArthur, the trainer of MERRY YEOMAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 5 : SCULLIAN FARMS RATING 0-68 HANDICAP - 2000 metres

Approaching the winning post on the first occasion ODYSSEO (A. Herrmann) was inclined to get its head up, raced keenly and brushed LEATHAL'S LEGACY (H. McKechnie).

J. Holder, the rider of WHERE'S TIM, explained that the gelding dipped behind on a couple of occasions during the event and when placed under pressure in the vicinity of the 400 metres failed to respond to his riding. He added that in his opinion, the gelding raced flat and may have reached the end of its preparation. WHERE'S TIM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : SOUTH KILLANOOLA RATING 0-58 HANDICAP - 1430 metres

MOUNT MEE UP (S. Westover) and TEBERUS (H. McKechnie) were slow to begin.

LONCAY (R. Mayers) was inclined to lay out under pressure in the straight resulting in that rider having to stop and straighten her mount on a number of occasions.

S. Westover, the rider of MOUNT MEE UP, reported that the gelding felt sore behind. MOUNT MEE UP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: CADGEE PARK RATING 0-58 HANDICAP - 1200 metres

COURTING JUSTICE (D. Tourneur) jumped away awkwardly and shifted in onto ANGUS CAROLUS (H. McKechnie) which was taken in onto KIRVIC (A. Herrmann).

On jumping away LADY BLACKMAN (P. Marks) shifted in at the same time that OCEAN STREET (T. Baker) shifted out resulting in JOLLY BEL (J. Toeroek) being tightened between those runners.

RACE 7 : CADGEE PARK RATING 0-58 HANDICAP - 1200 metres - Cont'd

In the vicinity of the 800 metres KIRVIC (A. Herrmann) which was racing keenly, appeared to slip behind and shifted out contacting ANGUS CAROLUS (H. McKechnie).

At the entrance to the straight ANGUS CAROLUS (H. McKechnie) shifted out onto COURTING JUSTICE (D. Tourneur) which was weakening, resulting in COURTING JUSTICE having to be steadied off the heels of JOLLY BEL (J. Toeroek).

COURTING JUSTICE lost its near fore plate.
