Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Monday, 10 March 2014

RACE 1 : ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1600 metres

In the vicinity of the 1400 metres UNSPUN (T. Pannell) commenced to over-race and became awkward between the heels of LORD DA VINCI (D. Oliver) and MAJESTIC MOMENT (M. Neilson), which both shifted ground slightly, and was obliged to alter course to the outside of MAJESTIC MOMENT.

Inside the 800 metres UNSPUN (T. Pannell) shifted out abruptly of its own accord and raced wide without cover for some distance.

UNSPUN (T. Pannell) hung out from in the vicinity of the 500 metres. UNSPUN was examined by the Club's Veterinary Surgeon who reported moderate heat stress. First Aid was administered.

T. Pannell, the rider of UNSPUN, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

ISLAND BEACH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : MAGIC MILLIONS ADELAIDE 2YO CLASSIC - 1200 metres

BEYOND THE BATTLE (D. Oliver) was slow to begin.

BEST OF TIMES (D. Tourneur) jumped away awkwardly.

EXCITE A SHANTY lost its off fore plate during the event.

RACE 2 : MAGIC MILLIONS ADELAIDE 2YO CLASSIC - 1200 metres (Cont'd)

J. Bowditch, the rider of DEIHEROS, was advised of his obligations under AR137A(4)(g) in relation to using his whip when his mounts are clearly winning.

BEYOND THE BATTLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FLAMIN' MOGUL was examined by the Club's Veterinary Surgeon who reported the colt to be shin sore in the off foreleg. Mr. D. Hayes, the Trainer of FLAMIN' MOGUL, was advised a Veterinary Certificate of Fitness would be required prior to presenting the colt for a future trial or race.

RACE 3 : SPORTINGBET CINDERELLA STAKES - 1050 metres

THE NIGHT SKY (J. Holder) laid out from the vicinity of the 600 metres. THE NIGHT SKY was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. L. Macdonald, the Co-Trainer of THE NIGHT SKY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 4 : SCHWEPPE S HAYES MEMORIAL CUP - 1600 metres

Mr. J. MacMillan, the Trainer of BORISTAR, advised Stewards he would instruct Apprentice J. Kah to attempt to obtain cover in today's event.

LE ROI (GER) (C. Williams) jumped away awkwardly and contacted GAMBLIN' GURU (C. Lindop), turning that gelding's hindquarters.

GAMBLIN' GURU (C. Lindop) pulled very hard in the early stages of the event and in the vicinity of the 900 metres became difficult to restrain, clipped the heels of BORISTAR (J. Kah) and fell, dislodging C. Lindop. As a consequence KELLY ROYALE (S. Price), LE ROI (GER) (C. Williams) and ROAD TRIPPIN' (C. Newitt) were all inconvenienced. C. Lindop was examined by the First Care Ambulance personnel and transported to hospital for observation. GAMBLIN' GURU was examined by the Club's Veterinary Surgeon who reported a slight bleed from the near side nostril otherwise no visible abnormalities. Stewards inspected the track in the vicinity of the 900 metres post the incident and declared it safe to continue racing.

LE ROI (GER) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GAMBLIN' GURU lost its off fore plate during the event.

RACE 5 : ADELAIDE CASINO HANDICAP - 1100 metres

The start of this race was delayed approximately six minutes owing to the incident in Race 4.

STRAVINSKY CODE (J. Holder) jumped away awkwardly and was slow to begin.

In the vicinity of the 200 metres BRIMARVI PRINCE (J. Bowditch) and QADIR (M. Neilson) came together when both horses shifted ground slightly. As a consequence these horses brushed on a number of occasions over the concluding stages resulting in BRIMARVI PRINCE being taken wider on the track.

J. Holder, the rider of STRAVINSKY CODE, reported the gelding did not stride out freely during the race. STRAVINSKY CODE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. J. Hyam, the Trainer of STRAVINSKY CODE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 5 : ADELAIDE CASINO HANDICAP - 1100 metres (Cont'd)

C. Forrest, the rider of RED MAGNET, explained she had been instructed to take up a forward position in running. She stated the gelding began well, was able to obtain an easy lead and travelled well until the entrance to the straight where it did not respond to her riding in the manner she expected and finished the race off in a disappointing manner. RED MAGNET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following this race, Stewards reclassified the track to Good 3 at 2.52 pm, retrospective to Race 5.

RACE 6 : THE MYER FASHION TROPHY - 1200 metres

On arrival on course ANNANDALE LASS was examined by the Club's Veterinary Surgeon who reported the filly had opened an old wound on the off hind fetlock. ANNANDALE LASS was ruled fit to race.

The start of this race was delayed approximately five minutes owing to COUNTER SPIN and DISTINCTIVE FLYER springing their near fore plates in the mounting enclosure, requiring Farrier attention. COUNTER SPIN and DISTINCTIVE FLYER were examined by the Club's Veterinary Surgeon and ruled fit to race.

CLASSY JACK (J. Frew) and MURTLE TURTLE (J. Holder) contacted at the start when both horses shifted ground.

DISTINCTIVE FLYER (C. Schofield) jumped away awkwardly and shifted in, contacting COUNTER SPIN (C. Newitt).

MEADOWS ANGEL (L. Hopwood) over-raced in the early stages of the event.

TIPS AND BEERS (S. Baster) raced wide without cover in the early stages of the event.

J. Frew, the rider of CLASSY JACK, was questioned regarding him making a celebratory gesture prior to the winning post. He pleaded guilty to a charge under AR137(c) and was fined \$400.

THOMASON lost its near fore plate during the event.

THOMASON was examined by the Club's Veterinary Surgeon who reported the gelding to be sore in front. Mr. P. Stokes, the Trainer of THOMASON, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

DISTINCTIVE FLYER was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off hind leg. Mr. L. Macdonald, the Co-Trainer of DISTINCTIVE FLYER, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

MAGICAL TYCOON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following this event J. Kah stood down from fulfilling her ride in Race 8. She was advised she would require a Medical Clearance prior to presenting to ride again.

RACE 7 : TATSBET ADELAIDE CUP - 3200 metres

The start of this race was delayed approximately two minutes.

RACE 7 : TATSBET ADELAIDE CUP - 3200 metres (Cont'd)

VIMA (T. Pannell) raced wide without cover throughout the event.

In the vicinity of the 3000 metres MOTIVADO (GB) (S. Baster), which was inclined to lay out when being restrained, became awkwardly placed inside the heels of DISTILLATION (S. Price) for a number of strides.

MOTIVADO (GB) (S. Baster) was eased out of the event in the vicinity of the 1800 metres. S. Baster explained MOTIVADO (GB) did not travel well after making the crossing in the vicinity of the 1900 metres and as he felt there may be something amiss with the gelding, he eased it out of the event. MOTIVADO (GB) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

S. Price, the rider of DISTILLATION, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$100.

C. Williams, the rider of BIG MEMORY (FR), explained the gelding travelled well in the early stages and he was comfortable with his position in running near the 2000 metres. He stated shortly thereafter RIALYA (J. Bowditch) applied pressure but he was nevertheless able to settle in the box seat. He added in the vicinity of the 900 metres the gelding was under pressure and from the vicinity of the 800 metres had commenced to labour and in his opinion, near the 400 metres, had run its race. He further added in his opinion the gelding is not yet seasoned and did not run out the distance. BIG MEMORY (FR) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : MAC JUST OVER? JUST DON'T DRIVE MATRICE STAKES - 1200 metres

On jumping away JUST DISCREET (M. Neilson) reared and struck its head on the barrier structure, was very awkward to begin and lost many lengths.

YOU'RE SO GOOD (NZ) (D. Lane) and NEAREST TO PIN (J. Bowditch) contacted on jumping away.

BELFAST BOY (C. Schofield) raced keenly in the early and middle stages of the event.

In the vicinity of the 200 metres OUT OF COOBER (S. Price) was obliged to alter course to the inside of BELFAST BOY (C. Schofield), which shifted out.

Approaching the 100 metres LOVEYAMADLY (D. Smith) was inconvenienced when taken in by RIZIZ (D. Oliver), which rolled in.

RIZIZ lost its near hind plate during the event.

JUST DISCREET was examined by the Club's Veterinary Surgeon who reported the mare had bled from the off side nostril due to external trauma.

LOVEYAMADLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9 : 7 NEWS HANDICAP - 1600 metres

As no Apprentice rider was available to replace J. Kah on SAVVY SMOKIN', Stewards permitted J. Holder to ride the gelding.

RACE 9 : 7 NEWS HANDICAP - 1600 metres (Cont'd)

The start of this race was delayed approximately one minute.

FREE THE WIND (A. Herrmann) and MOON BRICKS (C. Forrest) contacted on jumping away.

FLOW METER (B. Claridge) shifted out on jumping away and contacted STEREOSONIC (NZ) (D. Oliver).

BALLYPATRICK (J. Toeroek) jumped away awkwardly and was slow to begin.

MOON BRICKS (C. Forrest) raced wide without cover throughout the event.

SAVVY SMOKIN' (J. Holder) raced keenly in the early stages of the event.

STEREOSONIC (NZ) (D. Oliver) was held up for clear running from the vicinity of the 500 metres until inside the 200 metres and was obliged to alter course to obtain clear running and thereafter, in the vicinity of the 100 metres, shifted to the inside of FLOW METER (B. Claridge) and brushed with WINGS ON HER FEET (J. Benbow), which was inconvenienced when taken in onto SPIRITOF ENDEAVOUR (USA) (T. Pannell), which was taken in. D. Oliver was reminded of his obligations when shifting ground in future.

SPIRITOF ENDEAVOUR (USA) (T. Pannell) was held up for clear running from the vicinity of the 500 metres until shortly after the entrance to the straight.

PRESTIGE GLEN (S. Price) was held up for clear running from the vicinity of the 500 metres until in the vicinity of the 200 metres and was obliged to alter course to the outside of ALBONETTI (C. Schofield) to obtain clear ground.

SAVVY SMOKIN' (J. Holder) became held up in the vicinity of the 200 metres behind MOON BRICKS (C. Forrest) and was obliged to alter course inside the 100 metres to obtain clear ground.

K. Bishop, the rider of GOODNIGHT JOSS, was questioned regarding the use of her whip over the concluding stages. She was reminded of her obligations under AR137A(4)(c) when her mounts are out of contention.

SPIRITOF ENDEAVOUR (USA) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
