STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Ceduna Racecourse
by the Ceduna Racing Club on Saturday, 15 March 2014

TRACK: Good 3

WEATHER: Overcast

RAIL: Normal

RACE 1 : CEDUNA PHARMACY / SABOIS MAIDEN PLATE - 1000 metres

SING THAT SONG (R. Bell) jumped away awkwardly.

RACE 2 : FLINDERS PORTS RATING 0-62 HANDICAP - 1000 metres

On arrival at the barriers, T. Baker, the rider of MEG'S CASTLE requested the mare be examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

Shortly after the start DEEP BLUE (A. Doyle) was obliged to steady and lose its position when HEZAFRAAR (P. Roff) shifted in.

From the vicinity of the 400 metres until the winning post, DEEP BLUE (A. Doyle) laid in under pressure.

HEZAFRAAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : PHIL STEVENS & ASSOCIATES / PRESCOTT SECURITIES RATING 0-58 HANDICAP - 1200 metres

EXALTED FLING was reluctant to proceed to the barriers until its tongue tie was removed. After being examined by the Club's Veterinary Surgeon on arrival at the barriers and acting on his advice, Stewards permitted EXALTED FLING to race without its tongue tie.

Approaching the 200 metres NORTHSIDE LAD (A. Doyle) shifted in onto RUBY'S ANGEL (R. Bell) which had to be checked to avoid the heels of NORTHSIDE LAD, losing its position. A. Doyle pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 22 March and to conclude at midnight on Thursday 27 March 2014; a period of three (3) meetings.

NORTHSIDE LAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

NO VACANCY, who performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : VITERRA THEVENARD CUP - 1600 metres

In the vicinity of the 800 metres ARTIE'S ANGEL (D. Tootell) was inclined to race keenly when being restrained off the heels of ROAD TO DANTREE (S. Mullett).

In the vicinity of the 400 metres OKAMAN (A. Doyle) was obliged to shift out across the heels of ROAD TO DANTREE (S. Mullett) to obtain clear running.

RACE 5 : FLINDERS PORTS RATING 0-62 HANDICAP - 1400 metres

A. Doyle, the rider of SWEET NEVER, reported that the mare, in his opinion, had not handled the turn in the vicinity of the 400 metres. SWEET NEVER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
