Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 22 March 2014

RACE 1 : NOEL DARMODY HANDICAP - 2028 metres

GENEROUS BEAU (S. Westover) shifted out on jumping away, inconveniencing LENNYBE (J. Toeroek).

LENNYBE (J. Toeroek) raced keenly in the early and middle stages of the event.

RACE 2 : BRIAN BLOFFWITCH'S 80TH HANDICAP - 1050 metres

CASH IS COMING (O. Ay) reared on jumping away and was slow into stride.

TILDY LAD (H. McKechnie) raced greenly and was inclined to shift about throughout the event.

COUNTER SPIN (J. Holder) laid in under pressure in the straight.

MIKAELA lost both hind shoes during the event.

TILDY LAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

COUNTER SPIN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. L. Macdonald and Mr. A. Gluyas, the Co-Trainers of COUNTER SPIN, were advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 3 : ADELAIDE4AFRICA HANDICAP - 1600 metres

CHIEFTAIN JACK (D. Tourneur) laid out under pressure in the straight and in the vicinity of the 200 metres, shifted out onto DIRE WARNING (K. Bishop), which was forced to race in restricted room until inside the 100 metres when tightened onto DANISH SPY (J. Holder). D. Tourneur was severely reprimanded and advised in future he would be required to make a greater effort to keep his mounts straight when they commence to shift.

RACE 3 : ADELAIDE4AFRICA HANDICAP - 1600 metres (Cont'd)

Stewards questioned S. Carr, the rider of STELLA LANTE, into the use of her whip prior to the 100 metres. She pleaded guilty to a charge under AR137A(5)(a)(i) in that she used her whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded. She also pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions and was fined \$300.

Stewards questioned S. Price, the rider of FAMILY PORTRAIT, into the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions and was fined \$200.

CHIEFTAIN JACK and QUICK SNITZEL were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STELLA LANTE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : ITIPSPORTS.COM.AU HANDICAP - 1100 metres

On jumping away ALABAMA MISSILE (J. Holder) shifted out slightly onto AZZCOOL (S. Price), which was inconvenienced when tightened onto COCO MISS (D. Tourneur), which shifted in slightly.

AZZCOOL (S. Price) raced keenly in the early and middle stages of the event.

At the entrance to the straight AZZCOOL (S. Price) shifted out onto MISS JOOLIA (H. McKechnie), which had to be momentarily steadied and alter course back to that mare's inside.

Inside the 200 metres MISS JOOLIA (H. McKechnie) attempted to improve into a tight run between AZZCOOL (S. Price) and MINNYMOO (S. Carr), which rolled out slightly approaching the 100 metres, resulting in MISS JOOLIA having to shift out onto AZZCOOL to obtain clear ground.

J. Toeroek, the rider of ARJAE, explained he had been instructed to have the horse settle with cover and attempt to make his run to the outside of other runners on entering the straight, however, due to the formation of the field, he felt he would have to restrain too far to get to the outside and for this reason had elected to continue to improve to the inside of runners. He added that after being beaten to a run by ALABAMA MISSILE (J. Holder) approaching the 200 metres, he was obliged to alter course back to that mare's inside and then became held up from the vicinity of the 100 metres until near the 50 metres when awkwardly placed between the heels of ALABAMA MISSILE and HOTEL SIERRA (J. Bowditch).

AZZCOOL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : ZERELLA FRESH HANDICAP - 1600 metres

BALLYPATRICK (J. Toeroek) jumped away awkwardly and was slow to begin.

FRANK THE RIPPER (O. Ay) raced keenly in the early and middle stages of the event.

FLOW METER (J. Frew) raced wide without cover throughout the event.

RACE 5 : ZERELLA FRESH HANDICAP - 1600 metres (Cont'd)

RIPPLE EFFECT (J. Bowditch) was held up from the vicinity of the 500 metres until the vicinity of the 200 metres when it shifted in to obtain clear ground when insufficiently clear of GRAND GROUP (T. Pannell), which was forced to check to avoid that gelding's heels. J. Bowditch pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 29 March and to conclude at midnight on Sunday, 6 April 2014; a period of four (4) meetings.

At the entrance to the straight MOON BRICKS (S. Carr) rolled out onto FREE THE WIND (A. Herrmann), which was taken out onto FLOW METER (J. Frew), which shifted out onto BALLYPATRICK (J. Toeroek), which was taken wider onto SAVVY SMOKIN' (H. McKechnie), which was forced to steady.

From the vicinity of the 300 metres until near the 200 metres SET ON STONE (J. Maund) was disappointed when attempting a tight run between the heels of MOON BRICKS (S. Carr), which shifted in at the same time as FRANK THE RIPPER (O. Ay) rolled out.

VAN ROSSUM was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

SAVVY SMOKIN' was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : TAYLOR COLLISON HANDICAP - 1200 metres

CORVIDAE (S. Cahill) shifted out on jumping away, inconveniencing ENDLESS SHADOW (D. Tourneur).

LADY DYNAMO (T. Pannell) shifted out on jumping away onto NEAREST TO PIN (J. Holder), which was inconvenienced when tightened onto GOLDEN DANE (J. Toeroek).

At the entrance to the straight CORVIDAE (S. Cahill) shifted out, contacting NEAREST TO PIN (J. Holder), which became unbalanced when its hindquarters were turned out, resulting in NEAREST TO PIN shifting back in onto CORVIDAE, which became awkwardly placed on the heels of GOLDEN DANE (J. Toeroek) for several strides. As a consequence ENDLESS SHADOW (D. Tourneur), which was racing behind CORVIDAE, was obliged to alter course. S. Cahill was reprimanded and advised in future to ensure there was sufficient room prior to attempting runs.

GOLDEN DANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : MAESBURY PLUMBING HANDICAP - 1200 metres

WISE JOURNEY (J. Potter) was slow to begin.

Shortly after the start GALLANT HARMONY (K. Bishop) shifted out onto CHESTNUT CHARLIE (S. Price), which became awkwardly placed on that gelding's heels for a number of strides, resulting in CHESTNUT CHARLIE shifting out onto SERBIAN CROWN (T. Pannell), which was taken out onto WISE JOURNEY (J. Potter), which shifted out abruptly. K. Bishop was advised of her obligations when shifting ground in future.

WISE JOURNEY (J. Potter) raced wide without cover throughout the event.

SERBIAN CROWN lost its off fore plate during the event.

RACE 7 : MAESBURY PLUMBING HANDICAP - 1200 metres (Cont'd)

ALPHA MAN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mrs. H. Lehmann, the Trainer of ALPHA MAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
