Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Sunday, 30 March 2014

RACE 1 : THE TERRACE HURDLE – 3340 metres

In the vicinity of the 800 metres SCOTLAND THE BRAVE (B. Kane) shifted in onto MONTEFALCO (J. Lynch) which was obliged to ease for several strides. B. Kane was reprimanded and advised to take greater care when shifting ground in future.

SCOTLAND THE BRAVE (B. Kane) contacted the first of the double on the second occasion.

TRENCHTOWN (IRE) lost its off hind plate during the event.

DUMOSA was examined by the Club's Veterinary Surgeon who reported minor lacerations to the off fore cannon.

All other horses in this event were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : GAWLER SOUTH BAKERY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately two minutes.

THE NIGHT SKY (J. Holder) jumped away awkwardly and shifted in onto ATLANTIS (S. Price) which was inconvenienced for several strides.

SCAVENGER (D. Tourneur) jumped away awkwardly and shifted in contacting MAKO MAGIC (S. Westover).

In the vicinity of the 900 metres SCAVENGER (D. Tourneur) shifted in onto THE NIGHT SKY (J. Holder) which was obliged to ease for several strides and thereafter THE NIGHT SKY raced keenly for a short distance. D. Tourneur was severely reprimanded and advised in future to shift ground only when sufficiently clear.

RACE 2 : GAWLER SOUTH BAKERY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1100 metres – Cont'd

In the vicinity of the 300 metres WALLBANGER (M. Neilson) was inclined to lay in inconveniencing THE NIGHT SKY (J. Holder) for several strides.

In the vicinity of the 150 metres INNOVATIVE JILL (T. Pannell) which was inclined to race greenly, shifted out onto MIRACLE THE SECOND (L. Stojakovic) which was obliged to ease for several strides. Shortly thereafter INNOVATIVE JILL continued to shift out and inconvenienced MAKO MAGIC (S. Westover). T. Pannell was severely reprimanded and advised to shift ground only when sufficiently clear in future.

Correct Weight for this event was delayed to allow Ms. L. Stojakovic, the rider of the third placegetter, MIRACLE THE SECOND and Mr D. Clarken, that colt's trainer, to view the official footage in the straight.

WALLBANGER, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : JARVIS ISUZU / SABOIS MAIDEN PLATE - 1100 metres

T. Baker was examined on arrival on course by the First Care medical staff and passed fit to ride.

TEQUILA RED (M. Neilson) jumped away awkwardly and shifted in onto SEBRING MAGIC (T. Pannell) taking that filly in onto JOEY (A. Herrmann).

On jumping away CAPODECINA (S. Price) was inclined to rear and as a result was slow to begin.

ALWAYS MAGIC (S. Cahill) was slow to begin.

AGENT CASH (C. Forrest) jumped away awkwardly and shifted out.

TEQUILA RED (M. Neilson) shifted out under pressure over the concluding stages of the event.

MOLTO BELLA (T. Baker) was inclined to over-race throughout the event.

Stewards upgraded the track to Good 3 at 2:03 pm retrospective to Race 3.

RACE 4 : SANDERS FODDER / MITAVITE GAWLER TRAINERS AWARD / SABOIS 3 YEAR-OLD MAIDEN PLATE - 1500 metres

VASOJEVKA (T. Baker) was slow to begin.

THE SHADOW DANCER (J. Toeroek) hung out severely throughout the event.

M. Neilson, the rider of HEIRDOM, reported his mount may have been galloped on in the vicinity of the 600 metres. HEIRDOM was examined by the Club's Veterinary Surgeon who reported minor abrasions to the near hind cannon.

THE SHADOW DANCER was examined by the Club's Veterinary Surgeon who reported the gelding's teeth attention. Mrs L. Ryan, the trainer of THE SHADOW DANCER was advised to attend to this accordingly.

RACE 5 : MAXWELL COOPER MEMORIAL RATING 0-68 HANDICAP - 2100 metres

CRUZ'N NOW (T. Pannell) was slow to begin.

CLUBS ARE TRUMPS (O. Ay) jumped away awkwardly and shifted out contacting ROYAL AMATI (D. Tourneur) tightening that mare onto BLEVIC LAD (J. Toeroek).

In the vicinity of the 1600 metres NOT A ZERPRISE (S. Price) improved onto the heels of BELIEVE IN HARMONY (S. Carr) and in doing so shifted out onto BELLCHUCA (J. Potter) taking that mare wider on the track, obliging it to race wide without cover for the remainder of the event.

TERRIFIC FLAIR (J. Holder) was inclined to lay in under pressure in the straight.

J. Toeroek, the rider of BLEVIC LAD, reported his mount was inclined to lay in under pressure in the straight.

ROYAL AMATI which performed below expectations was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : SPORTSBET.COM TOP TOTE PLUS RATING 0-68 HANDICAP - 1100 metres

As the Thoroughbred Identification Card was not available for MY BOY BRANDO, Stewards were able to identify the gelding from their official brands and markings and the gelding was permitted to start. Mr J.B. O'Connor, the trainer of MY BOY BRANDO was fined \$50 under AR59A(i)

SPOILSPOT (K. Bishop) jumped away awkwardly and shifted out contacting MISTLETOE (O. Ay).

In the vicinity of the 1000 metres MISTLETOE (O. Ay) shifted out contacting MY BOY BRANDO (S. Westover) on a number of occasions tightening that gelding onto GLENARIFF (T. Pannell). O. Ay was severely reprimanded and advised to shift ground only when sufficiently clear in future.

In the vicinity of the 600 metres MISTLETOE (O. Ay) became unbalanced for a number of strides for no apparent reason.

An inquiry into Apprentice S. Carr's use of the whip on STATUE OF GLORY will be conducted on a date to be advised.

MISTLETOE was examined by the Club's Veterinary Surgeon who reported the mare to have laboured respiration and signs of soreness across the lower back. Mr. J. Cornell, the trainer of MISTLETOE, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future race or trial. Mr J. Cornell advised Stewards that the mare would now be spelled.

RACE 7 : COOPERS KANGAROO ISALND CUP – 1500 metres

Acting on confirmed advice from trainer Mr K. Sweeney that SAVVY SMOKIN' had swelling in its near fore cannon, Stewards withdrew the gelding at 1:30 pm.

EMMOOKI'S DASH (S. Cahill) jumped away awkwardly and shifted out contacting CLAY PAVER (J. Toeroek).

In the vicinity of the 200 metres LIGHTNING DREW (D. Tourneur) shifted in taking the running of NEHRU (T. Pannell) which was obliged to steady and alter course to obtain clear ground. D. Tourneur was reprimanded and advised only to shift ground when sufficiently clear to do so in future.

RACE 7 : COOPERS KANGAROO ISALND CUP - 1500 metres - Cont'd

Approaching the 100 metres WOTZITWORTH (J. Maund) attempted a tight run to the outside of STREET RELATED (J. Potter) and to the inside of RIVER OF SALVATION (O. Ay) but was unable to improve its position as RIVER OF SALVATION rolled in when taken in by EMMOOK'S DASH (S. Cahill) and MONICA KATE (A. Herrmann) which shifted in slightly. As a result WOTZITWORTH had to be steadied and lost its position.

Correct Weight for this event was delayed to allow T. Pannell, the rider of the third placegetter NEHRU, to view the official footage in the straight. After doing so T. Pannell lodged an objection against LIGHTNING DREW (D. Tourneur) being declared the second placegetter alleging interference in the vicinity of the 200 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *upheld* the objection. The amended placings were -

RACE 8 : HAPPY BIRTHDAY DULCIE COBB CLASS 1 HANDICAP - 1200 metres

Rounding the home turn PURE QUARTZ (T. Pannell) shifted out abruptly and in doing so took LIZANA (S. Price) off its course, forcing that mare and RED BEGONIA (K. Brooks) wider on track.

In the vicinity of the 300 metres DESDANE (J. Toeroek) was obliged to be steadied as SHABAAM (R. Steward) shifted out and LADY BESS (M. Neilson) shifted in.
