

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Streaky Bay Racecourse
by Streaky Bay Racing Club on Saturday, 29 March 2014

Stewards: D. Bucknell (A/Chairman) (Steward), P. Dearman, R. Evans (HT) & T. Kerry (F) (Deputy Stewards), Dr. Y. Flemming & Dr D. Anderson (Veterinary Surgeon)

TRACK: Good 3

WEATHER: Fine

RAIL: Normal

RACE 1 : CHAS MCEVOY MEMORIAL / SABOIS MAIDEN PLATE - 1000 metres

On arrival on course DOUBLE GREY was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off fore leg. DOUBLE GREY was a late withdrawal on Veterinary advice at 12.30 pm. Mr T. Jolly, the trainer of the mare was advised that a Veterinary Certificate of Fitness would be required prior to accepting for a future race or trial.

FROESE (T. Baker) and BLACK JUGAH (R. Bell) was slow to begin.

Correct weight was delayed to allow T. Baker, the rider of FROESE, the third placegetter, to view the official photo finish.

RACE 2 : LETCHER & MORONEY ACCOUNTANTS RATING 0-68 HANDICAP
- 1000 metres

On jumping away KOODA DUCHESS (T. Baker) attempted to buck and then raced tractably for a short distance. Thereafter the mare bucked for a considerable distance, dislodging its rider T. Baker. T. Baker was examined by the First Care medical staff and passed fit fulfill his remaining engagements.

KOODA DUCHESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr J. Dunn, the trainer KOODA DUCHESS, was advised that the mare must trial to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. Given that KOODA DUCHESS had previously bucked, Stewards ruled that the mare must trial in a full race saddle.

K. Brooks, the rider of DEEP BLUE, reported that she had concerns with the gelding's action and for that reason did not ride it out to the finish. DEEP BLUE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near fore leg. Mr T. Trenowden, the trainer of the gelding was advised that a Veterinary Certificate of Fitness would be required prior to accepting for a future race or trial.

RACE 3 : STREAKY BAY RACING CLUB'S VALUED SPONSORS RATING 0-58
HANDICAP - 1200 metres

HEART OF STONE was a late withdrawal at 12:00 pm as there was no rider available.

COSTLY ARGUMENT (T. O'Donnell) began awkwardly.

T. Baker, the rider of MISS BELLARAE, reported that his mount was slow to begin and in his opinion may have come to the end of its preparation. Mr B Cozamanis, the trainer of MISS BELLARAE, stated that the mare may not have appreciated racing on the dirt surface and would now be spelled.

**RACE 3 : STREAKY BAY RACING CLUB'S VALUED SPONSORS RATING 0-58
HANDICAP - 1200 metres – Cont'd**

A. Doyle, the rider of NORTHSIDE LAD, reported that the gelding did not run out the 1200 metres of the event. Ms T. Kropej, the trainer of the gelding advised Stewards that NORTHSIDE LAD would be freshened up and campaign over a shorter distance.

K. Brooks, the rider of RUBY'S ANGEL, stated that she had been instructed to ride the mare cold from the barriers and on straightening took the mare wide to avoid kick-back. She added in her opinion, the mare finished the race off well.

MISS BELLARAE, NORTHSIDE LAD and RUBY'S ANGEL were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : LINCOLN ESTATE WINES RATING 0-68 HANDICAP - 1400 metres

BERRY KISSES, (C. Forrest) was slow to begin.

C. Forrest, the rider of BERRY KISSES, reported that in her opinion the filly had failed to handle the dirt track.

Upon return to scale, M. Henderson, the rider of SOMBRE, made application for his mount to be declared a non-runner on the grounds that, momentarily after the start was effected, he heard the starter communicate in respect to a false start and had initially restrained his mount and lost ground, however, as the rest of the field continued to race he then rode his mount along. After considering evidence given by M. Henderson, the rider of SOMBRE, Mr G. Searle, the trainer of SOMBRE and Mr G. Woods, the Official Starter, as well as the footage and acting on their own observations, Stewards ruled that the mare be declared a non-runner with all bets placed on SOMBRE to be refunded and all successful bets to be subject to deductions of 31 cents in the win and 28 cents in the place.

It was determined that the gates were released inadvertently but the Starter and Stewards considered that the field had begun on terms. Stewards further advised Mr G. Woods the Official Starter that he must be more definitive as to whether or not a false start has been effected and if he is of the opinion that a false start should be called, he must make a more concerted effort to alert the riders.

RACE 5 : XXXX GOLD STREAKY BAY COMMUNITY HOTEL CUP - 1800 metres

OCSMEPOP (Z. Spain) was slow to begin.

TRESETTE (M. Henderson) and FORESHORE MAK (R. Bell) began awkwardly.

PRIMAL INSTINCT (P. Roff) over-raced badly in the early and middle stages.

P. Roff. The rider of PRIMAL INSTINCT reported that his mount was not suited by the slow tempo of the race.

A. Doyle, the rider of MONTALTO, reported that after initially hanging out rounding the home turn, he allowed his mount to shift to the outside of the track to avoid the kick-back and was of the opinion that the going was better out wide.

RACE 6 : STREAKY BAY & CEDUNA MEAT SERVICE / BILL BUTTERFIELD FARMS
0-58 HANDICAP - 1800 metres

After being loaded into the barriers, VOODOO BLACK MAGIC became fractious, reared and got itself cast in the barriers. VOODOO BLACK MAGIC and SOCIAL ASSASSIN, which was in the adjacent barrier stall were examined by the Club's Veterinary Surgeon and passed fit to start.

Ms J. Branford, the trainer of VOODOO BLACK MAGIC, was advised that given the gelding's previous poor record in respect to its barrier manners, it will be required to load without delay and prove tractable in the barriers in an Official Barrier Trial on two successive occasions prior to accepting for a future race.

GENERAL

D. Evans pleaded guilty to a charge under AR85B for failed to fulfil an engagement aboard HEART OF STONE. D. Evans was fined \$200 and advised of his right to an appeal.
