Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 5 April 2014

RACE 1 : SCHWEPES HANDICAP - 1000 metres

CRAYZED (S. Carr) jumped away awkwardly, shifted out and contacted BOSSY MISS MOSSY (J. Holder), which was taken out onto LOQUETEUX (J. Toeroek).

PATCH HERO (J. Potter) raced ungenerously for a short distance in the early stages of the event.

CRAYZED (S. Carr) and LOQUETEUX (J. Toeroek) raced greenly in the straight.

RACE 2 : SPORTINGBET HANDICAP - 1250 metres

NATURAL DISASTER (D. Stra) jumped away awkwardly and was slow to begin.

DASHITUDE (A. Herrmann) jumped away awkwardly, shifted out and was obliged to be steadied off the heels of CORVIDAE (D. Yendall). As a consequence DASHITUDE was slow to begin.

STREETCAR VALOUR (J. Potter) and NATURAL DISASTER (D. Stra) over-raced in the early stages of the event.

Inside the 600 metres NATURAL DISASTER (D. Stra) rolled out and was obliged to be steadied off the heels of ALMIGHTY BULLET (S. Carr).

DASHITUDE (A. Herrmann) raced wide without cover throughout the event.

RACE 3 : HINDMARSH PLUMBING HANDICAP - 1400 metres

ENDLESS SHADOW (S. Carr) over-raced in the early stages.

RACE 3 : HINDMARSH PLUMBING HANDICAP - 1400 metres (Cont'd)

MIGHTY LIKE (M. Neilson) became held up for clear ground near the 400 metres, shifted out to obtain clear running near the entrance to the straight and inconvenienced KRYPTON (J. Toeroek), which was taken out, resulting in KRYPTON having to be steadied for several strides. M. Neilson was reminded of his obligations when shifting ground in future.

Approaching the 200 metres MIGHTY LIKE (M. Neilson) was held up for several strides when racing on the heels of WHITE SAMBUCA (NZ) (D. Tourneur).

Following the running of this event the track was upgraded to Good 3 at 1.50 pm, retrospective to Race 3.

RACE 4 : STAKES FAMILY DAY RACES 12TH APRIL HANDICAP - 1250 metres

FINE APPROACH (S. Westover) was slow to begin.

COUNTER SPIN (J. Holder) jumped away awkwardly, shifted out and was then obliged to be steadied off the heels of MR BACKCHAT (H. Coffey).

TILDY LAD (H. McKechnie) jumped away awkwardly and shifted out onto MIKAELA (S. Price), which was taken a little wider.

COUNTER SPIN (J. Holder) pulled hard in the early and middle stages of the event.

Approaching the 400 metres COUNTER SPIN (J. Holder) shifted out and brushed with SANDHILL HERO (D. Tourneur), which was taken wider.

Over the concluding stages ONWARD (A. Herrmann) shifted out under pressure and momentarily inconvenienced ROWDY RICHARD (T. Pannell), which became awkward on the heels of COUNTER SPIN (J. Holder).

J. Toeroek, the rider of ARJAE, C. Forrest, the rider of PRINT MONEY, and A. Herrmann, the rider of ONWARD, all reported their mounts hung in during the event. ARJAE was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. R. Jolly, the Trainer of ARJAE, was advised that a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race. PRINT MONEY and ONWARD were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

H. McKechnie, the rider of TILDY LAD, reported it was her intention to take up a more forward position in running but due to her wide barrier and the manner in which the gelding began, she was unable to do so. TILDY LAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : HAPPY 90TH WIN ORMOND HANDICAP - 1300 metres

FLASK (A. Herrmann) over-raced in the early stages and then became awkward on the heels of COCO MISS (D. Tourneur) for a short distance near the 600 metres.

S. Carr, the rider of BEACH FRONT, was questioned regarding her use of the whip in the straight. She pleaded guilty to a charge under AR137A(5)(a)(i) for using her whip in consecutive strides and was fined \$200. S. Carr also pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$300.

D. Yendall, the rider of MEDAL CONTENDER, reported his mount hung out throughout the event.

RACE 5 : HAPPY 90TH WIN ORMOND HANDICAP - 1300 metres (Cont'd)

SLIPPERY NINJA and DARTOOK (NZ) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BEACH FRONT was examined by the Club's Veterinary Surgeon who reported a puncture wound to the horse's coronary band on the near hind leg.

RACE 6 : MEDALLION HOMES HANDICAP - 1950 metres

SOUTHERN INVASION (L. Hopwood) over-raced in the early stages.

Approaching the 600 metres AMALGAMATE (A. Herrmann) was obliged to alter course to the outside of SOUTHERN INVASION (L. Hopwood) as gelding shifted in. L. Hopwood was reminded of her obligations when shifting ground in future.

Inside the 100 metres PRESTIGE GLEN (D. Gauci) was obliged to alter course to the inside of CHIEFTAIN JACK (M. Neilson) as that gelding rolled out.

Approaching the winning post ELLDAMI (D. Tourneur) was obliged to be steadied when tightened between the heels of LENNYBE (J. Holder) and CHIEFTAIN JACK (M. Neilson), which both shifted ground. J. Holder and M. Neilson were both reminded of their obligations when shifting ground in future.

L. Hopwood, the rider of SOUTHERN INVASION, reported the gelding hung out throughout the event. SOUTHERN INVASION was examined by the Club's Veterinary Surgeon who reported the gelding had jarred up to a moderate degree and was fatigued.

J. Toeroek, the rider of SANDHILL CHIEF, reported the gelding felt sore on pulling up. SANDHILL CHIEF was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. S. Turner, the Trainer of SANDHILL CHIEF, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

PRESTIGE GLEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : ENDEAVOUR HOMES HANDICAP - 1250 metres

On leaving the mounting yard, ATHLETICISM became very fractious and dislodged its rider H. Coffey. H. Coffey was examined by the First Care Medical staff, who passed him fit to ride. ATHLETICISM, which was captured, was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

RIGHT IDEA (D. Tourneur) was slow to begin.

EGO'S GOOD (K. Brooks) was unable to obtain clear running for some distance shortly after the entrance to the straight when racing behind MORE READY (D. Tootell) and inside BELLA DOLCE (J. Toeroek) and approaching the 200 metres altered course to the outside of BELLA DOLCE. Shortly thereafter EGO'S GOOD raced in restricted room between AIR COMET (J. Potter), which was taken in slightly by ATHLETICISM (H. Coffey), and MISS JOOLIA (H. McKechnie), which attempted to improve into the same run as EGO'S GOOD. As a consequence EGO'S GOOD and AIR COMET contacted on several occasions, unbalancing both runners, resulting in EGO'S GOOD being unable to obtain clear running and not being fully tested for the remainder of the event. H. McKechnie was reminded of her obligations when attempting runs in future.

RACE 7 : ENDEAVOUR HOMES HANDICAP - 1250 metres (Cont'd)

MISS JOOLIA (H. McKechnie), which was following EGO'S GOOD (K. Brooks) at the entrance to the straight, was unable to obtain clear running for a short distance.

In the vicinity of the 100 metres, MISS JOOLIA (H. McKechnie) was obliged to alter course to the inside of BELLA DOLCE (J. Toeroek) to obtain clear running and in doing so hampered MORE READY (D. Tootell), which was weakening and taken out by HIGHLAND HENRY (C. Forrest), which laid out. H. McKechnie was reminded of her obligations when shifting ground in future.

TOO COOL TO FOOL (NZ) (J. Holder) commenced to lay in shortly after the entrance to the straight, resulting in J. Holder having to stop riding and straighten his mount and thereafter TOO COOL TO FOOL (NZ) was held up for clear ground when racing behind SECRETMENSBUSINESS (T. Pannell) and to the inside of WRIST WATCH (D. Gauci). TOO COOL TO FOOL (NZ) was only able to obtain clear running approaching the 100 metres where it was obliged to alter course to the outside of WRIST WATCH.

AIR COMET (J. Potter) had to be steadied over the concluding stages when awkwardly placed on the heels of ROWDY ROCKER (S. Carr).

C. Forrest, the rider of HIGHLAND HENRY, reported her mount hung out rounding the home turn.

MISS JOOLIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : CITY OF MARION HANDICAP - 1000 metres

OH GEORGE (D. Tourneur) was slow to begin.

CHELEMBRA, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

OH GEORGE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. T. McEvoy, the Trainer of OH GEORGE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

MINNYMOO was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off hind leg. First Aid was administered.

RACE 6 : MITTYS LAELIA STAKES - 1600 metres

Mr. R. Jolly, the Trainer of DISCO BELLE, which participated in this event, reported on Saturday, 5 April 2014 that on return to stable the filly was examined by the Stable Veterinarian and found to have a bone chip in the near fore knee. He advised the filly would now undergo surgery. Mr. Jolly was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

SHELBY APPLES

Mr. R. Jolly, the Trainer of SHELBY APPLES, advised Stewards on Saturday, 5 April 2014 that subsequent to the filly's last start on 18 September 2013, she had undergone corrective surgery for an epiglottic entrapment.
