RACE 1 : THE SOUTH EASTERN TIMES / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately four minutes owing to KANDY'S PRIDE being unruly en route to the gates. Mr S. McIntyre, the trainer of KANDY'S PRIDE was advised that a warning had been placed on this mare in relation to her pre-race behaviour. The start was further delayed owing to the tongue tie on JEUNE KING CARLOS having to be replaced.

JEUNE KING CARLOS (K. Post) jumped away awkwardly and shifted out, contacting FIRPO (S. Price) taking that gelding out onto the heels of REGAEYA (J. Maund). As a result FIRPO lost its position.

GRAHAM'S GIFT (H. McKechnie) was slow to begin.

JEUNE KING CARLOS (K. Post) was inclined to over-race in the early and middle stages of the event.

RACE 2: O'SULLIVAN TRANSPORT / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1700 metres

LUCKY DESERT (K. Bishop) was slow to begin losing seven lengths and shortly thereafter was slow into stride. Mr S. Gerbert, the trainer of LUCKY DESERT, was advised that the mare would now be required to complete an Official Barrier Trial to the Stewards satisfaction prior to accepting for a future race.

LAZARUS RISING (D. Dunn) jumped away awkwardly, shifted in contacting ROBBIE'S LAW (A. Herrmann) and as a result ROBBIE'S LAW lost ground.

WHAT A SAGA (D. Tourneur) jumped away awkwardly and shifted out, contacting SWITCH POINT (C. Jones) which was tightened onto HASTETOTHEWEDDING (A. Patterson) which had also jumped away awkwardly and shifted in.

SWITCH POINT (C. Jones) was inclined to lay in under pressure in the straight.

RACE 3: DIGIORGIO FAMILY WINES RATING 0-78 HANDICAP - 1400 metres

RAMSGATE (A. Herrmann) was slow to begin.

RAMSGATE (A. Herrmann) was inclined to race ungenerously when being restrained in the early and middle stages of the event.

TRIG (M. Walters) was held up for clear running from approximately the 400 metres until the entrance to the straight when racing behind EQUIVOCATION (H. McKechnie) which was weakening.

H. McKechnie, the rider of EQUIVOCATION, reported her mount may not have appreciated the track conditions.

RACE 4: WESTERN UNITED FINANCIAL SERVICES RATING 0-68 HANDICAP - 1100 metres

EXALTED ANGEL (R. Mageean) jumped away awkwardly and shifted out, contacting MY JESSY (K. Post) which was marginally slow to begin.

ORANGE MUSCAT (NZ) (K. Walters) was slow to begin.

In the vicinity of the 400 metres ORANGE MUSCAT (NZ) (K. Walters) rolled in slightly and as a result KAYJAYEM (NZ) (M. Walters) was obliged to be eased. Shortly thereafter KAYJAYEM (NZ) appeared to dip. K. Walters was reminded of her obligations when shifting ground in future. KAYJAYEM (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GRASSMERE MOOKTA, which performed below expectation, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : RAY WHITE KEATLEY RATING 0-68 HANDICAP - 1700 metres

WORK BEFORE PLAY (C. Jones) jumped away awkwardly and shifted out into the running line of EXALTED LADY (Z. Spain). As a result EXALTED LADY was obliged to steady. Shortly thereafter WORK BEFORE PLAY continued to shift out and bumped NOT BUCKLEY'S (A. Patterson).

Z. Spain, the rider of EXALTED LADY, reported his mount may not have appreciated the track conditions.

CASTANO GIRL, which performed below expectation, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: GRAND MOTEL MILLICENT HANDICAP - 1100 metres

KILL BILL (D. Tourneur) jumped away awkwardly and shifted out.

LOVEMELONGTIME (A. Herrmann) over-raced in the middle stages of the event.

In the vicinity of the 300 metres CONIDEL (C. Jones) attempted a tight run to the inside of LIL BIT MUSKY (R. Stewart) and in doing so CONIDEL had to be steadied. As a result DONNIDI SULINA (NZ) (M. Walters) which was following was obliged to ease. Shortly thereafter CONIDEL continued to attempt a tight run to the inside of LIL BIT MUSKY where there was insufficient room. Inside the 200 metres CONIDEL had to be checked and altered course to the outside of LIL BIT MUSKY. C. Jones was advised that in the opinion of the Stewards there was insufficient room to the inside of LIL BIT MUSKY to attempt the run and

that she had persisted attempting the run for too long. C. Jones was directed that the matter would be reviewed with the Apprentice Training Supervisor and Riding Instructor when she next attended Apprentice School to discuss alternative options when placed in a similar predicament in future.

Over the concluding stages CONIDEL (C. Jones) shifted in under riding at the same time as EXALTED BROTHER (D. Dunn) rolled out marginally. LOVEMELONGTIME (A. Herrmann) which was following had to be steadied. C. Jones was reprimanded and advised only to shift ground when sufficiently clear in future. D. Dunn was reminded of his obligations when shifting ground in future.

MIDNIGHT EXPRESS, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: SCOTT PETROLEUM / SABOIS PLUS MILLICENT CUP - 2100 metres

On arrival at the barriers TUSCAN RANGER was required to be re-saddled.

TUSCAN RANGER (C. Forrest) was slow to begin.

MICKIEM (D. Tourneur) was held up for clear running from in the vicinity of the 400 metres until the entrance to the straight when racing inside GET OUT OF TOWN (J. Hill), behind INNOCENT MUG (M. Walters) and to the outside of BOJANI (A. Herrmann).

RACE 8 : CARAMAR BUSLINES RATING 0-58 HANDICAP - 1400 metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate race.

A. Patterson, the rider of REDIAL, was concerned with the gelding's action en route to the barriers. REDIAL was examined by the Club's Veterinary Surgeon and ruled fit to race.

FRESNEL (J. Hill) jumped away awkwardly and shifted out.
