**RACE 1 : ARKABA / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1400 metres**

TRACY TRUE BLOOD (T. O'Donnell) was slow to begin.

CATCH HIM (R. Bell) laid in under pressure over the concluding stages.

**RACE 2 : HAWKER / SABOIS MAIDEN PLATE - 1100 metres**

PAGANINI'S BROTHER (K. Brooks) reared on jumping away and near the 700 metres had to be steadied off the heels of ALWAYS ABOUT ELLIE (T. O' Donnell).

T. Zanker, the rider of CHUNKY, reported that the filly was inclined to hang in rounding the home turn and in the straight. CHUNKY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : K S RASHEED MEMORIAL RATING 0-62 HANDICAP – 1100 metres**

The start of this race was delayed by approximately eight minutes owing to JACK'S A TIGER TOO escaping the confines of the racecourse.

D. Dunn was severely reprimanded under LR18.1.5 for being dually engaged in this event.

JACK'S A TIGER TOO was a late withdrawal by order of the Stewards at 2.33 pm when the gelding reared on leaving the mounting yard, dislodging its rider, before galloping a considerable distance before escaping the confines of the racecourse. Prior to the announcement of Correct Weight, Stewards ordered all monies invested on JACK'S A TIGER TOO to be refunded in full and all bets made prior to the withdrawal time to be subject to the following deductions: 29 cents in the dollar for the win and 27 cents in the dollar for the place.

MORE PLEASE was kicked behind the barriers and was a late withdrawal on Veterinary advice at 2.41 pm. Prior to the announcement of Correct Weight, Stewards ordered all monies invested on MORE PLEASE to be refunded in full and all bets made between

2.33 pm and 2.41 pm to be subject to the following deductions: 10 cents in the dollar for the win and 13 cents in the dollar for the place.

METRO CAT (T. Zanker) was slow to begin.

Approaching the 950 metres MISS CUTHBERT (L. Stojakovic) shifted in and momentarily tightened ALAKAZOO (T. O'Donnell).

Upon entering the straight BESA BOLA (K. Brooks) shifted in hampering EXALTED ANGEL (Z. Spain). K. Brooks was advised to exercise more care when shifting ground in future.

Following this race, R. Mageean was examined by The First Care Medical Personnel and passed fit to fulfil his remaining engagements.

Mr R. Wilkinson, the trainer of JACK'S A TIGER TOO, was advised a warning had been placed on the gelding in respect to its pre-race behaviour.

### **RACE 4 : NORTHPOINT TOYOTA HAWKER CUP – 1750 metres**

The start of this race was delayed by approximately ten minutes owing to the previous delay and CAPTAIN PERCY escaping the confines of the racecourse.

After being loaded into the barriers CLUB HA HA became fractious, reared up and was momentarily cast. As a result CAPTAIN PERCY (T. O' Donnell) became fractious and broke through the barrier stalls and galloped riderless for a considerable distance before escaping the confines of the racecourse. CAPTAIN PERCY was declared a late scratching at 3.24 pm. Prior to the announcement of Correct Weight, Stewards ordered all monies invested on CAPTAIN PERCY to be refunded in full and all bets made prior to the withdrawal to be subject to the following deductions: 10 cents in the dollar for the win and 13 cents in the dollar for the place.

CLUB HA HA was examined by the Club's Veterinary Surgeon who ruled the gelding fit to start.

DEFONET, JOKEN JIM, MONSTARHIT and ORCHESTRAL were examined by the Club's Veterinary Surgeon and ruled fit to start.

Having regard for the barrier manners of CLUB HA HA. Trainer, Mr B. Lukich, was advised that CLUB HA HA would be required to prove tractable in an approval to race Jump Out or Official Barrier Trial prior to accepting for a future race.

### **RACE 5 : XXXX GOLD WONOKA RATING 0-62 HANDICAP – 1400 metres**

ZIAZAN was a late withdrawal at 9.26 am. Ms H. Smith, the trainer of ZIAZAN, pleaded guilty to a charge under LR19.1 for failing to scratch the gelding by the prescribed time. After considering the matter and the circumstances Ms Smith was fined \$50.

As the saddle cloth for PALLADINO was unavailable, Stewards permitted that gelding to carry an alternate saddle cloth.
