

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 24 May 2014

WEATHER: Fine

RAIL: Out 3 metres 1000m to Winning Post, True Remainder

RACE 1 : JAMES THREDGOLD JEWELLERS HANDICAP - 1300 metres

WESTERN DESERT (J. Holder) knuckled severely at the start, dislodging its rider. As a result of WESTERN DESERT galloping freely, both CELEBRITY TYCOON (S. Westover) and ARTFUL CHARMER (S. Cahill) were inconvenienced in the early stages.

Correct Weight for this event was delayed to allow Stewards to review the start in relation to J. Holder being dislodged from WESTERN DESERT. It was determined WESTERN DESERT was under Starter's orders, was not impeded at the start, jumped on terms but then knuckled severely.

WESTERN DESERT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Holder was examined by the First Care medical staff and declared fit to fulfil his remaining engagements.

RACE 2 : ST ANDREW'S HOSPITAL HANDICAP - 1550 metres

In the vicinity of the 300 metres SATURDAY AFFAIR (J. Holder) shifted out to improve, resulting in LADY DYNAMO (C. Forrest) being obliged to alter course to that mare's inside.

JUSTIFY THAT (J. Childs) laid in, in the straight.

UNDERESTIMATION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : AEP HEALTH GROUP HANDICAP - 2400 metres

The start of this event was delayed approximately ten minutes owing to GOSSIP GURU requiring the attention of the Farrier at the barriers when it was established it lost its near fore plate en route to the start. GOSSIP GURU was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

NO SONG NO SUPPER (J. Childs) pulled hard in the early stages of the event. NO SONG NO SUPPER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CAROUN (IRE) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : THOMAS FARMS HANDICAP - 1400 metres

ABBA (R. Stewart) jumped away awkwardly, shifted out and inconvenienced DESDANE (J. Toeroek).

MISS JOOLIA (H. McKechnie) was awkward to begin.

SMOKY DUBAI (O. Ay) jumped away awkwardly, shifted out and contacted MITFORD GIRL (M. Neilson), which was tightened onto MACCY FIELDS (S. Price), which was inconvenienced.

FLIRTATIOUS GIRL (J. Holder) jumped away awkwardly.

SHADE OF GREEN (C. Forrest) raced wide without cover throughout the event.

Inside the 500 metres until near the entrance to the straight, FLIRTATIOUS GIRL (J. Holder) was unable to obtain clear running.

At the entrance to the straight SMOKY DUBAI (O. Ay) shifted out to improve and brushed with ABBA (R. Stewart), which was taken wider.

Racing to the 300 metres MISS JOOLIA (H. McKechnie) was obliged to alter course to the inside of FLIRTATIOUS GIRL (J. Holder) to obtain clear running and was then inclined to lay out for the remainder of the event.

S. Carr, the rider of MISS WYNETTE, was questioned regarding the use of her whip prior to the 100 metres. She pleaded guilty to a charge under AR137A(5)(a)(i) for using her whip in a consecutive manner on two separate occasions prior to the 100 metres and was fined \$200. S. Carr also pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip in a forehand manner on more than five occasions prior to the 100 metres. Given S. Carr's less than satisfactory record in regard to breaches of AR137A(5)(a)(ii), she was suspended from riding in races for a period to commence at midnight on Saturday, 31 May and to expire at midnight on Sunday, 8 June 2014; a period of three (3) meetings.

ABBA was examined by the Club's Veterinary Surgeon who reported an abrasion to the filly's near side hip.

RACE 5 : MERCEDES-BENZ ADELAIDE HANDICAP - 1250 metres

GREY MUSTANG (J. Toeroek) was slow to begin.

At the entrance to the straight POTICHE (D. Tourneur) shifted out to improve and in doing so tightened HANK'S NEPHEW (O. Ay) onto SUPREME WARRIOR (NZ) (J. Holder), resulting in the hindquarters of SUPREME WARRIOR (NZ) being turned when taken out. As a consequence, SUPREME WARRIOR (NZ) laid back in onto HANK'S NEPHEW, which was tightened onto POTICHE, which continued to shift out marginally. As a result HANK'S NEPHEW lost its position. D. Tourneur was severely reprimanded and advised to take greater care when shifting ground in future.

WHAT'S IN A NAME (M. Neilson) blundered for no apparent reason in the vicinity of the 300 metres and then laid in for the remainder of the event.

POTICHE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near hind leg. Mr T. McEvoy, the Trainer of POTICHE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

HANK'S NEPHEW lost its near fore plate during the event.

RACE 6 : RESOURCECO HANDICAP - 1400 metres

The start of this event was delayed approximately two minutes owing to an interstate delay.

AL CHICAGO (S. Price) jumped away awkwardly.

BALLYPATRICK (J. Frew) was slow to begin and then pulled hard in the early stages.

SPIRITOF ENDEAVOUR (USA) (J. Childs) raced wide without cover throughout the event.

Over the concluding stages RIGHT IDEA (H. McKechnie) shifted in under riding and crossed the running of ROWDY ROCKER (S. Carr), which was momentarily inconvenienced. H. McKechnie was reminded of her obligations when shifting ground.

J. Toeroek, the rider of TUSCAN FEVER, reported his mount hung out during the event. TUSCAN FEVER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. T. Dansie and Ms. N. Storr, the Co-trainers of TUSCAN FEVER, were advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

T. Baker, the rider of DAZZLING LILLY, reported the mare raced like a tired horse. DAZZLING LILLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TUSCAN FEVER lost its near fore plate during the event.

RACE 7 : MCMAHON SERVICES HANDICAP - 1000 metres

The start of this event was delayed approximately eight minutes owing to MR GOOD CAT and DAYTONA GREY requiring the attention of the Farrier on arrival at the barriers when MR GOOD CAT lost its off fore plate en route to the barriers and DAYTONA GREY pulled its near fore shoe at the barriers. Both horses were reshod and examined by the Club's Veterinary Surgeon who ruled them fit to race.

JUST DISCREET (A. Patterson) was very awkward to begin, threw its head up and struck A. Patterson in the face. As a consequence JUST DISCREET lost several lengths. A. Patterson was examined by the First Care medical staff and ruled fit to fulfil his remaining engagements.

UNDENIABLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : HAMILTON HOLDEN HANDICAP - 1000 metres

The start of this race was delayed approximately five minutes owing initially to SWINGING ARMS requiring the attention of the Farrier at the barriers when it lost its off fore plate en route to the barriers, and also owing to CASH IS COMING proving difficult to load. Mr K. Sweeney, the Trainer of CASH IS COMING, was advised a warning had been placed on the filly in relation to its barrier manners. SWINGING ARMS was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

CASH IS COMING (K. Bishop) shifted in at the start and contacted DOUBLE POCKETS (S. Price). Shortly thereafter LIGHT IT UP (J. Childs) rolled out and tightened DOUBLE POCKETS onto CASH IS COMING, which became awkward on the heels of DREAMTIME BABY (R. Stewart). As a consequence CASH IS COMING became very awkward and DOUBLE POCKETS lost its position. J. Childs was severely reprimanded and advised to ensure that when his mounts commence to shift ground shortly after the start he makes an attempt to straighten.

RACE 8 : HAMILTON HOLDEN HANDICAP - 1000 metres (Cont'd)

Approaching the 600 metres RED MAGNET (C. Forrest) shifted in and tightened BUDDY BUNDY (D. Tourneur) onto BALIGARI (M. Neilson), which was taken in onto PISTOLIER (J. Toeroek), which, when tightened, was obliged to be checked, losing its position. As a consequence GINGA GAL (NZ) (H. McKechnie), which was following, became awkward on the heels of PISTOLIER, had to be steadied and shifted out, resulting in DOUBLE POCKETS (S. Price) being inconvenienced. C. Forrest pleaded guilty to a charge of Careless Riding in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 25 May and to expire at midnight on Wednesday, 4 June 2014; a period of four (4) meetings.

C. Forrest, the rider of RED MAGNET, reported her mount made a breathing noise during the event. RED MAGNET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BALIGARI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PISTOLIER was examined by the Club's Veterinary Surgeon who reported a laceration to the off fore fetlock. First Aid was administered.

RACE 9 : ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1000 metres

WICKED TYCOON, which contacted the running rail at the barriers prior to the start, was examined by the Club's Veterinary Surgeon and ruled fit to race.

SHISO (J. Frew) slipped at the start and was awkward to begin.

SPOILSPOT (L. Hopwood) pulled hard in the early stages of the event.

USTINOV'S FURY (J. Potter) became awkward on the heels of BLACK JACK BOY (J. Childs) for a number of strides in the vicinity of the 400 metres, was unable to obtain clear running and thereafter approaching the 200 metres was obliged to alter course to the outside of SHISO (J. Frew) to obtain clear ground.

M. Neilson, the rider of WICKED TYCOON, reported his mount felt awkward in its action. WICKED TYCOON was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. D. Jolly, the Trainer of WICKED TYCOON, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

H. McKechnie, the rider of BUNGALALLY BOY, reported the gelding made a breathing noise during the event. BUNGALALLY BOY was examined by the Club's Veterinary Surgeon who reported a significant degree of the "thumps" and a poor respiratory recovery.
