Report on Race Meeting held at Balaklava Racecourse

RACE 1 : SAGLE CONSTRUCTION / SABOIS FILLIES & MARES MAIDEN PLATE
- 1210 metres

CALL ME PENNY (T. O'Donnell) jumped away awkwardly and shifted out contacting FACE LEICA STAR (K. Bishop).

ROCKY DIAMOND (D. Dunn) raced keenly in the early and middle stages of the event.

MISS CHEEKY CHARLI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : JLB QUALITY CLASS 1 HANDICAP - 1210 metres

Acting on confirmed advice from Mr R. Balfour, co-trainer of SHAABAM, that the gelding had injured itself in its stable prior to being loaded onto the float and was unfit to race, Stewards ordered the withdrawal of SHAABAM at 10.15 am.

GEORDIE'S SECOND (B. Claridge) raced keenly in the early and middle stages of the event and was inclined to lay out throughout. GEORDIE'S SECOND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Approaching the 400 metres HAPPY SYMBOL (J. Frew) was disappointed when attempting to improve to the inside of GEORDIE'S SECOND (B. Claridge), which rolled in slightly, resulting in HAPPY SYMBOL becoming held up for a short distance.

Inside the 100 metres GEORDIE'S SECOND (B. Claridge) shifted in slightly onto HAPPY SYMBOL (J. Frew) which was forced to race in restricted room to the finish.

PIT BOSS (D. Tourneur) was inclined to lay in under pressure over the final 200 metres.

RACE 3 : AUSSIE CIDER / SABOIS MAIDEN PLATE - 1055 metres

FAITH SEEKER (B. Claridge) shifted out on jumping away, contacting the hindquarters of SHAVANO'S IMAGE (J. Holder), inconveniencing that filly.

RACE 3 : AUSSIE CIDER / SABOIS MAIDEN PLATE - 1055 metres (Cont'd)

SHAVANO'S IMAGE (J. Holder) raced keenly in the early and middle stages of the event.

FAITH SEEKER (B. Claridge) hung out severely throughout the event. FAITH SEEKER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer Mr K. Frew was advised that the filly would be required to trail tractably and competitively prior to accepting for a future race.

THE KING OF HAITI (E. Boyd) raced greenly throughout the event, was inclined to shift about in the straight, and in the vicinity of the 150 metres shifted in and had to be steadied off the heels of SUPER ESRA (A. Herrmann). THE KING OF HAITI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : JACOBS CREEK / SABOIS TWO-YEAR-OLD MAIDEN PLATE – 1055 metres

THE LONE RANGA (E. Boyd) shifted out on jumping away and contacted PERFECT GIVEAWAY (K. Bishop).

WARRASIDE EDDY (K. Brooks) jumped away awkwardly and raced keenly in the early and middle stages of the event.

SHEPHERDING (S. Westover) jumped away awkwardly and shifted in, inconveniencing LADY ANDRESS (NZ) (R. Stewart).

THE LONE RANGA (E. Boyd) raced greenly throughout the event.

Approaching the 900 metres TRINKET LADY (D. Dunn) shifted out slightly onto BRIDGEY FLYER (J. Holder), which was taken out, contacting BONITA ICE (B. Claridge), which shifted out and away abruptly making heavy contact with LADY ANDRESS (NZ) (R. Stewart), which was tightened onto AWARD OF MERIT (D. Tourneur), which became unbalanced when taken out onto ZIP DELICIOUS (J. Toeroek), which was hampered when contacting ZERPRISE JOURNEY (S. Price), which was taken wider on the track.

BRIDGEY FLYER (J. Holder) was inclined to lay in under pressure in the straight.

SHEPHERDING (S. Westover) laid in under pressure over the concluding 200 metres. SHEPHERDING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BONITA ICE lost its off hind plate during the running of the event.

Correct Weight was delayed to allow R. Stewart, rider of third placegetter, LADY ANDRESS (NZ), to view the official footage in the vicinity of the 900 metres.

RACE 5 : MY BUTCHER TWO-YEAR-OLD & OVER MAIDEN PLATE - 1410 metres

VALIK (J. Potter) raced keenly in the early and middle stages of the event resulting in RED PEPPER (J. Maund), which was racing behind that gelding, becoming awkwardly placed on its heels and getting its head up and racing fiercely until the entrance to the straight.

RACE 6 : THOMAS COOPER SELECTION 0-62 HANDICAP - 1610 metres

MURTAJACK (T. O'Donnell) jumped away awkwardly.

In the vicinity of the 900 metres NEW CONCEPT (R. Yetimova) commenced to race keenly resulting in that gelding being steadied. As a consequence BRIMMING (S. Westover)

improved onto the heels of NEW CONCEPT and rolled out slightly, inconveniencing KING CADEL (E. Finnegan) and KRYPTON (E. Boyd), which were both taken wider on the track.

TONI'S CONNECTION (K. Brooks) hung out throughout the event. TONI'S CONNECTION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Approaching the finish PRINCE OF HOPE (D. Dunn) rolled in onto TRIUMPHANT ONE (O. Ay), which was forced to race in restricted room to the end of the race.

Stewards questioned R. Yetimova, the rider of NEW CONCEPT, into the use of his whip in the straight. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$300.

RACE 7 : FIRST DEGREE / SABOIS PLUS RATING 0-68 HANDICAP - 2214 metres

MUSTANG SCHILLER (D. Dunn) jumped away awkwardly and was slow into stride.

PIERREMONT ROCKS (R. Stewart) shifted out on jumping away onto WOTZITWORTH (J. Maund), which was taken out onto CALIGO (R. Mageean).

At the entrance to the straight RACHECK'S LEGACY (L. Hopwood) laid out and had to be steadied off the heels of ALLY THE GREAT (T. O' Donnell).

D. Dunn, the rider of MUSTANG SCHILLER, explained that after jumping away poorly he was forced to settle further back than he had hoped, however, the gelding had travelled well in the early and middle stages of the event. He added that he placed MUSTANG SCHILLER under pressure in the vicinity of the 800 metres and it responded to his riding and at the entrance to the straight he felt that he would win the race, however, the gelding had not sprinted as he had anticipated.

GOODNIGHT JOSS was examined by the Club's Veterinary Surgeon who reported the gelding lame in the near foreleg. Trainer Mr J. Smith, was advised that a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

RACE 8 : WOODSTOCK RATING 0-62 HANDICAP - 1408 metres

FALPOLLO (A. Herrmann) raced keenly in the early and middle stages of the event.

At the entrance to the straight COSMIC KHELEYF (S. Price) had to be steadied when he attempted a run to the outside of DATS A LASS (R. Stewart) and inside MASTER BLACK (J. Toeroek) as that gelding rolled in.

MASTER BLACK (J. Toeroek) laid in under pressure in the straight. MASTER BLACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
