# RACE 1 : PETER & ROBYN WALTERS / SABOIS DISTANCE MAIDEN PLATE - 2000 metres

In the vicinity of the 1600 metres LECHENAULTIA (J. Potter) was inclined to jump the vehicle crossing on the track.

In the vicinity of the 250 metres FATE (S. Price) brushed the inside running rail, resulting in its hind quarters being turned out and becoming unbalanced. FATE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

After the running of this event some remedial work was undertaken to the inside running rail in the vicinity of the 250 metres.

### RACE 2 : NRC PATRONS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE HANDICAP - 1000 metres

Mr W. Walters, the Trainer of THE ARMANI (NZ), advised Stewards that there was no suitable crossover nose band on course and requested if the gelding could race without the declared gear. Stewards exceeded to the request and permitted THE ARMANI (NZ) to race without the crossover nose band. Mr. W. Walters was found guilty of a charge under AR140B(2) and was fined \$100. Stewards backdated the removal of the gear.

MISS TORY stood flat footed in the gates and missed the start by several lengths. MISS TORY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr L. Cadzow, the Trainer of MISS TORY, was advised that the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial before accepting for a future trial or race.

BOKARA ROAD (J. Potter) jumped away awkwardly.

LITTLE HULLA (H. McKechnie) was inclined to lay in in the straight.

## RACE 2 : NRC PATRONS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE HANDICAP - 1000 metres (Cont'd)

GOT THE MUNCHIES (A. Doyle) raced very greenly in the straight.

In the vicinity of the 100 metres GOT THE MUNCHIES (A. Doyle) shifted out taking LITTLE HULLA (H. McKechnie) out onto LEGAL VEINE (P. Marks), which was taken wider on the track.

Approaching the winning post BOKARA ROAD (J. Potter) shifted out abruptly of its own accord.

### RACE 3 : MOSS ROOFING & PLUMBING & HAWTHORNE BUILDERS RATING 0-68 HANDICAP - 1000 metres

On jumping away CASINO WIZARD (H. McKechnie) was inclined to get it head up.

BELARUSKI (D. Tourneur) jumped away awkwardly and shifted out, making contact with DADDY'S LITTLELADY (J. Potter).

In the vicinity of the 900 metres ROYAL GLANCE (J. Fry) was inclined to shift in, tightening DADDY'S LITTLELADY (J. Potter) onto BELARUSKI (D. Tourneur), which was taken out slightly by ICONSEEFRAARAWAY (D. Dunn). As a result DADDY'S LITTLELADY was tightened for room and lost its position. J. Fry was severely reprimanded and advised in future to give the riders to his inside the room to which they are entitled.

In the vicinity of the 600 metres ICONSEEFRAARAWAY (D. Dunn) was obliged to be restrained when it commenced to race keenly on the heels of MAGNUSIFICENT (A. Herrmann).

From the vicinity of the 400 metres ICONSEEFRAARAWAY (D. Dunn) was held up for clear running when racing behind CASINO WIZARD (H. McKechnie) and inside GO NINNY GO (S. Price), and was only able to obtain clear ground when able to ease across heels in the vicinity of the 150 metres.

Rounding the home turn GO NINNY GO (S. Price) was awkwardly placed between the heels of COLLA VOCE (A. Doyle), which was inclined to roll about under pressure and CASINO WIZARD (H. McKechnie), which held its line.

In the vicinity of the 100 metres GO NINNY GO (S. Price) was obliged to be eased and shifted out across the heels when COLLA VOCE (A. Doyle) rolled in under pressure. A. Doyle was reminded of his obligations in correcting his mounts when commencing to shift ground.

J. Fry, the rider of ROYAL GLANCE, which performed below expectation, explained that the mare had travelled comfortably in the early and middle stages, however, when placed under pressure in the vicinity of the 600 metres had failed to respond to his riding and in his opinion finished the race off disappointingly. ROYAL GLANCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 4 : SINCLAIR ELECTRICAL RATING 0-78 HANDICAP - 1200 metres

GAUSS (D. Dunn) and MY WAY (M. Munday) were slow to begin.

On jumping away MY WAY (M. Munday) shifted out.

KILL BILL (D. Tourneur) shifted in taking MIDNIGHT EXPRESS (H. McKechnie) in, which brushed with SON OF COCO (W. Walters).

# RACE 4 : SINCLAIR ELECTRICAL RATING 0-78 HANDICAP - 1200 metres (Cont'd)

CONIDEL, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 5 : NRC COMMITTEE / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1430 metres

On arrival on course KNIGHT HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HASTA LA THOMAS (M. Sunday) over raced in the early and middle stages of the event.

In the vicinity of the 500 metres REGAL TIFF (A. Herrmann) was held up on the heels of BONNY BLONDE (H. McKechnie) for a short distance and was obliged to be steadied.

From the vicinity of the 300 metres HASTA LA THOMAS (M. Munday) was held up for a short distance off the heels of KEETIMO (L. Hopwood).

In the vicinity of the 200 metres KEETIMO (L. Hopwood) and URBAN MIRACLE (P. Marks) came together and brushed.

In the vicinity of the 150 metres KNIGHT HERO (S. Price) shifted out and brushed with REGAL TIFF (A. Herrmann).

In the vicinity of the 50 metres URBAN MIRACLE (P. Marks) shifted in, tightening KANDY'S PRIDE (K. Bishop), which was forced to be steadied to avoid the heels of URBAN MIRACLE. P. Marks was severely reprimanded and advised in future to only shift ground when he was entitled to do so.

H. McKechnie, the rider of BONNY BLONDE, reported the filly raced greenly throughout the event. BONNY BLONDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

P. Marks, the rider of URBAN MIRACLE, reported that in the early stages of the event, his mount was inclined to get in and brushed with the inside running rail on two occasions.

### RACE 6 : RACELANDS RACING STABLES RATING 0-68 HANDICAP - 2000 metres

On jumping away WELCOME NED (E. Finnegan) and HENRY'S QUEST (J. Potter) came together and brushed.

On jumping away BONNYKEAST (D. Tourneur) shifted out and made contact with TORRIDON (R. Stewart).

Approaching the winning post on the first occasion TORRIDON (R. Stewart) raced keenly and got its head up when being restrained.

In the vicinity of the 1600 metres HENRY'S QUEST (J. Potter) was obliged to restrain his mount when WORK BEFORE PLAY (H. McKechnie) shifted in. H. McKechnie was severely reprimanded and was advised to ensure she was clear prior to shifting ground.

In the vicinity of the 1700 metres TORRIDON (R. Stewart) was tightened between the heels of BIONDA DREAM (S. Price) and LEATHAL'S LEGACY (D. Dunn), which both shifted ground slightly.

# RACE 7 : GRAROCK PLUMBING & DONNA'S ELECTRICAL RATING 0-68 HANDICAP - 1430 metres

CARTHY ROAD (E. Finnegan) was slow into stride.

ARDROY (J. Fry) pulled hard in the early and middle stages of the event.

From the vicinity of the 400 metres ARDROY (J. Fry) commenced to weaken. ARDROY had left the course prior to being examined by the Club's Veterinary Surgeon. Mr M. Williams, the Trainer of ARDROY was reminded of his obligations under AR117(3) in relation to leaving the course before the time prescribed by the Rules. Mr M. Williams advised that ARDROY would be retired.

S. Cahill, the rider of TONS OF DASH, was questioned regarding the use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

CONSCRIBE (NZ), which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 8 : NARACOORTE FREIGHT CENTRE RATING 0-58 HANDICAP - 1200 metres

On jumping away AKERBOY (E. Finnegan) was tightened between LADY OF TROY (P. Marks), which shifted in at the same time as KAYJAYEM (NZ) (K. Walters) shifted out.

MR DOUGHBOY (C. Jones) jumped away awkwardly and shifted out.

KIRVIC (D. Tourneur) was inclined to race keenly in the middle stages of the event.

From the vicinity of the 600 metres to inside the 100 metres ON THE REBOUND (B. Claridge) was held up for clear running.

From the vicinity of the 400 metres to the inside the 200 metres KAYJAYEM (NZ) (K. Walters) was held up for clear running.

Mr C. Stewart, the Trainer of MADEMOISELLE DENON, was questioned regarding the apparent improved performance of the mare. Mr C. Stewart could offer no explanation other than the addition of the tongue control bit.
