**Report on Race Meeting held at Gawler Racecourse**

**RACE 1 : SANDERS BROS / MITAVITE / SABOIS TWO-YEAR-OLD MAIDEN PLATE –**  
**1200 metres**

SAMSTAG (S. Price) jumped away very awkwardly, shifted out and tightened SCHERZOSO (D. Tourneur) onto BRIDGEY FLYER (J. Holder) resulting in SCHERZOSO being unable to maintain its position.

Inside the 800 metres REGAL MAGNUS (J. Bowditch) shifted in and inconvenienced SAMSTAG (S. Price), which had to be steadied. J. Bowditch was reminded of his obligations when shifting ground.

MASANI STAR, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : WATERSEARCH / SABOIS MAIDEN PLATE - 1200 metres**

MR ROSSELLINI was examined by the Club's Veterinary Surgeon on arrival on course who reported the gelding to be lame in the off hind leg. Acting on this advice, Stewards declared MR ROSSELLINI a late scratching at 11.32 am.

The start of this race was delayed approximately three minutes owing to SINAWEH proving very difficult to load. Mr G. Searle, the Trainer of SINAWEH, was advised the gelding would be required to load without delay in an Approval to Race Jump Out or an Official Barrier Trial prior to accepting for a future race.

SINAWEH (S. Westover) jumped away very awkwardly and contacted TIDY PROPHET (D. Tourneur), which was slow to begin. As a consequence SINAWEH was slow losing two to three lengths.

## **RACE 2 : WATERSEARCH / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)**

FIELDLO (R. Stewart) was slow to begin.

AUTUMNAL (S. Price) laid in, in the early stages of the event and became awkward for several strides when being corrected in the vicinity of the 900 metres.

SINAWEH (S. Westover) and CAVALOCE (J. Holder) over-raced in the early stages of the event.

WHO YOU KNOW (T. Baker) was inclined to lay in, in the straight.

SINAWEH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : GAWLER SOUTH BAKERY MAIDEN PLATE - 1700 metres**

JASPERS GLEN (S. Price) over-raced for some distance inside the 1400 metres.

In the vicinity of the 1000 metres JASPERS GLEN (S. Price) shifted in and inconvenienced THINK TO MYSELF (T. Pannell), which had to be steadied.

JASPERS GLEN (S. Price) was held up for clear running from in the vicinity of the 500 metres until near the 400 metres and prior to the entrance to the straight, was obliged to alter course to the outside of REAL FINNISS (J. Toeroek) to obtain clear ground.

Shortly after the entrance to the straight THINK TO MYSELF (T. Pannell), after initially being held up for a number of strides behind URANIA BELLE (J. Potter), was obliged to steady when awkwardly placed between URANIA BELLE, when improving into a run to the outside of that horse, as a consequence of REAL FINNISS (J. Toeroek) shifting in. Thereafter, in the vicinity of the 200 metres, THINK TO MYSELF shifted out to improve and inconvenienced REAL FINNISS, which was taken wider.

YARN (J. Maund) laid in, in the straight. YARN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**Following the running of this event, the track was upgraded to a Dead 5 at 1.19 pm retrospectively.**

## **RACE 4 : KINGSFORD HOTEL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 metres**

The start of this event was delayed approximately two minutes owing to ASH ROAD proving difficult to load. Mr J. Hickmott, the Trainer of ASH ROAD, was advised that a warning had been placed on the gelding in relation to its loading manners.

LAST MOMENT (R. Stewart) jumped away awkwardly, shifted in and contacted KURTEOUS CAT (O. Ay).

WALKA COUNTRY MILE (E. Finnegan) jumped away awkwardly, shifted in and contacted ALL BAR TWO (L. Hopwood).

ASH ROAD (J. Frew), after initially being held up for a number of strides rounding the home turn, became awkward on the heels of WALKA COUNTRY MILE (E. Finnegan), as that horse

rolled out marginally and was obliged to alter course to that horses outside, to obtain clear running and in doing so, ASH ROAD shifted out very abruptly.

DESTELLO DE LUZ (K. Bishop) raced very greenly in the straight and shifted out abruptly over the concluding stages of the event.

**RACE 5 : JARVIS ISUZU RATING 0-68 HANDICAP - 2100 metres**

MAGIC NIELLO (B. Claridge) got its head down in the barriers just before the gates were released, and dwelt at the start losing one to two lengths. Thereafter MAGIC NIELLO over-raced in the early stages. B. Claridge, the rider of MAGIC NIELLO, reported that as a consequence of the manner in which his horse began, he was obliged to settle further back in the field than intended.

KARIZMA MISS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Trainer, Mr J Vandermyle, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

CALL ME BISCUIT was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both forelegs. Trainer, Mr S. Gower, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

**RACE 6 : COOPERS BREWERY CLASS 2 HANDICAP - 1500 metres**

DOTTY KAY was a late scratching by order of Stewards at 7.53 am acting on confirmed advice from Mr G. Young, the Trainer of DOTTY KAY, that he omitted to scratch the mare by the time required. Mr G. Young was reprimanded under LR19.1 and advised in future to ensure that he scratches his horses by the time required.

RESENDA was a late scratching by order of Stewards at 10.33 am acting on confirmed advice from Mr C. Hotchkiss representative for Trainer Ms K. Duffie that they considered the horse to not be suited to race on a Slow 6 surface. Mr Hotchkiss was advised in future to ensure that all applications for scratching's are made in a timeous manner.

MISS MILAN and GRIGIO NOW both had to be re-saddled at the barriers.

The start of this event was delayed approximately three minutes owing to GEORDIE'S SECOND proving difficult en route to the barriers and arriving late.

In the vicinity of the 1000 metres CALIFORNIA KING (J. Bowditch) shifted in onto BOUNCING BEVERLEY (E. Finnegan), tightening that horse onto GEORDIE'S SECOND (B. Claridge), which laid out and was inclined to shift off the inside rail, resulting in B. Claridge having to steady his mount when being inconvenienced. J. Bowditch was severely reprimanded and advised to only shift ground when entitled to do so.

L. Stojakovic, the rider of ROULETTE PRINCE, reported that the gelding hung out from in the vicinity of the 800 metres.

**RACE 7 : SPORTSBET.COM.AU FIXED ODDS / SABOIS FILLIES & MARES RATING 0-68**  
**HANDICAP - 1200 metres**

The start of this race was delayed approximately two minutes owing to LIZANA rearing after arrival at the barriers, dislodging its rider D. Tourneur and galloping freely for some distance

before breaking through the outside perimeter of the course proper and galloping towards the public area, and was eventually captured near the parade ring. LIZANA was declared a late scratching by order of Stewards at 3.30 pm on Veterinary advice. Ms C. Rose, the trainer of LIZANA and the declared rider, D. Tourneur was questioned regarding the behaviour of the mare after arrival at the barriers. Acting on the submissions made by the parties and on their own observations having regard to the vision available, Stewards advised Ms C. Rose that the mare would be required to prove tractable in an Official Barrier Trial before presenting for a future race.

D. Tourneur was examined by the First Care Medical staff who reported no significant findings.

LADY SILHOUETTE (S. Price) was held up for clear running from the entrance to the straight when racing on the heels of VISUAL IMPACT (O.AY) and to the inside of HAIL MAHER (B. Claridge), which was inclined to lay in and was only able to obtain clear running approaching the 100 metres where it was obliged to shift out very wide on the track.

HAIL MAHER (B. Claridge) laid in throughout in the straight resulting in B. Claridge having to stop riding on several occasions. HAIL MAHER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : JACOBS CREEK RATING 0-62 HANDICAP – 1100 metres**

WILD RUN (S. Westover) jumped away awkwardly, shifted out and contacted GREYBROW (E. Boyd), which was inconvenienced when taken onto CASH JOB (O. Ay).

SPOILSPOT (L. Hopwood) over raced in the early and middle stages of the event.

Inside the 500 metres HAPPY SYMBOL (J. Frew) became held up for a short distance on the heels of ROCK OUT (J. Holder). Shortly thereafter PINKY TUSCADERO (M. Nielson) become held up on the heels of HAPPY SYMBOL, shifted out to obtain clear ground and tightened HIGHLAND HENRY (D. Dunn) onto THE CONCORDE (Z. Spain), which rolled in after racing in tight room to the inside of MY UNCLE VINNIE (J. Maund). As a consequence D. Dunn was obliged to take hold of his mount to avoid the heels of THE CONCORDE and lost his position. M. Nielson, the rider of PINKY TUSCADERO, was severely reprimanded and advised to only shift ground when entitled to do so.

IRISH CHEER (A. Herrmann) became held up for clear running on the heels of PINKY TUSCADERO (M. Nielson) and HIGHLAND HENRY (D. Dunn) from inside the 400 metres until the entrance to the straight.

M. Neilson was found guilty under AR.91 for failing to obtain the permission of Stewards prior to leaving the race course and was fined \$100.

Race 7 – LIZANA – Suspended – Required to prove tractable in Official Trial prior to accepting for future race.
