THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Wednesday, 16 July 2014

RACE 1: ANGELAKIS BROS DISTANCE MAIDEN PLATE - 1950 metres

EMCEECEE (L. Hopwood) was awkward to begin.

HOYLAKE (NZ) (J. Bowditch) raced keenly in the early stages of the event.

J. Holder, the rider of TRESPASSER, explained he had no specific instructions other than to allow the horse to settle where it was comfortable. He stated he was comfortable with his position mid race, however, the gelding was under pressure from the vicinity of the 400 metres, failed to respond to his riding and finished the race off in a disappointing manner. TRESPASSER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: HINDMARSH PLUMBING MAIDEN PLATE - 1000 metres

J. Bowditch which was dislodged from SCARLET LETTER on leaving the mounting yard was examined by the First Care Medical personnel on arrival at the barriers and declared fit to fulfil his engagement.

ARDERE (J. Kah) jumped away very awkwardly, shifted out, contacted MONEY'S MONEY (T. Baker) and shifted back in contacting PTOLEMY (J. Toeroek) resulting in ARDERE being buffeted between MONEY'S MONEY and PTOLEMY for a short distance.

Near the 400 metres ROUSSANNE (E. Boyd) became buffeted between JETMAKER (C. Lindop) and PTOLEMY (J. Toeroek) for a number of strides.

SCARLET LETTER (J. Bowditch) raced greenly in the straight.

T. Baker, the rider of MONEY'S MONEY, reported the filly felt sore in its action during the event. MONEY'S MONEY was examined by the Club's Veterinary Surgeon who reported the filly to be short in its action in both forelegs. Mr P. Beshara, the Trainer of MONEY'S MONEY was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

ARDERE lost its near fore plate during the event.

RACE 2: HINDMARSH PLUMBING MAIDEN PLATE - 1000 metres (Cont'd)

- J. Kah, the rider of ARDERE, reported that as a result of the filly not beginning on terms, she was unable to lead to the extent she intended to in this event. ARDERE was examined by the Club's Veterinary Surgeon who reported a small skin laceration to the near hind pastern.
- S. Price, the rider of TRIPLESS, who was dislodged from his mount on pulling up, was examined by the First Care Medical Personnel and declared fit to fulfil his remaining engagements.

RACE 3: EXPRESS COLOUR PRINTING FILLIES & MARES MAIDEN PLATE - 1400 metres

TRANSFORMING (K. Bishop) was slow to begin losing three to four lengths.

DEVIL'S CHANCE (B. Claridge) raced keenly in the early stages.

FIGURE THIS (L. Hopwood) got its head up and commenced to race keenly when being restrained in an attempt to obtain cover behind DEVIL'S CHANCE (B. Claridge) in the vicinity of the 1200 metres.

RACE 4: DOMINANT TWO-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes owing to TYCOON CHESTER becoming unruly in the mounting yard, rearing and partly dislodging its rider, J. Frew. In the incident TYCOON CHESTER fell over backwards and partly landed on J. Frew, who was examined by the First Care Medical Personnel who declared him unfit to fulfil his remaining engagements. J. Frew was advised he would require a Medical Certificate of Fitness before riding again. TYCOON CHESTER was declared a late scratching by order of Stewards at 1.50 pm. Mr J. Hickmott, the Trainer of TYCOON CHESTER, was advised that in view of the colt's behaviour in the mounting yard, it would now be required to prove tractable at an Official Trial prior to accepting for a future race.

JUST KAPPY (J. Potter) was awkward to begin. At the same time COOL HERO (J. Toeroek) was awkward and shifted out onto JUST KAPPY, which was tightened resulting in the gelding losing its position.

In the vicinity of the 800 metres SUBMARINE (J. Holder), which raced greenly, was inclined to lay in, shifted in and contacted JUST KAPPY (J. Potter), which was tightened onto FREDERATION (T. Baker), which raced ungenerously at the time, resulting in FREDERATION contacting the inside running rail for a number of strides and T. Baker having to check his mount, losing his position. Thereafter FREDERATION was unable to maintain contact with the field. SUBMARINE (J. Holder) continued to race ungenerously for a short distance thereafter.

FREDERATION was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr I. Collins, the trainer of FREDERATION was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

J. Potter, the rider of JUST KAPPY, reported that as a consequence of the interference suffered at the start he was unable to lead in this event as intended. JUST KAPPY was examined by the Club's Veterinary Surgeon who reported the gelding to have minor abrasions to the near fore and off hind leg.

RACE 5: SPORTINGBET C, G & E RATING 0 - 68 HANDICAP - 1250 metres

THE CONCORDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: IRISH RACE DAY AUDUST 30 FILLIES & MARES RATING 0-68 HANDICAP - 1250 metres

Shortly after the start TWIGHLIGHT DANCER (L. Hopwood) was tightened between SCANTY (J. Toeroek) and ZOVISTA (J. Potter), which both shifted ground and lost its position.

TWIGHLIGHT DANCER (L. Hopwood) became held up for clear ground shortly after the entrance to the straight when racing behind QUIET CHAT (J. Bowditch) and RHINESTONE RUBY (J. Holder) and was only able to obtain clear running near the 200 metre where it was obliged to shift to the inside of QUIET CHAT.

Near the 50 metres BELLCHUCA (S. Price) was obliged to check his mount when tightened between QUIET CHAT (J. Bowditch), which rolled in and ZOVISTA (J. Potter), which shifted out under pressure. J. Potter and J. Bowditch were severely reprimanded and advised to ensure they take greater care when their mounts commence to shift ground in future

ZOVISTA lost its near fore plate during the event.

CALL ME PENNY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: SCHWEPPES RATING 0-68 HANDICAP - 1000 metres

SATURDAY'S CHILD (K. Brooks) reared as the gates were released began awkwardly and as a consequence was slow to begin.

POP HERO (S. Cahill) was slow into stride.

KOODA DAWN (B. Claridge) became held up for clear ground shortly after the entrance to the straight when racing behind HOLY GRAIL (T. Pannell) and DON ROBERTO (J. Potter) and was unable to obtain clear ground for the remainder of the event. As a consequence KOODA DAWN was untested to the line.

- L. Hopwood, the rider of RIP APART, accidentally dropped her whip approaching the 100 metres. L. Hopwood was fined \$50 under AR137(a) for carelessness in dropping her whip.
- K. Brooks, the rider of SATURDAY'S CHILD, reported that as a result of the manner in which the gelding began she was unable to take up a forward position as intended.
- S. Cahill, the rider of POP HERO, reported that he intended to settle in a forward position but due to the manner in which the gelding began, was unable to do so and was obliged to settle further back in the field.
- B. Claridge, the rider of KOODA DAWN, explained that he had considered his options shortly after the entrance to the straight, elected to be patient in the hope that a run would develop between HOLY GRAIL (T. Pannell) and DON ROBERTO (J. Potter), which did not eventuate. He considered he had no option to improve to the outside of HOLY GRAIL due to his positioning inside the filly's heels and the position of POP HERO (S. Cahill) in the early part of the straight.

RACE 7: SCHWEPPES RATING 0-68 HANDICAP - 1000 metres (Cont'd)

S. Price, the rider of WRITE NO MORE, explained that he was comfortable with his position in running in the early part of the event but when asked for an effort inside the 500 metres, the mare failed to respond in the manner he expected and finished the race of in a disappointing manner. WRITE NO MORE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Ms K. Byrnes, the Trainer of WRITE NO MORE was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

DON ROBERTO was examined by the Club's Veterinary Surgeon who reported the gelding had dislodged its top and bottom right middle incisors.

ROCK OUT (J. Holder) was inclined to lay in, in the straight. ROCK OUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: MAC JUST OVER? DON'T DRIVE RATING 0-62 HANDICAP - 14000 metres

IRISH CHEER (J. Bowditch) was slow to begin losing one to two lengths.

CAVALOCE (J. Holder) had to be steadied for several strides approaching the 700 metres when awkwardly placed on the heels of EXCITATE (T O' Donnell), which shifted about.

CAVALOCE (J. Holder) was held up for clear running in the early part of the straight when racing behind EXCITATE (T. O'Donnell) and PORTICI (T. Pannell) and was obliged to alter course to the outside of the field to obtain clear running.

J. Holder, the rider of CAVALOCE, explained he was comfortable with his settling position and had considered improving his position approaching the 600 metres but was unable to do so due to the positioning of EXCITATE (T. O'Donnell) and LATIN HERO (S. Cahill) to his immediate outside. He added, as a consequence, he was obliged to ride patiently and at the entrance to the straight he had difficulty obtaining clear ground between PORTICI (T. Pannell) and EXCITATE, which rolled in. He stated, as a result, he was obliged to alter course to the outside of EXCITATE approaching the 200 metres.

JUST A SPARK lost its off fore plate during the event.

RACE 7: TAPESTRY WINES HANDICAP - 1000 metres

Mr D. Jolly, the Trainer of CANON DIABLO, reported to Stewards that the colt coughed repeatedly in the float on return to his stables and for this reason had the colt undergo an endoscopic examination. He advised that the results showed no evidence of exercise induced pulmonary haemorrhage or mucus in the upper airway but extensive "kick back" material was present throughout the length of the trachea.
