

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 19 July 2014

TRACK: Heavy 9 (*Upgraded to Heavy 8 at 12.13 pm, retrospective to Race 1*)

WEATHER: Overcast

RAIL: Out 6 metres 1200m to Winning Post, 3 metres remainder.

RACE 1 : MAC JUST OVER? DON'T DRIVE HANDICAP - 1200 metres

TURBO STREET (J. Holder) jumped away awkwardly.

COOBER'S RUN (J. Toeroek) was slow into stride.

MANHATTAN PRINCE (D. Tourneur) raced keenly in the early stages of the event.

TURBO STREET (J. Holder) was inclined to lay out under pressure from approaching the 200 metres and commenced to hang out severely over the concluding 50 metres, placing J. Holder at a severe disadvantage. TURBO STREET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T. McEvoy, the Trainer of TURBO STREET, was advised a warning had been placed on the gelding in relation to its racing manners.

J. Holder, the rider of TURBO STREET, was questioned regarding his use of the whip prior to the 100 metres. After considering his explanation, J. Holder pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$350.

J. Holder, the rider of TURBO STREET, explained the gelding was inclined to lay out under pressure upon entering the straight, however, in the vicinity of the 50 metres he felt TURBO STREET had hit a soft section of the track and commenced to hang out severely, became unbalanced and lost momentum.

RACE 2 : ENDEAVOUR HOMES HANDICAP - 2020 metres

LABETENOIRE (NZ) (S. Cahill) was slow to begin.

RACE 2 : ENDEAVOUR HOMES HANDICAP - 2020 metres (Cont'd)

THEY CALL ME LISA (R. Stewart) jumped away awkwardly and shifted out, bumping FIELLO (T. Pannell), which was inconvenienced when taken out onto JASPERS GLEN (S. Price), which was hampered.

LABETENOIRE (NZ) (S. Cahill) raced keenly in the early stages of the event.

JASPERS GLEN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : ADELAIDE GALVANISING HANDICAP - 1200 metres

LIGHT IT UP (J. Bowditch) shifted in on jumping away, contacting BOLDACIOUS GIRL (J. Kah).

On entering the straight MASTER BLACK (K. Bishop) shifted in under pressure and was then inclined to lay in for the remainder of the event.

L. Hopwood, the rider of MEADOWS ANGEL which performed below expectations, explained the gelding had travelled comfortably in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 500 metres had failed to respond to her riding and in her opinion had not handled the track condition. MEADOWS ANGEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of CASINO WIZARD which performed below expectations, explained the gelding had not travelled well during the event and when placed under pressure had failed to respond to his riding and in his opinion had not appreciated the track condition. CASINO WIZARD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MASTER BLACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : HOLDFAST INSURANCE HANDICAP - 2050 metres

The start of this race was delayed approximately one minute to avoid a clash with an interstate event.

From the vicinity of the 600 metres until approaching the 400 metres BAKLAVA BOY (NZ) (J. Bowditch) was held up when racing behind DUMOSA (K. Bishop), which had commenced to give ground, and inside DOC HENNESSY (T. Pannell).

CAROUN (IRE) (J. Kah) laid in under pressure in the straight.

DOC HENNESSY (T. Pannell) laid out throughout the event.

ISAIAH, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BARRIERS, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : EVRIGHT HANDICAP - 1200 metres

The start of this race was delayed approximately one minute owing to OUR LITTLETREASURE (S. Price) becoming fractious in its barrier after being loaded. OUR LITTLETREASURE was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

WISE AND HAPPY (S. Carr) dipped on jumping away.

WISE JOURNEY (K. Bishop) was slow to begin.

Shortly after the start BELFAST BOY (J. Kah) shifted out slightly, contacting WISE JOURNEY (K. Bishop), which was inconvenienced when tightened onto NIGHT BREEZE (L. Hopwood).

In the vicinity of the 800 metres BELFAST BOY (J. Kah) raced keenly when awkwardly placed on the heels of SHEEZ ON TOP (J. Toeroek) and shifted out, contacting NIGHT BREEZE (L. Hopwood), which was inconvenienced when taken wider on the track.

SUPER SILKS (NZ) (J. Matthews) raced wide without cover throughout the event.

LAST DAY (NZ) (J. Holder) laid in under pressure in the straight, resulting in J. Holder having to stop riding and straighten on a number of occasions.

Correct Weight for this event was delayed owing to J. Kah, the rider of BELFAST BOY, weighing in approximately two kilograms under the weight she weighed out at. Stewards were able to determine the lead bag that J. Kah had weighed out with was missing and it was discovered in the stall area of Trainer Mr. G. Richards. After Stewards questioned both Trainer and rider, Mr. G. Richards pleaded guilty to a charge under AR143(b) for being the person at fault for J. Kah weighing in under her allocated weight and was fined \$750. Acting under AR143(a), BELFAST BOY was disqualified from the event.

LAST DAY (NZ), which laid in, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WISE JOURNEY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SHEEZ ON TOP was examined by the Club's Veterinary Surgeon who reported the mare had a minor laceration to the near hind hock, which was consistent with being galloped on.

RACE 6 : TAPESTRY WINES HANDICAP - 1800 metres

The start of this race was delayed approximately one minute to avoid a clash with an interstate event.

Inside the 400 metres FINNISS POWER (K. Bishop) rolled in slightly as that horse commenced to weaken, resulting in FREE THE WIND (J. Holder) being forced to steady and alter course to obtain clear ground.

Approaching the 200 metres FREE THE WIND (J. Holder) became awkwardly placed on the heels of LUNAR NOVA (J. Bowditch) for a short distance and was only able to obtain clear ground when that gelding commenced to roll out.

SMOKE BURNER, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following this event R. Stewart was examined by the First Care medical staff who ruled him unfit to fulfil his remaining engagements.

RACE 7 : JAMES BOAG PREMIUM HANDICAP - 1050 metres

EL PRADO GOLD (S. Westover) was slow to begin.

Shortly after the start ACHENAR (J. Potter) rolled out onto EGO'S GOOD (E. Boyd), which was taken out onto BRAVE JOURNEY (K. Bishop), which was inconvenienced.

C. Forrest, the rider of OGUNDE, which performed below expectations, reported the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight had failed to respond to her riding and had finished the event off poorly.

J. Holder, the rider of MORE THAN EAGLE, which performed poorly, explained the mare had travelled well in the early and middle stages, however, when placed under pressure in the vicinity of the 500 metres failed to respond to his riding, was reluctant to stretch out and in his opinion had not handled the track condition. MORE THAN EAGLE collapsed in the parade ring on return to its stall and was deceased when examined by the Club's Veterinary Surgeon.

RACE 8 : TATSBET HANDICAP - 1600 metres

From the vicinity of the 700 metres until near the 400 metres BELGIETTO (S. Price) was held up when racing behind DANISH SPY (S. Cahill) and inside HALAYR JET (C. Lindop) and shifted out on a number of occasions, brushing with HALAYR JET.

From the vicinity of the 500 metres until near the 300 metres LORD ASHFORD (C. Forrest) became held up when awkwardly placed on the heels of WARATOR (J. Toeroek), which had commenced to give ground, and inside ALLEZ TARA (T. Pannell).

CRYSTAL ICON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
