RACE 1: HOLCIM / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1498 metres

SWEET CAROLINE (T. Baker) began awkwardly and shifted out onto MEADOWS WINGS (D. Tootell).

TRACY TRUE BLOOD (T O' Donnell) was slow to begin.

MISS CHEEKY CHARLI (L. Hopwood) raced keenly in the early stages of the event.

In the vicinity of the 1200 metres TRACY TRUE BLOOD (T O' Donnell) raced in restricted room inside FACE LEICA STAR (Z. Spain), which shifted in and away from MISS CHEEKY CHARLI (L. Hopwood).

Approaching the 300 metres Z. Spain, the rider of FACE LEICA STAR, was obliged to restrain his mount after attempting a run between EMAIL (J. Kah) and MORETHANYOUTHINK (S. Price), which did not eventuate. Z. Spain was reprimanded for Careless Riding and advised only to attempt to take runs once they present themselves.

L. Hopwood, the rider of MISS CHEEKY CHARLI, explained that the filly was under pressure a long way out and had failed to finish the race off. MISS CHEEKY CHARLI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : VEOLIA ENVIRONMENTAL SERVICES / SABOIS MAIDEN PLATE - 1100 metres

On arrival on course JUNKET, which had not raced for approximately three years was examined by the Club's Veterinary Surgeon who passed the mare fit to start.

PAGANINI'S BROTHER (Z. Spain) began awkwardly.

MISS SERENDIPITY (J. Potter) began awkwardly, shifted out and made contact with SMARTIE SCHILLER (J. Kah).

From the 700 metres until approaching the 500 metres PAGANINI'S BROTHER (Z. Spain) raced ungenerously.

Making the home turn, DAJEBONY RO (S. Carr) was held up on the heels of DELAWAY BROM (T. Baker).

In the vicinity of the 100 metres DELAWAY BROM (T. Baker) shifted in under pressure inconveniencing DAJEBONY RO (S. Carr), which was obliged to shift to the outside of DELAWAY BROM'S heels to obtain clear running. T. Baker, the rider of DELAWAY BROM, was advised to exercise greater care when shifting ground in future.

RACE 3: WHYALLA EARTHWORKS PTY LTD / SABOIS TWO-YEAR-OLD HANDICAP - 1100 metres

OBJECTION (T. Baker) knuckled over badly on jumping away.

TIPSY ON RED (C. Lindop) began awkwardly.

Approaching the 800 metres TIPSY ON RED (C. Lindop) was inclined to lay out and had to be steadied off the heels of SEPTEMBER STORM (L. Hopwood). TIPSY ON RED was inclined to race ungenerously for a short distance thereafter.

ABBANABBI ABBANEW (C. Forrest) was inclined to lay out under pressure over the concluding stages and approaching the winning post had to be steadied off the heels of SOUTHERN SEA (T. O'Donnell).

T. Baker, the rider of OBJECTION, reported that after knuckling over on jumping away, the filly was reluctant to race and took no competitive part in the event. OBJECTION was examined by the Club's Veterinary Surgeon who reported the filly to be shin sore and had ulcers in both sides of the mouth. Mr B. Smart, the Trainer of OBJECTION, was advised that a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future race or trial. Mr B. Smart reported that OBJECTION would be spelled.

RACE 4: EVENTS WHYALLA RATING 0-58 HANDICAP - 1100 metres

HEZAFRAAR (E. Finnegan) began awkwardly and shifted in onto ACT OF FAITH (R. Mageean), which also began awkwardly and as a result unbalanced its rider. ACT OF FAITH was then tightened between HEZAFRAAR and HE'LL TELL US (S. Carr), which was taken out on jumping away by SUPER ESRA (T. Baker).

COMSTRUM (T. Zanker) was slow to begin.

BIT O' ME (J. Potter) began awkwardly.

CARDINAL MISSION, which performed disappointingly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : ASSET PROTECTIVE FENCING BENCHMARK HANDICAP 80 HANDICAP - 1200 metres

DABAMIRAK (Z. Spain) shifted in and made contact with SPIRIT OF FLATLEY (J. Potter) on jumping away.

SHISO (J. Kah) was tightened in between GRAND TAJ (S. Price) and ST IVES (NZ) (T. Zanker) on jumping away.

Shortly after the start ST IVES (NZ) (T. Zanker) shifted in and away from SHISO (J. Kah) and became awkwardly placed on the heels of DABAMIRAK (Z. Spain).

SPIRIT OF FLATLEY was examined by the Club's Veterinary Surgeon who reported that the gelding had an unusual gait but in his opinion was not lame.

RACE 6 : BUDGET RENT A CAR WHYALLA & PORT AUGUSTA RATING 0-62 HANDICAP - 1396 metres

FINNISS MOMENT (R. Mageean) was slow into stride.

Shortly after the start LUCKY SUNDAY (E. Finnegan) was inclined to lay in and had to be steadied off the heels of CAPACITATE (J. Potter) and in doing so brushed BLAKELEY (C. Forrest).

Approaching the 1200 metres LUCKY SUNDAY (E. Finnegan) shifted out and brushed BLAKELEY (C. Forrest).

TRUE SASSO (J. Toeroek) over-raced in the middle stages.

RACE 7 : CITY OF WHYALLA CUP - 1867 metres

MOUNTAIN CLIMBER was re-saddled upon arrival at the barriers.

MOUNTAIN CLIMBER (A. Doyle), SPANISH HALO (NZ) (S. Price) and SLIPPERY NINJA (J. Toeroek) were all slow to begin.

A. Doyle, the rider of MOUNTAIN CLIMBER, was questioned regarding his use of the whip over the concluding stages. A. Doyle stated he was of the belief that he was in contention for fourth place and as such had continued to ride his mount out with the whip. A. Doyle was reprimanded under AR137A(4)(b) for using the whip in a manner which raises his arm above shoulder height.

RACE 8: TINDALL GASK BENTLEY LAWYERS RATING 0-58 HANDICAP - 1600 metres

The start of this event was delayed approximately two minutes.

Upon return to scale E. Finnegan, the rider of ODETTE, made application for her mount to be declared a non-runner. After taking evidence from E. Finnegan, Ms L. Conlon, the Trainer of ODETTE and Mr S. Pearson, tho Official Starter as well as viewing the Official Footage and acting upon their own observations, Stewards ruled that ODETTE be declared a runner and Correct Weight was issued on the judges placing's.

After being loaded into the barriers, E. Finnegan, the rider of ODETTE, had attempted to adjust her goggles as the start was effected and as a result was slow to begin.

RACE 8: TINDALL GASK BENTLEY LAWYERS RATING 0-58 HANDICAP - 1600 metres (Cont'd)

TIGER JET (T. O' Donnell) began awkwardly and shifted out making contact with CROSS CONSTANCE (J. Toeroek).

On jumping away BURN SO BRIGHT (NZ) (J. Potter) made contact with TEAM LAGO (T. Zanker), both of which shifted ground.

- T. O' Donnell, the rider of TIGER JET, explained that the gelding was inclined to lay in under pressure over the concluding stages and as such she was not able to ride her mount out to the line.
- C. Forrest, the rider of BESA BOLA, pleaded guilty to a charge under AR145 in that she returned to scale one kilogram over her allotted riding weight. After considering the evidence and the fact that BESA BOLA had been beaten 1.7 lengths, C. Forrest was fined the sum of \$200 and advised of her right to appeal.
