**RACE 1 : THE TERRACE MAIDEN HURDLE – 3280 metres**

TROBEN (J. Lynch) jumped the first hurdle in the vicinity of the 3000 metres awkwardly resulting in that rider losing both his irons J. Lynch was unable to regain the use of his irons until after he had jumped the next hurdle.

TROBEN (J. Lynch) pulled hard for some distance in the middle stages.

FANTAUZZO (N. O'Shea) and BAKLAVA BOY (NZ) (M. Kelly) raced wide without cover in the middle stages of the event.

In the vicinity of the 800 metres TROBEN (J. Lynch) was eased out of the event. TROBEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr J. Dunn, the Trainer of TROBEN, was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Jumping Trial prior to accepting for a future jumping event.

ORBITAL MOTION (S. Jackson) jumped the last hurdle in the straight awkwardly.

BAKLAVA BOY (NZ), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. First Aid was administered. Mr G. Young, the Trainer of BAKLAVA BOY (NZ), was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

ORBITAL MOTION lost its near fore plate during the event.

**RACE 2 : JARVIS ISUZU / SABOIS DISTANCE MAIDEN PLATE - 2100 metres**

BELLOTTOS DAUGHTER (D. Tourneur) was slow to begin.

In the vicinity of the 600 metres BELLOTTOS DAUGHTER (D. Tourneur), which had attempted to improve into a tight run to the inside of MR ROSSELLINI (S. Carr) as that gelding commenced to give ground, had to be restrained and shifted to the outside of

MR ROSSELLINI. As a result BELLOTTOS DAUGHTER clipped the heels of MR ROSSELLINI. D. Tourneur was reprimanded and advised to only attempt runs when there is sufficient room in future.

Passing the winning post on the first occasion RECHARGING TO WIN (J. Holder) and MR ROSSELLINI (S. Carr) came together and brushed.

S. Carr, the rider of MR ROSSELLINI, reported that the gelding had raced untractably throughout the event and the bit had pulled through the gelding's mouth in the middle stages of the event making the gelding difficult to control. MR ROSSELLINI was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both hind legs. Mr J. Hyam the Trainer of MR ROSSELLINI was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

BELLOTTOS DAUGHTER was examined by the Club's Veterinary Surgeon who reported the mare to have a minor laceration to inside of near fore knee. First Aid was administered.

## **RACE 3 : COOPERS BREWERY / SABOIS FILLIES & MARES MAIDEN PLATE** **- 1100 metres**

Acting on confirmed advice from Mr R. Jolly, the Trainer of PERFECT YANK that the filly was lame in its off foreleg and was unfit to race, Stewards withdrew PERFECT YANK at 8.30 am.

WILD RED (J. Matthews) jumped away very awkwardly and shifted in at the same time as MOLTO VIVACE (L. Stojakovic) shifted out resulting in ELECTRIC PUSSYCAT (D. Tourneur) becoming tightened and losing its position.

BYTHESTARS (R. Mageean) threw its head up on jumping away.

In the vicinity of the 700 metres WILD RED (J. Matthews) was obliged to steady and lose its position when ELECTRIC PUSSYCAT (D. Tourneur) shifted out and MARRIED FOR MONEY (J. Frew) rolled in slightly. D. Tourneur was severely reprimanded and advised in future to only shift ground when entitled to do so.

Rounding the home turn ELECTRIC PUSSYCAT (D. Tourneur) was held up behind MOLTO VIVACE (L. Stojakovic) and BEESRULETHEWORLD (K. Brooks) for a short distance.

In the early stages of the straight BYTHESTARS (R. Mageean) laid in under pressure.

MOLTO VIVACE (L. Stojakovic) was inclined to lay out under pressure in the straight

Over the final 100 metres ELECTRIC PUSSYCAT (D. Tourneur) was inconvenienced when CARAJILLO (E. Finnegan) rolled in, resulting in ELECTRIC PUSSYCAT having to ease across the heels to the outside of that filly to obtain clear running. E. Finnegan was reminded of her obligations in straightening her mounts when they commence to shift ground.

From the vicinity of the 100 metres BEESRULETHEWORLD (K. Brooks) was held up for clear running behind MOLTO VIVACE (L. Stojakovic) and inside SHELLY ANN (J. Holder) until the winning post.

CARAJILLO lost its off fore plate during the event.

ELECTRIC PUSSYCAT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 4 : RSMU HAWKS / SABOIS MAIDEN PLATE - 1200 metres**

As Stewards were able to identify GOD'S AURA from records held by them when the Thoroughbred Identification Card was not available as required, the gelding was permitted to start. Mr J. O' Connor, the Trainer of GOD'S AURA, pleaded guilty to a charge under AR59A and was fined \$50.

D. Dunn, the rider of PUPPETRY IN MOTION, was dislodged en route to the barriers. D. Dunn was examined by the First Care Medical Personnel who ruled him fit to ride.

The start of this event was delayed approximately three minutes owing to NEXT DAY proving very difficult to load. Mr D. Jolly, the Trainer of NEXT DAY, was advised the gelding would be required to perform to Stewards satisfaction in an Official Barrier Trial or Approval Jump Out prior to accepting for a future race.

The start was also delayed owing to SCARLET LETTER which became fractious in the barriers being examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

SCARLET LETTER (A. Herrmann) shifted in on jumping away and made contact with ORLANDO'S CHARM (J. Kah)

SCARLET LETTER (A. Herrmann) raced wide without cover and was inclined to lay in throughout the event.

D. Tourneur, the rider of GOLD CURRENCY, reported that his saddle slipped back in the vicinity of the 600 metres and had placed him at a disadvantage for the remainder of the event.

A. Herrmann, the rider of SCARLET LETTER, reported the mare never travelled and did not feel comfortable throughout the event. SCARLET LETTER was examined by the Club's Veterinary Surgeon who reported minor lacerations to the end of the tongue.

#### **RACE 5 : GAWLER SOUTH BAKERY / SABOIS FILLIES & MARES RATING 0-68 HANDICAP - 1100 metres**

Acting on confirmed advice from Ms K. Byrnes, the Trainer of WRITE NO MORE, that the mare was lame in its off foreleg and unfit to race, Stewards withdrew WRITE NO MORE at 10.23 am.

LEAHONE (K. Brooks) raced very wide without cover throughout the event.

K. Brooks, the rider of LEAHONE, reported that the mare, in her opinion, had raced flat and never let down. LEAHONE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 6 : SUNSET AND SADDLES CLASS ONE HANDICAP - 1200 metres**

In the vicinity of the 1000 metres CANON DIABLO (J. Toeroek) raced ungenerously for a short distance.

In the vicinity of the 900 metres SCANTY (A. Patterson) shifted in when insufficiently clear of STACK THE TRUCK (R. Mageean), which was taken in onto BELLE OF THE SOUTH (R. Stewart), which was forced to restrain and lost its position. A. Patterson pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Sunday, 10 August and to conclude at midnight on Sunday, 17 August 2014: a period of three (3) meetings.

### **RACE 6 : SUNSET AND SADDLES CLASS ONE HANDICAP - 1200 metres (Cont'd)**

At the entrance to the straight STACK THE TRUCK (R. Mageean) was held up behind DISAGREE (J. Kah) and inside LEMERIO (S. Price) for a short distance.

J. Toeroek, the rider of CANON DIABLO, explained that the gelding had travelled well throughout but finished the race off disappointingly. CANON DIABLO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 7 : SPORTSBET.COM.AU – 1706 metres**

After being loaded HELD HOSTAGE broke through the gates and was quickly restrained by its rider. HELD HOSTAGE was examined by the Club's Veterinary Surgeon who ruled the mare fit to start.

SANDHILL JETT (D. Dunn) raced three wide without cover in the middle stages for some distance.

From the vicinity of the 400 metres SHEIK OF TWEAK (R. Stewart) commenced to weaken from the event. SHEIK OF TWEAK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LADY SILHOUTTE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 8 : BETTY HICKEN MEMORAIL RATING 0-58 HANDICAP – 1506 metres**

On arrival at the barriers, E. Finnegan, the rider of NAVAN LASS, was concerned with the mare's action. NAVAN LASS was examined by the Club's Veterinary Surgeon and was ruled fit to race.

CONQUEST OF ARMS (T. Zanker) jumped away very awkwardly unbalancing its rider for a short distance.

BELLE'S REWARD (S. Price) raced three wide without cover during the middle stages of the event.

ITS LUMSDEN (K. Brooks) raced keenly during the middle stages of the event.

S. Cahill, the rider of QUINN'S TURN, reported that in his opinion, the gelding did not handle the track and did not feel comfortable in its action. QUINN'S TURN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

T. Baker, the rider of KHAIBAR, reported that the gelding was inclined to lay out from the vicinity of the 800 metres. KHAIBAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ETERNAL HEART was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

NAVAN LASS, which performed poorly, was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.
