RACE 1 : FARMERS UNION ICED COFFEE HANDICAP - 1100 metres

MEADOWS ANGEL (J. Frew) jumped away awkwardly, shifted in and contacted WISE JOURNEY (S. Carr). Thereafter both MEADOWS ANGEL and WISE JOURNEY were slow into stride.

DECADES (C. Lindop) and CALIANCO (K. Bishop) both over-raced in the early stages of the event.

S. Carr, the rider of WISE JOURNEY, explained her instructions were to take up a forward position in running but due to the manner in which the gelding began and its reluctance to respond to her riding in the early stages, she was unable to do so.

J. Kah, the rider of MOSQUE, reported the gelding made a breathing noise during the event. MOSQUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TRUENO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DECADES, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : ENDEAVOUR HOMES HANDICAP - 1200 metres

MAGLISSA (C. Lindop) jumped away awkwardly, shifted out and brushed FLASK (T. Pannell).

AZZCOOL (J. Toeroek) jumped away awkwardly, shifted out and tightened TWILIGHT DANCER (A. Herrmann) onto ACES AND ANGELS (R. Wheeler), which was inconvenienced when taken out.

MAGLISSA (C. Lindop) over-raced in the early stages of the event.

J. Kah, the rider of LIONHEARTED GIRL, reported the mare travelled only fairly in the early and middle stages and when placed under pressure in the vicinity of the 600 metres, failed to respond to her riding and she became concerned with its action. LIONHEARTED GIRL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. N. Walker, the Trainer of LIONHEARTED GIRL, advised the mare would now be spelled.

RACE 2 : ENDEAVOUR HOMES HANDICAP - 1200 metres (Cont'd)

L. Hopwood, the rider of NIMASAEL, reported the mare did not travel comfortably throughout the event and she became concerned with its action in the straight. NIMASAEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Bowditch, the rider of SO HASTY, reported the mare travelled fairly in the early stages of the event, however, when placed under pressure in the vicinity of the 500 metres, failed to respond to his riding and he became concerned with the mare's action over the concluding stages. SO HASTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ACES AND ANGELS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : KEVERN KLEMICH MEMORIAL GRAND NATIONAL HURDLE- 3500 metres *(Run on Morphetville Parks Track)*

FANTAUZZO (P. Flood) contacted the first of the double in the straight on the final occasion, stumbled and fell, dislodging P. Flood. As a consequence ISIAH (P. Gallagher), which was following, was obliged to be checked and altered course to the outside of the fallen horse and rider. P. Flood was examined by the First Care medical staff who reported no significant findings.

Following the event DUMOSA, URBAN EXPLORER (NZ), TAKE OUT, FANTAUZZO and ISIAH were all examined by the Club's Veterinary Surgeon who reported that ISIAH sustained a minor laceration to the off hind pastern and FANTAUZZO was lame in the off hind leg. Mr. J. O'Connor, the Trainer of the FANTAUZZO, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 4 : EVRIGHT THREE-YEARS-OLD MAIDEN PLATE - 1050 metres

LOQUETEUX (J. Toeroek) began very awkwardly, shifted in and contacted DEANNA JEAN (J. Potter), which was inconvenienced.

BEST OF TIMES (J. Matthews) began awkwardly.

RAINBOW REFLECTION (C. Forrest) and PEPPER THE PIN (C. Lindop) were slow to begin.

TIGER RUBY (S. Price) was inconvenienced shortly after the start when tightened between BEST OF TIMES (J. Matthews), which rolled out, and SILENT WHISPER (J. Bowditch), which shifted in.

In the vicinity of the 800 metres PEPPER THE PIN (C. Lindop) shifted in sharply, away from YODINI (J. Holder), as that gelding improved to its outside, and contacted TIGER RUBY (S. Price), which was tightened onto BEST OF TIMES (J. Matthews), which in turn contacted LOQUETEUX (J. Toeroek), turning that gelding's hindquarters as it became awkward on the heels of DEANNA JEAN (J. Potter), which commenced to race ungenerously and rolled out. As a consequence, LOQUETEUX laid out onto BEST OF TIMES, resulting in TIGER RUBY, BEST OF TIMES and LOQUETEUX all being severely hampered and becoming unbalanced for several strides. RAINBOW REFLECTION (C. Forrest), which was following, was obliged to alter course to the outside of runners to avoid the incident. Stewards were satisfied that no one rider was to blame for the incident.

MIRACLE THE SECOND (R. Hurdle) became held up for clear ground from in the vicinity of the 300 metres until inside the 200 metres when racing between the heels of TIGER RUBY (S. Price) and SILVER MINT (J. Kah), which commenced to weaken.

In the vicinity of the 100 metres JUST DEMANDING (A. Herrmann) dipped for no apparent reason.

RACE 4 : EVRIGHT THREE-YEARS-OLD MAIDEN PLATE - 1050 metres (Cont'd)

TIGER RUBY and MIRACLE THE SECOND were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : FARRELL O'NEILL HANDICAP - 1600 metres

On arrival on course, IRISH HIGH KING, which had not raced since January 2012, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

The start of this event was delayed approximately seven minutes owing to ON A DREAM requiring the attention of the Farrier on arrival at the barriers due to the gelding having lost its near fore plate. After several attempts the Farrier was able to re-plate the gelding. ON A DREAM was examined by the Club's Veterinary Surgeon who ruled it fit to race, but thereafter, when being presented to load into the barriers, ON A DREAM initially refused to be loaded and after being loaded into its barrier stall proved fractious and was declared a late scratching by order of Stewards at 3.01 pm.

In the vicinity of the 500 metres BRIMMING (C Forrest) shifted in and inconvenienced PIT BOSS (J Holder) for a short distance. C. Forrest was reprimanded and advised to take greater care when shifting ground in future.

J. Bowditch, the rider of ATHLETICISM, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

RACE 6 : HAPPY 101ST STAN COYLE HANDICAP - 2000 metres

The start of this event was delayed approximately two minutes owing to MIDNIGHT GLORY, which got its leg up onto the barrier partition, having to be examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

CAROUN (IRE) (C. Lindop) dipped for no apparent reason shortly after the crossing near the 1800 metres.

TIMELYINTERRUPTION (L. Hopwood) pulled hard in the early stages of the event.

Inside the 700 metres WARATOR (J. Holder) improved onto the heels of MIDNIGHT GLORY (C. Lever) and DANISH SPY (J. Toeroek) and was obliged to be steadied for several strides.

ST GABRIEL (S. Price) was held up momentarily at the entrance to the straight.

J. Holder, the rider of WARATOR, was questioned regarding his use of the whip prior to the 100 metres. J. Holder pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$350.

J. Kah, the rider of SAINT DESIR (GB), reported from in the vicinity of the 500 metres the gelding was off the bridle and failed to finish the race off. SAINT DESIR (GB) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CAROUN (IRE) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Ms. S. Barr, the Trainer of SAHARA SYMPHONY, advised Stewards the gelding would now be spelled.

RACE 7 : DAVID R COLES AM SPRING STAKES - 1200 metres

No report.

RACE 8 : ADELAIDE GALVANISING HANDICAP - 1050 metres

Mr J. MacMillan, the Trainer of DAUNTING DANCER, advised Stewards he would be instructing Jockey J. Kah to attempt to obtain a handy position with cover and not to lead.

CORVIDAE (D. Dunn) shifted out shortly after the start and tightened BELFAST BOY (M. Vance) onto WHAT'S IN A NAME (J. Bowditch), resulting in BELFAST BOY losing its position. D. Dunn was reminded of his obligations when his mounts commence to shift ground.

EXALTED WILLIAM (C. Lindop) became held up for clear running shortly after entering the straight when awkwardly placed inside the heels of IMPULSE BUY (S. Carr) as that gelding shifted in under riding. As a consequence EXALTED WILLIAM was unable to obtain clear running for a short distance thereafter when racing on the heels of CORVIDAE (D. Dunn) and to the inside of IMPULSE BUY. S. Carr was reminded of her obligations and advised to stop riding and straighten her mounts when they commence to shift ground in future. Shortly thereafter, inside the 200 metres, EXALTED WILLIAM shifted to the outside of CORVIDAE to improve between that horse and IMPULSE BUY but was disappointed for clear ground and obliged to steady and alter course to the inside of CORVIDAE as that horse shifted out when taken out by BRAVE JOURNEY (K Bishop). Inside the 100 metres, when improving to the inside of CORVIDAE, EXALTED WILLIAM was hampered, taken in and unable to improve its position as CORVIDAE continued to shift ground inwards. As a consequence, EXALTED WILLIAM was untested to the line and was obliged to be steadied off the heels of BELFAST BOY (M. Vance) over the concluding stages as that gelding rolled out. D. Dunn was reminded of his obligations when shifting ground in future.

Inside the 200 metres WHAT'S IN A NAME (J. Bowditch) shifted out to improve at the same time as EL PRADO GOLD (A. Patterson) rolled in, resulting in DAUNTING DANCER (J. Kah), which had improved between these two runners, having to be steadied to avoid the heels of WHAT'S IN A NAME. J. Bowditch was reminded of his obligations when shifting ground in future.

GENERAL:

RACE 1 : FARMERS UNION ICED COFFEE HANDICAP - 1100 metres

Mr. J. MacMillan, the Trainer of MOSQUE, advised Steward that on return to stable the gelding was found to be lame in the off foreleg. Mr. MacMillan was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
