Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 16 August 2014

RACE 1 : MINT LANE HANDICAP - 1600 metres

ON A DREAM was a late scratching by order of Stewards at 9.20am acting on confirmed advice from Trainer Mr L. Macdonald that the gelding had soreness in the near foreleg.

In the vicinity of the 1200 metres MISS WYNETTE (D. Tourneur) commenced to race keenly for a short distance when awkwardly placed on the heels of CHONDRA (A. Herrmann).

LUSTREMAN (S. Cahill) laid in, in the straight.

J. Holder, the rider of LATIN HERO which laid in, in the straight, explained that the gelding was off the bridle from in the vicinity of the 500 metres, failed to finish its race off and was disappointing. LATIN HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : PERKS CHARTERED ACCOUNTANTS GRAND NATIONAL STEPLECHASE
- 3500 metres (Run on Morphettville Parks Track)

BIG JAM (NZ) (B. Small) jumped the steeple near the 1400 metres on the first occasion awkwardly unbalancing its rider on landing.

KIRRIBILLI GOLD (T. Ryan) jumped the steeple in the vicinity of the 800 metres on the first occasion awkwardly.

After jumping the steeple in the vicinity of the 600 metres on the first occasion, KING TRITON (G. Bedggood) landed awkwardly and shifted in, at the same time as GROENENBOOM (A. Lynch) jumped awkwardly and shifted out, resulting in these two horses making contact and the hind quarters of KING TRITON being turned. As a consequence, REDEVELOP (T. Wells), which was following, had to be steadied and was inconvenienced.

BIG JAM (NZ) (B. Small) was eased out of the event near the 800 metres and did not jump the final four steeple. BIG JAM (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr J. McLean, the trainer of BIG JAM (NZ), was advised that in view of the gelding's performance today, it would be required to trial to the stewards' satisfaction in a steeple trial before next being allowed to start in a steeple event. Mr McLean advised the gelding will now be retired from racing.

RACE 2 : PERKS CHARTERED ACCOUNTANTS GRAND NATIONAL STEPLECHASE
- 3500 metres (Run on Morphettville Parks Track) – (Cont'd)

MALDIVES (M. Kelly) and GROENENBOOM (A. Lynch) were both eased out of the event in the vicinity of the 400 metres and did not jump the final two steeplechases.

GROENENBOOM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MALDIVES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CATS FUN was examined by the Club's Veterinary Surgeon who reported a laceration to this horse's off fore cannon. First aid was administered.

RACE 3 : DALAKHANI HANDICAP - 1511 metres

TOO DISCREET (J. Matthews) was slow to begin.

Inside the 1200 metres MERMAID RUN (K. Brooks) became awkwardly placed on the heels of BRINKLEY BLISS (J. Toeroek) for several strides, and when being restrained shifted in onto RAFFINATO (D. Tourneur), which had to be steadied, losing its position.

In the vicinity of the 200 metres ALBONETTI (J. Kah) shifted out and away from RAFFINATO (D. Tourneur), which shifted out. As a consequence, ALBONETTI tightened REMORSE (T. Pannell) onto TOO DISCREET (J. Matthews), taking both these horses wider on the track.

MERMAID RUN lost its off hind plate during the event.

RAISE A DREAM, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BRINKLEY BLISS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RAFFINATO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : CORNERSTONE STUD HANDICAP - 1200 metres

Trainer R. Balfour was fined \$50 under LR18.1 for the late declaration of a rider for LIGHT IT UP.

ON FACE VALUE (P. Denton) jumped away awkwardly. As a consequence, P. Denton contacted the barrier gate with his left shoulder. P. Denton was examined by the First Care Medical staff after the event who reported no significant findings.

PISTOLIER was examined by the Club's Veterinary Surgeon who reported the horse to be lame in the off foreleg. Mr R. Jolly, the trainer of PISTOLIER, was advised that a veterinary certificate of fitness would be required prior to this horse's next trial or race start.

CLASSY CHLOE was examined by the Club's Veterinary Surgeon who reported the horse to be lame in the near foreleg. Trainer Mr. J. Hickmott was advised that a veterinary certificate of fitness would be required prior to this horse's next trial or race start.

RACE 5 : AMBIDEXTER HANDICAP - 1600 metres

In the vicinity of the 1500 metres CAPODECINA (A. Herrmann) commenced to pull very hard when awkwardly placed on the heels of LONGSHOREMAN (J. Holder) and got its head up when being restrained and was ungenerous for several strides, placing A. Herrmann at a disadvantage. Thereafter, in the vicinity of the 1000 metres, CAPODECINA commenced to over race, was ungenerous for a short distance and brushed the running rail when again awkwardly placed on the heels of LONGSHOREMAN.

Over the concluding stages EVENMOREACTION (K. Bishop) shifted out and tightened LONGSHOREMAN (J. Holder) onto DETOX (D. Tourneur), which was taken out towards the heels of LITTLE AKIE (S. Price), resulting in LONGSHOREMAN and DETOX racing in restricted room for several strides.

LONGSHOREMAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : MORPHETTVILLE EQUINE CLINIC HANDICAP - 1200 metres

STROBES (D. Tourneur) was slow to begin.

In the vicinity of the 600 metres STROBES (D. Tourneur) became held up for clear ground, was obliged to shift out and in doing so took MOLTO VIVACE (L. Stojakovic) wider.

STROBES (D. Tourneur) laid in, in the straight and as a consequence D. Tourneur had to stop riding and straighten his mount near the 200 metres and thereafter in the vicinity of the 100 metres STROBES (D. Tourneur) shifted in and inconvenienced ILOVEWHATSEBRINGS (T. Pannell). D. Tourneur was reminded of his obligations when shifting ground.

RACE 7 : MILL PARK STUD HANDICAP - 2014 metres

Prior to the event J. Holder, the rider of PIT BOSS, advised Stewards that the trainer of the horse, Mr T. McEvoy, had instructed him to settle further back in the field and not take up a forward position as is the horse's normal racing pattern.

LEATHAL'S LEGACY (C. Lindop) and CRUZ'N NOW (T. Baker) were slow to begin.

BAKLAVA BOY (NZ) (R. Hurdle) shifted out at the start, taking SPANISH HALO (NZ) (S. Price) out, at the same time as HOYLAKE (NZ) (D. Tourneur) shifted in at the start, resulting in LEATHAL'S LEGACY (C. Lindop) being unable to maintain its position.

LEATHAL'S LEGACY (C. Lindop) got its head up and raced ungenerously in the early stages of the event.

TIMELYINTERRUPTION (L. Hopwood) and CROSS CONSTANCE (T. Pannell) pulled hard in the early stages.

POWER TO POSSESS (A. Herrmann) raced keenly for a short distance inside the 1700 metres.

Approaching the 200 metres LENNYBE (J. Kah) shifted out and inconvenienced PIT BOSS (J. Holder). J. Kah was reminded of her obligations when shifting ground.

J. Toeroek, the rider of MR LOWNDES (NZ), was reminded of his obligations when riding his horses out to the finish.

RACE 7 : MILL PARK STUD HANDICAP - 2014 metres (Cont'd)

PIT BOSS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ASSERTIVE BILLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HOYLAKE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : MAGIC MILLIONS HANDICAP - 1200 metres

C. Forrest, the rider of PTOLEMY, was granted permission to claim only 2 kilograms of her 3 kilogram allowance.

J. Toeroek the rider of IMPERIAL LINES, who was dislodged from his mount on leaving the mounting yard, was examined by the First Care Medical staff on arrival at the barriers and declared fit to ride.

PORTICI (R. Hurdle) jumped away awkwardly.

A SAUCY SNITZEL (J. Holder) jumped away awkwardly, shifted out and when being corrected shifted in and tightened ASTRO DAMUS (A. Herrmann), which was obliged to be steadied losing its position. J Holder was reminded of his obligations when his mounts commence to shift ground.

ZAYAK (L. Hopwood) and ASTRO DAMUS (A. Herrmann) over raced in the early stages.

Inside the 600 metres RUSSIAN ROCKER (GB) (D. Tourneur) became held up when racing behind BUSINESS DECISION (R. Stewart) and shifted out to improve and contacted A SAUCY SNITZEL (J. Holder) for a short distance and shortly thereafter at the entrance to the straight RUSSIAN ROCKER (GB) again shifted out, taking A SAUCY SNITZEL (J. Holder) out onto ASH ROAD (J. Matthews), which was taken out onto the heels of WYARA MISS (J. Potter), resulting in ASH ROAD having to be steadied, losing its position. D. Tourneur was reprimanded for shifting ground when insufficiently clear and advised to take greater care in future.

ASTRO DAMUS (A. Herrmann) was inclined to lay out in the straight.

In the vicinity of the 200 metres PTOLEMY (C. Forrest) was obliged to steady and alter course to the outside of A SAUCY SNITZEL (J. Holder) as that horse rolled in.

Approaching the 200 metres RUSSIAN ROCKER (GB) shifted out and crossed the running of A SAUCY SNITZEL (J. Holder), which was obliged to alter course to that horse's inside. D. Tourneur was reprimanded for shifting ground when insufficiently clear. Thereafter, approaching the 100 metres, A SAUCY SNITZEL shifted to the outside of IMPERIAL LINES (J. Toeroek), taking PTOLEMY (C. Forrest) out. When being corrected, A SAUCY SNITZEL became awkward on the heels of IMPERIAL LINES, which rolled out.

S. Price, the rider of KING KEV, was reminded of his obligations when riding his horses out to the finish.

J. Holder, the rider of A SAUCY SNITZEL, explained that his mount was off the bridle from near the 600 metres, failed to finish the race off and was disappointing. A SAUCY SNITZEL was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near hind leg. Mr P. Moody, the trainer of the mare, was advised that a veterinary certificate of fitness would be required prior to this horse's next trial or race start.

RACE 8 : MAGIC MILLIONS HANDICAP - 1200 metres (Cont'd)

D. Tourneur, the rider of RUSSIAN ROCKER (GB), was fined \$200 under AR91 for leaving the course without seeking the permission of the stewards after this event.

GENERAL:

17 riders were breathalysed prior to taking their first ride of the day - all returned negative.
