RACE 1 : KINGSFORD HOTEL / SABOIS DISTANCE MAIDEN PLATE – 2122 metres

JUNIOR (Z. Spain) jumped away awkwardly.

In the vicinity of the 500 metres MORETHANYOUTHINK (A. Herrmann) rolled in and brushed with DELAWAY BROM (D. Dunn), which became unbalanced and brushed the running rail.

From in the vicinity of the 500 metres until the entrance to the straight DELAWAY BROM (D. Dunn) was held up when racing behind FINAL TWIST (J. Potter) and inside MORETHANYOUTHINK (A. Herrmann) and brushed MORETHANYOUTHINK on two occasions.

RACE 2 : SUNSET & SADDLES MAIDEN PLATE - 1511 metres

CLARIFY (A. Herrmann) was slow to begin.

In the vicinity of the 1300 metres the saddle on CONQUER THE MOMENT (Z. Spain) shifted forward, placing Z. Spain at a disadvantage for the remainder of the event.

DEAR DARLIN' (C. Lindop), WANA DECISION (R. Stewart) and CHAMPAGNE KRIS (T. Pannell) raced keenly in the early and middle stages of the event.

In the vicinity of the 800 metres RIGHT AND READY (J. Frew) rolled in and brushed CONQUER THE MOMENT (Z. Spain).

Approaching the finish WANA DECISION (R. Stewart) rolled in under pressure.

L. Hopwood, the rider of FIGURE THIS, was reminded of her obligations in relation to riding her mounts out to the finish.

RACE 3 : COOPERS BREWERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE

- 1111 metres

DEHERE'S MOMENT proved difficult to load. Ms S. Barr, the Trainer of DEHERE'S MOMENT, was advised a warning had been placed on the filly in relation to its barrier manners.

NORDIC ECLIPSE (M. Vance) jumped away awkwardly.

Shortly after the start NORDIC ECLIPSE (M. Vance) attempted to buck for a short distance.

FORTISSIO (J. Frew) jumped away awkwardly and in the early and middle stages could not maintain contact with the field.

On jumping away TRUE EXCEPTION (E. Finnegan) shifted in at the same time as DEHERE'S MOMENT (S. Carr) shifted out, resulting in HURRY HOME HUGO (A. Herrmann) becoming tightened and losing its position.

THE RED LADY (R. Stewart) raced ungenerously in the early and middle stages of the event.

PARUNA MISS (L. Hopwood) raced keenly for a short distance in the vicinity of the 1000 metres.

In the vicinity of the 900 metres TRUE EXCEPTION (E. Finnegan) shifted in when insufficiently clear of THE RED LADY (R. Stewart), which had to be checked to avoid that filly's heels. E. Finnegan pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 23 August and to conclude at midnight on Saturday, 30 August 2014: a period of three (3) meetings.

From the vicinity of the 800 to the 600 metres JIM'S JOURNEY (S. Cahill) was inclined to lay in under pressure.

Rounding the home turn JIM'S JOURNEY (S. Cahill) was inclined to hang out.

HURRY HOME HUGO (A. Herrmann) was inclined to lay in under pressure in the straight. HURRY HOME HUGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : ANGAS PARK HOTEL / SABOIS MAIDEN PLATE (1) - 1111 metres

As Stewards were able to identify GOD'S AURA from records held by them when the Thoroughbred Identification Card was not available as required, the gelding was permitted to start. Mr J. O' Connor, the Trainer of GOD'S AURA, pleaded guilty to a charge under AR59A and was fined \$50.

SHAVANO'S IMAGE proved difficult to load. Mr D. Jolly, the Trainer of SHAVANO'S IMAGE, was advised a warning had been placed on the mare in relation to its barrier manners.

CHOSEN FRIEND (J. Frew) was slow to begin.

On jumping away SHOP FRAAR'N WIDE (L. Hopwood) shifted in and brushed with SEYAADAH (T. Zanker).

Rounding the home turn SHAVANO'S IMAGE (J. Holder) was inclined to hang out.

RACE 5 : PD EXCAVATIONS / SABOIS MAIDEN PLATE (2) - 1111 metres

On arrival on course ELLE DEEZ GOLD which had not raced since February 2013 was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

The start of this event was delayed approximately six minutes owing to ELLE DEEZ GOLD losing its near fore plate en route to the barrier. As the on course Farrier was unable to re-plate the mare and Stewards received permission from Ms Y. Forrest, the Trainer of ELLE DEEZ GOLD, the mare was permitted to race barefoot in front.

Shortly after the start SILVER ILLUSION (A. Herrmann) shifted out and bumped with HASTA LA GORBY (J. Kah), which was taken out onto the heels of JETMAKER (C. Lindop) and was obliged to be steadied.

Shortly after the start STAR PEDRILLE (L. Hopwood) became awkward on the heels of ELLE DEEZ GOLD (C. Forrest) for a short distance.

In the vicinity of the 700 metres ZANONI (K. Brooks) which was inclined to race keenly and became awkwardly placed inside STAR PEDRILLE (L. Hopwood), was obliged to be restrained and shifted out, contacting HASTA LA GORBY (J. Kah), which was taken wider on the track.

Over the final 100 metres FINNTUITION (K. Bishop) shifted in under pressure, inconveniencing JETMAKER (C. Lindop).

RACE 6 : SPORTSBET.COM.AU FIXED ODDS CLASS 2 HANDICAP - 2122 metres

The start of this event was delayed approximately two minutes owing to ETERNAL HEART getting its leg up in the gates. ETERNAL HEART was examined by the Club's Veterinary Surgeon who ruled the mare fit to race. Mr G. Searle, the Trainer of ETERNAL HEART, was advised a warning had been placed on the mare in relation to it being fractious in the barriers.

OUTRAGEOUS MAN (A. Herrmann) was slow to begin.

GO DREAMING (J. Potter) was inclined to race keenly in the early stages of the event.

In the vicinity of the 1500 metres FRANKENFURTER (GB) (K. Bishop) rolled in and inconvenienced GO DREAMING (J. Potter), which continued to race keenly.

In the vicinity of the 800 metres SMOKE BURNER (D. Dunn) and RUBY BE THERE (L. Hopwood) came together and brushed on a number of occasions.

In the vicinity of the 600 metres RUBY BE THERE (L. Hopwood) in an attempt to improve, shifted out and brushed with SMOKE BURNER (D. Dunn) on a number of occasions.

Rounding the home turn FRANKENFURTER (GB) (K. Bishop) shifted out and brushed with GO DREAMING (J. Potter).

Rounding the home turn ETERNAL HEART (A. Patterson) shifted out and inconvenienced SMOKE BURNER (D. Dunn) and RUBY BE THERE (L. Hopwood) which were taken wider on the track.

In the vicinity of the 350 metres ETERNAL HEART (A. Patterson) shifted in under pressure onto the heels of GO DREAMING (J. Potter), which was inclined to shift out under pressure, resulting in ETERNAL HEART been taken out and losing its position when tightened onto RUBY BE THERE (L. Hopwood).

RACE 7 : NATIONAL JOCKEYS TRUST RATING 0-62 HANDICAP – 1511 metres

In the early stages MINERS KEEPERS (W.Kerford) raced ungenerously and was inclined to get its head up.

MOLASMO JET (C. Forrest) raced fiercely in the early and middle stages.

In the vicinity of the 400 metres MISS FEARLESS (B. Claridge) shifted out at the same time as BELLE OF THE SOUTH (J. Potter) rolled in, resulting in EXALTED GEM (K. Bishop) becoming tightened and losing its position. B. Claridge was reprimanded and advised in future to stop riding and straighten his mounts when they commence to shift ground.

Correct Weight in this event was delayed to allow Stewards to view the official footage in the vicinity of the 400 metres.

RACE 8 : JARVIS ISUZU MARES RATING 0-68 HANDICAP – 1211 metres

Prior to entering the mounting yard LEAHONE, which had blood in its mouth, was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

The start of this event was delayed approximately four minutes owing to BOUNCING BEVERLEY refusing to load. BOUNCING BEVERLEY was withdrawn by Stewards at 4.09 pm. Mr D. O'Leary, the Trainer of BOUNCING BEVERLEY was advised that the mare would be required to perform to Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

On jumping away SOMBRE (K. Bishop) shifted in taking SHADE OF GREEN (C. Jokic) in onto BELLA MUCHACHA (L. Hopwood).

BYTHESTARS (R. Mageean) jumped away awkwardly and as a result was slow to begin.

Z. Spain, the rider of GENTLE MELODY, reported that the mare was inclined to lay in in the straight.

BYTHESTARS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9 : JACOBS CREEK RATING 0-62 HANDICAP – 1111 metres

CALIANCO (J. Toeroek) shifted in on jumping away and made contact with KOODA DAWN (K. Bishop).

In the vicinity of the 700 metres REWIND TIME (J. Matthews) dipped for no apparent reason.

In the vicinity of the 200 metres COMBAT DANCER (J. Holder) shifted in and brushed with ROCK OUT (S. Cahill).

ROCK OUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL

RACE 3 : COOPERS BREWERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE **- 1111 metres**

Mr. A. Beswick, the Trainer of SIRIUS SASS, advised Stewards on Thursday, 21 August 2014, on return to his stables, the filly was lame in the near foreleg. Mr. Beswick was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.
