**RACE 1 : AUGUSTA AUTOMALL / SABOIS MAIDEN PLATE - 1100 metres**

On jumping away REGROUP (C. Jokic) shifted in and brushed with MUSICAL MISS (S. Carr).

Shortly after the start DON'T CALL ME MISS (A. Patterson) shifted out and brushed with BEESRULETHEWORLD (K. Brooks). As a result, the hindquarters of DON'T CALL ME MISS were turned.

Approaching the winning post MADAME ZARA (D. Dunn) shifted in under pressure onto ABBANABBI ABBANEW (T. Baker), which was hampered when tightened onto DON'T CALL ME MISS (A. Patterson).

REGROUP (C. Jokic) failed to maintain contact with the field in the middle stages. Ms K. McKerlie representing the filly's Trainer, Mr J B O'Connor, was advised a warning been placed on the filly in relation to its performance.

R. Bell, the rider of FERRO MORN, reported that the mare was inclined to hang out throughout the event. FERRO MORN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DON'T CALL ME MISS was examined by the Club's Veterinary Surgeon who reported excess upper respiratory noise. Mr G. Searle, the Trainer of DON'T CALL ME MISS was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

**RACE 2 : IAN'S CHICKEN HUT RATING 0-68 HANDICAP - 1867 metres**

S. Carr was questioned in relation to her being unable to claim down to her minimum riding weight on BLAKELEY. As there was no other available apprentice on course to ride at her minimum riding weight, S. Carr was permitted to ride. S. Carr pleaded guilty to a charge under AR120(b) and was fined \$200.

On arrival at the barriers MOTACADE was re-saddled.

BLAKELEY (S. Carr) and MOUNTAIN CLIMBER (A. Doyle) were slow to begin.

**RACE 2 : IAN'S CHICKEN HUT RATING 0-68 HANDICAP - 1867 metres (Cont'd)**

In the vicinity of the 1000 metres ALLY THE GREAT (C. Jokic) shifted out taking LADY LUSH (T. Baker) wider on the track.

T. Baker requested to be examined by the First Care Medical Personnel prior to taking his next ride. T. Baker was cleared fit to ride.

**RACE 3 : MOTEL POINSETTIA BENCHMARK 72 HANDICAP - 1100 metres**

No report.

**RACE 4 : COMFORT INN AUGUSTA WESTSIDE MOTEL / SABOIS MAIDEN PLATE - 1396 metres**

Acting on confirmed advice from Mr. S. Burford, the Trainer of HILL TOP HOOLIGAN, that the gelding had injured it's near foreleg and was unfit to race, Stewards withdrew the gelding at 8.33 am.

CUTS BOTH WAYS (E. Boyd) and EPONA REBEL (R. Bell) came together and brushed at the same time as THE BABY SITTER (L. Stojakovic) shifted in and inconvenienced EPONA REBEL.

TRACY TRUE BLOOD (Z. Spain) was inclined to rear on jumping away.

From inside the 600 metres CUTS BOTH WAYS (E. Boyd) was inclined to hang out.

Inside the 500 metres EPONA REBEL (R. Bell) was hampered and obliged to shift out to the outside of CUTS BOTH WAYS (E. Boyd) to obtain clear running.

From in the vicinity of the 400 metres HEARD (S. Carr) was eased out of the event. HEARD was examined by the Club's Veterinary Surgeon who reported the mare had suffered a bi-lateral bleeding attack. Mr R. Atkinson, the Trainer of HEARD, was advised that as this was the mare's second bleeding attack, HEARD was banned for life from racing in accordance with AR53A(5).

Inside the 200 metres TRACY TRUE BLOOD (Z. Spain) shifted in abruptly under pressure resulting in that rider having to stop riding and straighten his mount.

E. Boyd, the rider of CUTS BOTH WAYS, reported that the gelding had become awkward in its action in the middle stages of the event. CUTS BOTH WAYS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : WESTSIDE VEGIE PATCH RATING 0-68 HANDICAP – 1396 metres**

Acting on confirmed advice from Mr S. Whittle, representing Mr M. Whittle, the Trainer of MONEYBALL, that the gelding had refused to be loaded on the truck, Stewards withdrew MONEYBALL at 7.32 am.

ARTHURIAN LEGEND (C. Jokic) jumped away awkwardly.

**RACE 6 : WESTSIDE NEWSAGENCY RATING 0-58 HANDICAP - 1600 metres**

On arrival on course SO MANY PENNIES which had not raced since June 2013 was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

SALARY CAP (K. Brooks) jumped away awkwardly.

**RACE 6 : WESTSIDE NEWSAGENCY RATING 0-58 HANDICAP - 1600 metres**

On jumping away PELL MELL (T' O Donnell) and MUGMARINO (T. Baker) came together and brushed.

In the vicinity of the 100 metres TIGER JET (W. Kerford) shifted in onto SAREM (L. Stojakovic), which was inconvenienced when tightened onto SERENA (E. Boyd).

K. Brooks, the rider of SALARY CAP, reported that she was concerned with the gelding's action in the straight. SALARY CAP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

A. Doyle, the rider of TEAM LAGO, reported that the gelding had raced erratically throughout the event.

**RACE 7 : CENTRAL AUGUSTA FOOTBALL & COMMUNITY CLUB RATING 0-58 HANDICAP - 1200 metres**

On arrival at the barriers, the winkers on RETAIN BELIEF required adjusting.

The start of this event was delayed approximately two minutes.

HE'LL TELL US (R. Bell) jumped away awkwardly and shifted out at the same time as BRAUNY HUNTER (D. Dunn) shifted in, resulting in ALAKAZOO (T. O' Donnell) becoming tightened.

Inside the 1000 metres WICKED TYCOON (E. Boyd) shifted in resulting in METRO CAT (A. Doyle) having to be momentarily eased. E. Boyd was reminded of her obligations to only shift ground when entitled to do so.

WICKED TYCOON (E. Boyd) hung out rounding the home turn.

Over the final 100 metres CARDINAL MISSION (T. Pannell) and BRAUNY HUNTER (D. Dunn) shifted out under pressure.

R. Bell, the rider of HE'LL TELL US, reported the gelding had begun awkwardly, had never travelled and finished the event off poorly. HE'LL TELL US was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**GENERAL**

Stewards conducted a search of the Jockeys' Rooms for mobile devices. Seven mobile phones were confiscated. All seven riders pleaded guilty to a charge under AR160B(3) in that they each had in their possession, in the Jockeys' Room, a mobile phone. After taking into account various circumstances, the riders were fined as follows:

- R. Bell - \$500;
- C. Jokic - \$400;
- K. Brooks - \$400;
- T. Zanker - \$200;
- A. Doyle - \$200;
- T. O' Donnell - \$200;
- E. Boyd - \$200.

Stewards were able to determine that no race day information had been transmitted or received on the mobile devices.

**JOCKEY TESTING:**

All seventeen (17) riders were breathalysed prior to taking their first ride of the day – all returned negative.
