RACE 1: ADELAIDE GALVANISING HANDICAP - 1250 metres

ALCHEMY'S EIGHT (J. Frew) was slow into stride.

In the vicinity of the 1000 metres DEFIANT ANGEL (D. Dunn) shifted in and tightened IMPERIAL LINES (J. Maund) for a short distance, resulting in IMPERIAL LINES having to be steadied. As a consequence ON FACE VALUE (J. Holder), which was following, got its head up and raced ungenerously when awkwardly placed on the heels of IMPERIAL LINES. D. Dunn was severely reprimanded and advised in future to take greater care when shifting ground.

RACE 2: SPORTINGBET HANDICAP - 1550 metres

TWILIGHT DANCER (A. Herrmann) was slow to begin.

TYCOON QUEEN (J. Maund) was held up for clear running for a short distance in the vicinity of the 400 metres.

PAMUKKALE (NZ) and RAFFINATO were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: ALLAN HORN MEMORIAL HANDICAP - 1250 metres

REWIND TIME (J. Matthews) jumped away awkwardly and shifted out, contacting KING KEV (T. Baker), which was hampered when tightened onto LIGHTNING DREW (J. Frew), which was inconvenienced.

IRISH CHEER (C. Lindop) was slow to begin.

KING KEV (T. Baker) raced greenly throughout the event and in the vicinity of the 700 metres laid in onto the hindquarters of NIGHT BREEZE (L. Hopwood), turning that gelding out, resulting in KING KEV being inconvenienced for a number of strides.

RACE 3: ALLAN HORN MEMORIAL HANDICAP - 1250 metres (Cont'd)

SHAVANO'S IMAGE (J. Holder) hung out rounding the home turn and in the vicinity of the 100 metres shifted in abruptly, inconveniencing IRON FOCUS (J. Toeroek).

J. Holder, the rider of SHAVANO'S IMAGE, reported the mare had raced greenly throughout the event and over the concluding 200 metres was inclined to shift about and he had become concerned with its action and for that reason did not ride SHAVANO'S IMAGE out in his normal manner. SHAVANO'S IMAGE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KING KEV was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : GOLD STAR RV HANDICAP - 1400 metres

Shortly after the start NIMASAEL (L. Hopwood) and UNSPUN (A. Patterson) contacted for several strides when both horses shifted ground.

Inside the 1000 metres WISE JOURNEY (S. Carr) rolled out and away from NOT A ZERPRISE (S. Price), which rolled out slightly, and tightened NIMASAEL (L. Hopwood) onto JUST A CHAT (J. Kah), which was taken wider. As a result NIMASAEL had to be steadied off the heels of ROWDY ROCKER (J. Toeroek) for several strides as it continued to roll out.

SUPER SILKS (NZ) (J. Matthews) was held up for clear ground from in the vicinity of the 600 metres until the 300 metres.

ROWDY BELLE (C. Lindop) was held up from in the vicinity of the 500 metres to the entrance to the straight.

In the vicinity of the 300 metres WRITE NO MORE (J. Holder) shifted out to improve, resulting in NOT A ZERPRISE (S. Price) shifting out and away from that mare onto the hindquarters of PORTICI (T. Pannell), turning that gelding's hindquarters slightly, resulting in PORTICI laying back in onto NOT A ZERPRISE. Shortly thereafter WRITE NO MORE continued to improve, shifted out and tightened NOT A ZERPRISE, resulting in NOT A ZERPRISE having to be steadied to avoid the heels of WRITE NO MORE. J. Holder was severely reprimanded and advised in future to take greater care when shifting ground.

WISE JOURNEY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. B. Mueller, the Trainer of WISE JOURNEY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

ROWDY BELLE and NIMASAEL were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: HINDMARSH PLUMBING HANDICAP - 1400 metres

CORVIDAE (B. Claridge) shifted out shortly after the start and tightened WHITE ROE (C. Lindop) onto RING ME NOT (E. Boyd).

ALMIGHTY BULLET (S. Carr) was held up for clear running from the 600 metres to the 300 metres.

J. Kah, the rider of SANDHILL WARRIOR, reported the gelding hung out during the event. SANDHILL WARRIOR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WHITE ROE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: PETER ELBERG FUNERALS HANDICAP - 1250 metres

The start of this race was delayed approximately two minutes owing to TIGER RUBY and SOLID BULLET proving fractious after being loaded into their barrier stalls. SOLID BULLET was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

SOVEREIGN DUKE (J. Holder) jumped away awkwardly, shifted out and contacted BEAU'S MY BOY (T. Pannell).

SOLID BULLET (S. Carr) and WHAT'S THE CRAIC (J. Potter) contacted on jumping away and shortly thereafter FRANK HEAVENS (C. Lindop) shifted in and contacted SOLID BULLET at the same time as SALADIN (B. Higgins) shifted out and contacted WHAT'S THE CRAIC, resulting in these four horses brushing for a number of strides.

Inside the 1000 metres FRANK HEAVENS (C. Lindop) commenced to over-race, shifted out and became awkward on the heels of LOQUETEUX (J. Toeroek) for a number of strides and then continued to over-race for some distance thereafter and became very awkward and was obliged to shift out wider to avoid the heels of runners.

S. Carr, the rider of SOLID BULLET, pleaded guilty to a charge under AR145 for weighing in at more than half a kilogram over the weight at which she weighed out and was fined \$200.

SOVEREIGN DUKE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TIGER RUBY was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. S. Gower, the Trainer of TIGER RUBY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

S. Carr, the rider of SOLID BULLET, reported the filly never travelled in the event. SOLID BULLET was again examined by the Club's Veterinary Surgeon who reported low grade tying up in the hindquarters. Mr. J. Hyam, the Trainer of SOLID BULLET, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

WHAT'S THE CRAIC was examined by the Club's Veterinary Surgeon who reported cardiac arrhythmia and atrial fibrillation. Mr. S. Oxlade, the Trainer of WHAT'S THE CRAIC, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the colt performing satisfactorily in an Official Barrier Trial.

RACE 7: JAMES BOAG'S PREMIUM HANDICAP - 1950 metres

MR LOWNDES (NZ) (J. Toeroek) was slow to begin.

CRUZ'N NOW (J. Frew) was slow to begin losing one to two lengths.

KEEPAKIWI (NZ) (C. Lindop) raced wide throughout the event.

CLARIFY (T. Pannell) was held up for clear running from in the vicinity of the 600 metres until near the 300 metres.

GRAND GROUP (J. Kah) was held up for clear running from the vicinity of the 400 metres to the entrance to the straight.

BELLE OF THE SOUTH (J. Potter) was inclined to lay out in the straight.

RACE 7: JAMES BOAG'S PREMIUM HANDICAP - 1950 metres (Cont'd)

B. Higgins, the rider of DIFFERENT DRUMMER (NZ), explained the gelding was disappointing and in his opinion may not have backed up from its previous starts. DIFFERENT DRUMMER (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: SCHWEPPES HANDICAP - 1000 metres

EXALTED WILLIAM, which was fractious in the barriers prior to the start being effected, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

BLUE MAGNATE (A. Herrmann) jumped away awkwardly and shifted out onto BOLD SENATOR (M. Vance), which was inconvenienced. Shortly thereafter BLUE MAGNATE and FORCE OF THREE (T. Baker) came together as FORCE OF THREE shifted in, resulting in BLUE MAGNATE laying out onto FORCE OF THREE taking that gelding out onto FLYIN' FOR ME (C. Lindop), which was taken out onto the heels of DEBEERSONUS (R. Hurdle), which was inclined to lay in, resulting in FLYIN' FOR ME having to be checked to avoid the heels of DEBEERSONUS. As a consequence CALIANCO (J. Kah), which was following to the outside of FLYIN' FOR ME, was inconvenienced.

In the vicinity of the 500 metres GET PRONTO (K. Bishop) brushed the running rail.

Approaching the 200 metres MASTER BLACK (J. Toeroek) rolled in and contacted SPIRIT OF FLATLEY (R. Stewart).

GET PRONTO (K. Bishop) was held up for clear ground from the entrance to the straight until approaching the 100 metres and thereafter, over the concluding stages, was unable to improve due the positioning of runners.

NITE ROCKER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities other than a slightly lower than expected heart rate.

EXALTED WILLIAM was again examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
