RACE 1 : MALLEE DIPPING & MULESING/RIVERLAND FLOOR CENTRE/SABOIS
CG&E MAIDEN PLATE - 1000 metres

On arrival at the barriers NORDIC ECLIPSE was required to be re-saddled.

YOULLNEVAWALKALONE (J. Kah) jumped away awkwardly and shifted out onto AKKACAN (K. Bishop).

ALCOBRO (J. Toeroek) was inclined to race keenly in the early and middle stages of the event.

AKKACAN (K. Bishop) was inclined to lay in under pressure in the straight.

ATOMIC HERO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : KELVIN WESTBROOK TRANSPORT/LOXTON IRRIGATION/SABOIS F&M
MAIDEN PLATE - 1000 metres

ELLE DEEZ GOLD (C. Forrest) jumped away awkwardly and shifted out onto THE LONE RANGA (E. Boyd), at the same time as LOTSALOVE (C. Lindop) jumped away awkwardly and shifted in onto SEPTEMBER STORM (L. Hopwood). As a consequence THE LONE RANGA and SEPTEMBER STORM both lost their positions.

In the vicinity of the 900 metres SEPTEMBER STORM (L. Hopwood) was obliged to be eased when LOTSALOVE (C. Lindop) shifted in marginally. C. Lindop was severely reprimanded and advised to take greater care in future.

In the vicinity of the 800 metres THE LONE RANGA (E. Boyd) improved onto the heels of LISA'S GEM (T. O'Donnell) and had to be steadied momentarily.

ELLE DEEZ GOLD (C. Forrest) made the home turn awkwardly and as a result SEPTEMBER STORM (L. Hopwood) was taken wider on the track. As a consequence LOTSALOVE (C. Lindop), which was weakening, was obliged to be eased momentarily.

**RACE 2 : KELVIN WESTBROOK TRANSPORT/LOXTON IRRIGATION/SABOIS F&M
MAIDEN PLATE - 1000 metres**

Correct Weight for this event was delayed to allow D. Tourneur, the rider of the fourth placegetter, PERPETUAL BLISS and Mr J. MacMillan, the Trainer of the third placegetter THE LONE RANGA, to view the official photo for second.

RACE 3 : NORM HUMPHRYS MEMORIAL / SABOIS MAIDEN PLATE - 1380 metres

On arrival on course GOOD CALL BAD CALL, which had not raced since January 2013, was examined by the Club's Veterinary Surgeon and ruled fit to race.

HAPPY LANE (J. Frew) was held up for clear running from in the vicinity of the 600 metres until approaching the 400 metres when racing behind LITTLE AUDREY (T. O'Donnell).

B. Hoppo, the rider of ADMIRALS EIGHTH, reported his mount was inclined to race greenly throughout.

RACE 4 : FLEA & DOUG FULLSTON MEMORIAL RATING 0-58 HANDICAP – 1380 metres

On arrival at the barriers BYTHESTARS, which contacted a perimeter fence in the mounting yard was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

MILD MANNERED (A. Patterson) was inclined to over-race during the early and middle stages of the event.

In the vicinity of the 600 metres SMART JESTER (D. Dunn) improved onto the heels of TIZZY LIZZY (T. O' Donnell) and in doing so shifted out and inconvenienced KALO TAXITHI (J. Potter). D. Dunn was reprimanded and advised to take greater care when shifting ground in future.

L. Hopwood, the rider of GRIGIO NOW, reported her saddle shifted during the event.

WHERE'S THAT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr R. Mirelli, the Stable Foreman for Mr K. Sweeney, the Trainer of WHERE'S THAT was advised a Veterinary Certificate of Fitness would be required prior to a trial or race.

Correct Weight for this event was delayed to allow T. Baker, the rider of second placegetter DUBAI SUNRISE, and Mr G. Kluske the mare's Trainer, to view the official footage in the vicinity of the 1000 metres and the official photo for first.

Following this event J. Frew was examined by the First Care Medical Personnel who ruled him unfit to fulfil his remaining engagement. J Frew was advised a Medical Certificate is required prior to riding again.

**RACE 5 : ZADOW WELL DRILLING/LANDMARK GREENFIELD KAROONDA RATING
0-62 HANDICAP - 1000 metres**

SHE'S ON FIRE (K. Bishop) jumped away awkwardly.

In the vicinity of the 700 metres CHARLIE'S PRINCESS (L. Stojakovic) was obliged to be steadied when tightened for room by SHE'S ON FIRE (K. Bishop), which was taken in by DON ROBERTO (J. Maund), which was inclined to lay in slightly, before being straightened by its rider. J, Maund was reprimanded and advised to take greater care when shifting ground in future. Shortly after SHE'S ON FIRE shifted out slightly taking ETHBAAL (D. Dunn) out onto CON NOW (L. Hopwood) as MAGNUM PE I (T. Baker) improved to its outside. As a result CON NOW was obliged to be steadied off the heels of MAGNUM PE I.

**RACE 5 : ZADOW WELL DRILLING/LANDMARK GREENFIELD KAROONDA RATING
0-62 HANDICAP - 1000 metres (Cont'd)**

CHARLIE'S PRINCESS (L. Stojakovic) was held up from approaching the 200 metres until inside the 100 metres when racing between SHE'S ON FIRE (K. Bishop) and DON ROBERTO (J. Maund).

Inside the 100 metres SHE'S ON FIRE (K. Bishop) rolled out marginally onto WARRASIDE (A. Patterson) taking that gelding out onto MAGNUM PE I (T. Baker), which was obliged to ease momentarily as OUR BELVOIR (C. Lindop) rolled in marginally. As a result MAGNUM PE I was unable to obtain clear running for the remainder of the event. MAGNUM PE I was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : COLLINS INDUSTRIAL MINDARIE-HALIDON CUP - 1800 metres

IRISH HIGH KING (D. Tourneur) jumped away awkwardly and shifted in onto FINNISS MOMENT (R. Mageean).

**RACE 7 : RADIO 801-5RM / RADIO 5MU & POWER FM RATING 0-62 HANDICAP -
1800 metres**

KISS MY ARAZI (J. Kah) was slow to begin.

In the vicinity of the 500 metres JUNIOR (S. Cahill) was inclined to lay in onto the heels of STEP DANCE (J. Maund) resulting in JUNIOR having to be steadied to avoid the heels of STEP DANCE.

BELLCHUCA (D. Tourneur) was inclined to lay in under pressure in the straight.

JUNIOR, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STEP DANCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : RADIO 801-5RM / RADIO 5MU & POWER FM RATING 0-62 HANDICAP -
1800 metres**

Mr J. Hickmott pleaded guilty to a charge under AR140A(1) in that he failed to present RICH PRIDE to race in a Norton Bit which was its declared gear and was fined \$50.
