RACE 1 : GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE – 1700 metres

The start of this race was delayed approximately two minutes owing to QUEEN KYLIE, which struck a perimeter fence in the mounting yard, being examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

LITTLE AUDREY (Z. Spain) jumped away awkwardly and as a result was slow into stride.

HAPPY LANE (J. Frew) raced ungenerously in the early and middle stages of the event.

RACE 2 : GUY SEBASTIAN @ MORPHETTVILLE 4/11 SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 metres

JUST ONE WISH (B. Claridge) jumped away awkwardly.

MIGHTY MAHER (A. Patterson) raced greenly throughout the event.

MIGHTY MAHER (A. Patterson) laid in under pressure in the straight. MIGHTY MAHER was examined by the Club's Veterinary Surgeon who reported the filly to be shin sore in the off foreleg.

RACE 3 : JACOBS CREEK HANDICAP - 1100 metres

EL PRADO GOLD (A. Patterson) was slow to begin.

Approaching the finish SPLASH OF MOET (J. Holder) had to momentarily steady when tightened between BARIGAN BOY (J. Kah), which rolled out under pressure and EL PRADO GOLD (A. Patterson), which rolled in under pressure.

RACE 4 : JOHN MILLS GBJC VOLUNTEER OF THE YEAR / SABOIS 4UP MAIDEN PLATE
- 1200 metres

CELESTIAL ME (K. Cross) was slow to begin.

HARRY'S HOT (T. Pannell) jumped away awkwardly and shifted out inconveniencing ARTFUL DIVA (R. Hurdle).

Shortly after the start ZANONI (A. Patterson) shifted out taking HARRY'S HOT (T. Pannell) out, at the same time as ROCMARR (D. Tourneur) shifted in, resulting in ARTFUL DIVA (R. Hurdle) having to be steadied, clipping the heels of HARRY'S HOT.

In the vicinity of the 800 metre ATOMIC HERO (S. Cahill) had to check and lose its position when SOU SOUNI PRINCESS (J. Kah) shifted in. As a result CELESTIAL ME (K. Cross), which was racing behind SOU SOUNI PRINCESS, was inconvenienced when that mare raced up on heels. READY AGAIN (M. Neilson), which was racing to the outside of CELESTIAL ME, was inconvenienced when that mare was taken wider. J. Kah, the rider of SOU SOUNI PRINCESS pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 5 October, and to conclude at midnight on Sunday, 12 October 2014 : a period of four(4) meetings.

Approaching the 400 metres ROCMARR (D. Tourneur) rolled in marginally bumping READY AGAIN (M. Neilson), which had its hindquarters turned out.

RACE 5 : JARVIS ISUZU / SABOIS PLUS RATING 0-92 HANDICAP - 2100 metres

CROSS CONSTANCE was examined by the Club's Veterinary Surgeon who reported the gelding to be exhibiting signs of heat stress. First Aid was administered.

RACE 6 : COOPERS BREWERY FOUR-YEARS-OLD & OVER CLASS TWO HANDICAP - 1500 metres

In the vicinity of the 400 metres FOUR STAR GENERAL (L. Hopwood) had to be steadied when IRON FOCUS (T. Pannell) rolled out to improve around the heels of TOKEN ONE (A. Herrmann) at the same time as MOON BRICKS (T. Baker) rolled in and away from TIZZY LIZZY (Z. Spain), which brushed with KOOMA BLAZE (B. Claridge), which was improving to its outside. T. Pannell was reminded of his obligations when shifting ground in future.

MOON BRICKS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : PD EXCAVATIONS GAWLER CUP – 1500 metres

ALMIGHTY BULLET (J. Holder) was slow to begin.

Approaching the 200 metres GOLDBY (A. Patterson) was momentarily held up for a short distance when awkwardly placed between the heels of MISS WYNETTE (R. Stewart) and EXCITES ZELADY (A. Herrmann).

Correct Weight for this event was delayed to allow A. Herrmann, the rider of the fourth placegetter EXCITES ZELADY, to view the official photo finish.

A Herrmann, the rider of EXCITES ZELADY was questioned regarding the use of her whip prior to the 100 metres. She pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200.

RACE 7 : PD EXCAVATIONS GAWLER CUP – 1500 metres (Cont'd)

T. Baker, the rider of EBONY ROCK, reported that in his opinion, the gelding did not feel comfortable in its action during the event. EBONY ROCK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DEFIANT ANGEL was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr P. Stokes, the trainer of DEFIANT ANGEL was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 8 : SPORTSBET.COM.AU FIXED ODDS FOUR-YEARS-OLD & OVER RATING 0-68 HANDICAP – 1200 metres

On arrival at the barriers, LEADER'S SAGA was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg and unfit to race. Acting on that advice Stewards withdrew LEADER'S SAGA at 4.50 pm. Mr K. Buick, the Trainer of LEADERS SAGA was informed a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

MISTLETOE (J. Kah), MUSTANG SCHILLER (S. Cahill) and MONSOON POON (A. Herrmann) were slow to begin.

SVEGLIA (M. Vance) jumped away awkwardly and shifted out bumping HEART REEF (C. Jokic).

RED BEGONIA (A. Patterson) was inclined to lay in throughout the event.

In the vicinity of the 800 metres SVEGLIA (M. Vance) had to steady and lose its position when RED BEGONIA (A. Patterson) was inclined to lay in.

A. Patterson, the rider of RED BEGONIA, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded.

MUSTANG SCHILLER, SCALAIRE and RED BEGONIA were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
