Report on Race Meeting held at the Penola Racecourse

RACE 1 : COONAWARRA CUP 8TH JANUARY / SABOIS MAIDEN PLATE -
1700 metres

TRANSFORMING (E. Finnegan) was slow to begin.

ORNE RIVER (L. Hopwood) jumped away awkwardly and shifted in onto BACK TO REALITY (H. McKechnie).

ORNE RIVER (L. Hopwood) raced wide without cover in the middle stages of the event.

From in the vicinity of the 600 metres until inside the 200 metres LITTLE AUDREY (A. Patterson) was held up for clear running when racing behind PERFECT BITE (NZ) (S. Cahill).

S. Cahill, the rider of PERFECT BITE (NZ), was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

Miss N. Bruggemann, the Trainer of LITTLE AUDREY, was questioned regarding the mare's improved performance today. She explained she felt the application of a noseroll for the first time enabled the mare to settle during the race. She added LITTLE AUDREY had been working well since its last start at Gawler and in her opinion, the engagement of a senior rider benefited the mare as it can be difficult to ride.

ORNE RIVER, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : JOANNE'S ESPRESSO EXPRESS RATING 0-58 HANDICAP - 1700 metres

E. Creighton, the rider of CONSCRIBE (NZ), reported on jumping away he lost the use of his off side iron and was placed at a disadvantage for approximately 100 metres.

MEADOWS BOO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : HEYWARDS ROYAL OAK HOTEL RATING 0-62 HANDICAP - 1100 metres

The start of this race was delayed approximately three minutes owing to L'ESPRIT becoming fractious in its barrier stall after being loaded. L'ESPRIT was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. E. Creighton was examined by the First Care medical staff and passed fit to fulfil his remaining engagements. Mr. G. Hicks, the Trainer of L'ESPRIT, was advised the gelding would be required to perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

L'ESPRIT (E. Creighton) was slow to begin.

ANNANDALE LASS (A. Patterson) was held up for clear running from approaching the 400 metres until approaching the 200 metres when racing behind ZAAMMISSION (J. Frew).

QUIET CHAT (A. Herrmann) was held up for clear running from inside the 400 metres until the entrance to the straight when racing behind TELASNIP (D. Dunn).

RACE 4 : COOPERS BREWERY / SABOIS MAIDEN PLATE - 1400 metres

IT'S JAZZ TIME (NZ) (C. Jones) was slow to begin.

NEVER POINTLESS (M. Neilson) jumped away awkwardly.

In the vicinity of the 1100 metres RIGHT AND READY (J. Frew) shifted in when insufficiently clear of TUSCAN DIVA (E. Creighton). As a result HARRY'S HOT (S. Cahill), which was racing to the inside of TUSCAN DIVA, was obliged to be checked when tightened onto KINETIC ENERGY (A. Herrmann). J. Frew pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 15 October and to conclude at midnight on Wednesday, 22 October 2014; a period of three (3) meetings.

KINETIC ENERGY (A. Herrmann) was inclined to lay in, under pressure, in the straight.

A. Patterson, the rider of GANGSTA HOUR, reported the gelding never travelled well throughout the event and he was concerned with its action. He stated for this reason he did not ride GANGSTA HOUR out in his normal manner. He added on pulling up GANGSTA HOUR made several respiratory noises. GANGSTA HOUR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. G. Searle, the Trainer of GANGSTA HOUR, advised the gelding would now be spelled.

RACE 5 : KATNOOK ESTATE WINERY / SABOIS MAIDEN PLATE - 1100 metres

SELF DESTRICT (A. Herrmann) was slow to begin.

HONEST JOHN (L. Hopwood) jumped away awkwardly.

SELF DESTRICT (A. Herrmann) raced greenly throughout the event.

HONEST JOHN (L. Hopwood) was inclined to hang out throughout the event.

MOMENTOUS DAY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : CLARKE BROS BENCHMARK 80 HANDICAP - 1700 metres

GATALISTIC (D. Dunn) knuckled on jumping away.

GATALISTIC (D. Dunn) was inclined to over-race in the early and middle stages of the event.

BABAZAAR (NZ) (K. Walters) was inclined to hang out throughout the event.

S. Cahill, the rider of IRISH HIGH KING, reported his mount felt sore after pulling up and for this reason he did not ride the gelding back to Scale. As Stewards were satisfied that IRISH HIGH KING had carried the allotted weight, Correct Weight was declared. IRISH HIGH KING was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. D. O'Leary, the Trainer of IRISH HIGH KING, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 7 : CASTEC RURAL SUPPLIES BENCHMARK 80 HANDICAP - 1300 metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate race.

MY WAY (C. Puls) knuckled on jumping away.

NAUGHTY MOMENTS (E. Finnegan) jumped away awkwardly, knuckled and shifted in onto HASTA LA SHAMER (C. Lindop).

MADAM KAFOOPS (R. Mayers) was slow to begin.

HASTA LA SHAMER (C. Lindop) was inclined to over-race in the middle stages of the event.

SEASON OF FORTUNE (C. Jones) was held up for clear running when racing behind NAUGHTY MOMENTS (E. Finnegan) from in the vicinity of the 400 metres until inside the 200 metres.

HASTA LA SHAMER (C. Lindop) was held up for clear running when racing between STRIKE BREAKER (M. Neilson) and MY WAY (C. Puls) from the vicinity of the 300 metres until inside the 100 metres.

In the vicinity of the 100 metres MY WAY (C. Puls) shifted in marginally. As a result NAUGHTY MOMENTS (E. Finnegan) was obliged to ease when tightened onto SEASON OF FORTUNE (C. Jones). C. Puls was reminded of her obligations when shifting ground in future.

RACE 8 : SOUTH EAST ASBESTOS RATING 0-68 HANDICAP - 1400 metres

ZAYAK (E. Finnegan) jumped away awkwardly and shifted in onto BE FAIR (C. Jones), which was taken in onto RIP APART (A. Herrmann).

Shortly after the start CREON (K. Walters) bucked for a considerable distance. CREON was restrained by its rider and took no further part in the event. CREON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. R. Wilson, the Trainer of CREON, was advised the gelding would be required to complete either an Official Barrier Trial or Approval Jump Out to the satisfaction of the Stewards prior to accepting for a future race.

BIG BRUT (M. Munday) over-raced in the early and middle stages of the event. BIG BRUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : SOUTH EAST ASBESTOS RATING 0-68 HANDICAP - 1400 metres (Cont'd)

In the vicinity of the 200 metres HAAKON (A. Patterson) was obliged to steady as BIG BRUT (M. Munday) rolled in at the same time as RIP APART (A. Herrmann) shifted out off the heels of JETMAKER (C. Lindop), which was weakening.

ZYAK was examined by the Club's Veterinary Surgeon who reported lacerations to the mouth. Mr. D. O'Leary, the Trainer of ZYAK, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
