THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 11 October 2014

RACE 1: CITY OF MARION HANDICAP - 1600 metres

CLARIFY, which contacted the mounting yard perimeter fence en route to the barriers, was examined by the Club's Veterinary Surgeon on arrival at the start and ruled fit to race.

CLARIFY (A. Herrmann) jumped away awkwardly and was slow to begin.

RORY'S UNION (K. Bishop) raced wide without cover throughout the event.

HUMAN LEAGUE (T. Sadler) was held up for clear running when racing behind MOST HUSBANDS (C. Lindop) from in the vicinity of the 500 metres until the entrance to the straight.

In the vicinity of the 200 metres EFFCEE (C. Jokic) laid in, shifted in and tightened MUSTANG SCHILLER (S. Cahill) onto MOST HUSBANDS (C. Lindop), resulting in MUSTANG SCHILLER being inconvenienced for a number of strides.

HUMAN LEAGUE (T. Sadler), which was inclined to lay out from in the vicinity of the 200 metres, shifted out over the concluding stages onto MOST HUSBANDS (C. Lindop). As a consequence MOST HUSBANDS was accidentally struck by the whip of T. Sadler. T. Sadler was shown the vision of the incident and reminded of his obligations when his mounts commence to shift ground.

A. Herrmann, the rider of CLARIFY, explained it was her intention to settle in a mid-field position but due to the manner in which the mare began she was unable to take up the position intended. She added that in the vicinity of the 600 metres the mare was under pressure and appeared reluctant to respond to her riding. She added that after entering the straight the mare responded only fairly and was disappointing. CLARIFY was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Mr. B. Brook, the Trainer of CLARIFY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

HUMAN LEAGUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. C. Binnie, the Co-trainer of WANA DECISION, reported at scale the gelding had lost its tongue tie during the event.

RACE 2: ADELAIDE GALVANISING HANDICAP - 1200 metres

CELEBRITY TYCOON (C. Jokic) reared as the gates were released, began very awkwardly and lost many lengths at the start.

In the vicinity of the 1000 metres LORD ASPEN (M. Neilson) shifted in and inconvenienced MAGIC BOY (T. Pannell).

TIPSY ON RED (C. Lindop) over-raced in the early and middle stages and when being restrained, got its head up and raced ungenerously for some distance between the 1000 and 700 metres.

In the vicinity of the 300 metres SEENAAN (R. Hurdle), after attempting a run between VAN PERSIE (J. Potter) and FITOCRACY (A. Patterson), was disappointed as VAN PERSIE rolled out, resulting in SEENAAN and FITOCRACY, which maintained its line, brushing for a short distance. As a consequence SEENAAN was obliged to alter course to the inside of VAN PERSIE to obtain clear running.

Correct Weight for this event was delayed to allow C. Jokic, the rider of CELEBRITY TYCOON, and Mr. J. O'Connor, the gelding's Trainer, to view the official footage of the start. After doing so, C. Jokic made a submission to Stewards in respect of declaring CELEBRITY TYCOON a non-runner on the basis it was held by the Barrier Attendant when it reared and was denied a fair start. After taking evidence from the Starter, C Jokic, Mr. O'Connor, on viewing the official footage and acting on their own observations, Stewards declared CELEBRITY TYCOON to be a runner. Mr. O'Connor was advised that a warning had been placed on the gelding in relation to its barrier manners. CELEBRITY TYCOON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BOSSY MISS MOSSY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: GUY SEBASTIAN @ MORPHETVILLE 4/11 HANDICAP - 1520 metres

SEDUCTION COUNSEL (M. Neilson) was tightened at the start between HIDDEN'S SISTER (H. McKechnie) and SHADE OF GREEN (L. Hopwood), which both shifted ground.

Approaching the 1200 metres NIMASAEL (R. Hurdle) shifted in onto INFINITE FORTUNE (B. Claridge), which was taken in onto LOOKING THROUGH (C. Jokic), resulting in LOOKING THROUGH racing in restricted room for a short distance and having to be steadied, losing its position. R. Hurdle was reminded of his obligations when shifting ground in future.

ZIPNOTIZED (K. Bishop) raced wide without cover in the early stages.

LOOKING THROUGH (C. Jokic) was held up for clear running at various stages between the 500 metres and the 300 metres.

B. Claridge, the rider of INFINITE FORTUNE, reported the mare was inclined to hang out during the event. INFINITE FORTUNE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr. T. McEvoy, the Trainer of INFINITE FORTUNE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 3 : GUY SEBASTIAN @ MORPHETVILLE 4/11 HANDICAP - 1520 metres (Cont'd)

R. Bayliss, the rider of ATLANTA DREAM, explained his instructions were to take up a more forward position if possible, but owning to the manner in which the mare began and the formation of the field shortly after the start he was unable to do so and for that reason he elected to settle back of mid-field with cover. Mr. R. Maund, the Trainer of ATLANTA DREAM, confirmed he had instructed R Bayliss to attempt a more forward position owing to the apparent lack of pace in the event and the mare's wide barrier.

NIMASAEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: MINUZZO PROJECT MANAGEMENT HANDICAP - 1800 metres

BAKLAVA BOY (NZ) (B. Claridge) and GRIDHIAN (R. Bayliss) contacted at the start.

CADEL TRIOMPHE (NZ) (D. Thornton) was slow to begin, losing approximately one length.

RUSSIAN ROCKER (GB) (A. Patterson) jumped away awkwardly.

AMALGAMATE (A. Herrmann) over-raced in the early stages.

FROST DODGER (J. Potter) over-raced in the middle stages and when being restrained, raced ungenerously for a short distance.

Inside the 600 metres FROST DODGER (J. Potter) raced in restricted room on the heels of BAKLAVA BOY (NZ) (B. Claridge) and to the inside of CADEL TRIOMPHE (NZ) (D. Thornton) and was obliged to be steadied off the heels of BAKLAVA BOY (NZ). Shortly thereafter, EMMOOKI'S DASH (L. Hopwood) shifted out to improve and contacted the hindquarters of BAKLAVA BOY (NZ), which was taken out onto FROST DODGER, which shifted out and away from that gelding, resulting in CADEL TRIOMPHE (NZ) having to be checked to avoid the heels of FROST DODGER.

Correct Weight for this event was delayed to allow D. Thornton, the rider of CADEL TRIOMPHE (NZ), to view the official footage in the vicinity of the 500 metres.

FROST DODGER was examined by the Club's Veterinary Surgeon who reported a minor laceration to the left corner of its mouth.

EMMOOKI'S DASH and CADEL TRIOMPHE (NZ) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: HILL SMITH STAKES - 1800 metres

THERMOGENIC (J. Mott) and SHINING EYES (A. Creighton) were slow to begin.

FRANK HEAVENS (C. Lindop) over-raced in the early stages, got its head up when being restrained and raced ungenerously for some distance thereafter.

In the vicinity of the 800 metres JIM'S JOURNEY (S. Cahill) and MIRACLE THE SECOND (B. Claridge) contacted for a short distance.

TURBO STREET was examined by the Club's Veterinary Surgeon who reported a small laceration to its near hind leg. First Aid was administered.

LOQUETEUX lost its near fore plate during the event.

RACE 6: SCHWEPPES HANDICAP - 1200 metres

CANON DIABLO (M. Neilson) jumped away awkwardly.

Racing to the 1000 metres CASINO EXIT (R. Hurdle) shifted in and inconvenienced MEADOWS ANGEL (L. Hopwood).

Approaching the 500 metres IMPERIAL LINES (J. Maund) shifted out to improve and contacted SOL BRILLANTE (J. Toeroek), which maintained its line, resulting in these two runners brushing for several strides.

At the entrance to the straight PURREALY SOLVED (S. Vella) was obliged to be steadied off the heels of SANDHILL FLASH (J. Potter).

In the vicinity of the 200 metres SARCASM (K. Bishop) and HOUSE OF WAX (C. Jokic) improved into the same run between CHONDRA (A. Patterson) and IMPERIAL LINES (J. Maund). As a consequence HOUSE OF WAX was obliged to be steadied when awkwardly placed between CHONDRA and SARCASM, which shifted out, and was obliged to alter course to the outside of CHONDRA to obtain clear running. K. Bishop was reminded of her obligations when shifting ground in future.

CANON DIABLO, FINE APPROACH and MISS JOOLIA were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: SPPORTINGBET HANDICAP - 1200 metres

SET ON STONE was a late scratching at 10.20 am by order of Stewards acting on confirmed advice from its Trainer Mr S. Oxlade that the gelding was unfit to start.

WHAT'S IN A NAME (D. Dunn) pulled very hard in the early and middle stages and was difficult to restrain.

MERMAID RUN (K. Brooks) became held up for clear running for a number of strides at the entrance to the straight when racing behind ALMIGHTY BULLET (T. Baker).

CHESTNUT CHARLIE (A. Patterson) was held up for clear running shortly after the entrance to the straight when racing behind CONIDEL (M. Neilson) and to inside of ALMIGHTY BULLET (T. Baker) and was only able to obtain clear running approaching the 200 metres.

In the vicinity of the 300 metres ALMIGHTY BULLET (T. Baker) shifted out under pressure onto MERMAID RUN (K. Brooks), which was taken out onto WHAT'S IN A NAME (D. Dunn), which in turn was taken out into the running line of AZNA (L. Hopwood), which, in avoiding the heels of WHAT'S IN A NAME, was obliged to be steadied and shifted out onto WHITE ROE (C. Lindop), making contact with that gelding, resulting in WHITE ROE being severely hampered. T. Baker pleaded guilty to charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 19 October and to conclude at midnight on Saturday, 1 November 2014; a period of five (5) meetings.

QUICK LOVER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DANGER MOUSE was examined by the Club's Veterinary Surgeon who reported a poor post-race recovery with the possible onset of colic. First Aid was administered.

RACE 8: ENDEAVOUR QUALITY HOMES HANDICAP - 1050 metres

On arrival at the barriers T. Sadler, the rider of LONROCKSTAR, was struck in the face by the gelding and was examined by the First Care Medical staff who declared T. Sadler fit to fulfil his engagement. After the event and prior to leaving the course T. Sadler was again examined by the First Care Medical staff.

MYLADY CAROL (R. Hurdle), jumped away very awkwardly, shifted in and inconvenienced MYSTERY TOUR (S. Cahill).

READY SUNSHINE (T. Pannell) over-raced in the early and middle stages of the event.

At the entrance to the straight SANDHILL HERO (J. Potter) rolled out and contacted the hindquarters of BLUE MAGNATE (A. Herrmann).

MORPHETTVILLE PARKS – SATURDAY, 27 SEPTEMBER 2014 RACE 7: DARLEY HANDICAP - 1550 metres

Stewards concluded the matter relating to the instructions provided by Mr. N. Smart in respect of OCTOBER DATE. Stewards, having had the benefit of confirming the comments made by Mr. Smart during a radio interview on 27 September 2014, are satisfied Mr. Smart's instructions to J. Kah did not amount to a change in riding tactics and consequently took no action in respect of the matter. Stewards are satisfied that OCTOBER DATE leading in the event was unintentional.
