## RACE 1 : JOHN PEARCE / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1200 metres

WOTZINTHEBAG (C. Lindop) was inclined to hang in throughout the event. WOTZINTHEBAG was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KARADOC KID (A. Patterson) was inclined to hang in under pressure in the straight.

MARTINE was examined by the Club's Veterinary Surgeon who reported a slow recovery.

WROCLAW was examined by the Club's Veterinary Surgeon who reported minor abrasions to the off fore and near hind legs. First aid was administered.

## RACE 2 : VARIETY – THE CHILDREN'S CHARITY / SABOIS FILLIES & MARES MAIDEN PLATE - 1300 metres

CASSY'S ACE (J. Maund) was inclined to hang in under pressure in the straight.

D. Tourneur, the rider of AMBERCONI, was questioned in relation to the use of his whip prior to the 100 meters. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

GOLD KHADAN was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Mr D. Tootell (Jnr), the Trainer of GOLD KHADAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

### RACE 3: BTR EXCAVATIONS / SABOIS MAIDEN PLATE - 1050 metres

On arrival on course HITCH, which had not raced since July 2013, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

I DREAM OF GINA (D. Tourneur) jumped away awkwardly and shifted out onto CORONA SHAW (D. Dunn).

ONEHUNDREDCLICKS (NZ) (K. Cross) raced greenly throughout the event. ONEHUNDREDCLICKS (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

I DREAM OF GINA (D. Tourneur) was inclined to lay in under pressure over the concluding stages of the event. I DREAM OF GINA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 4: RAMSEY BROS RATING 0-68 HANDICAP - 1600 metres

OKAHU BAY (A. Patterson) was slow to begin.

SERBIAN CROWN (J. Kah) knuckled on jumping away.

SOUTHERN INVASION (R. Stewart) raced wide without cover in the early and middle stages of the event.

WICKED TYCOON (D. Dunn) was held up for clear running when racing between CLAY PAVER (T. Zanker) and SOUTHERN INVASION (R. Stewart) approaching the 400 metres. As a result WICKED TYCOON was untested to the line. WICKED TYCOON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

From approaching the 400 metres until the vicinity of the 200 metres SERBIAN CROWN (J. Kah) was held up for clear running when racing inside NO DOUBTFIRE (M. Neilson) and behind LIGHTNING DREW (D. Tourneur).

#### RACE 5: NORTH EAST ISUZU MAIDEN PLATE - 1600 metres

On arrival at the start JOURNEY UNKNOWN was required to be re-saddled.

DE LAGO HERIZ (J. Holder) jumped away awkwardly and shifted out onto COME ON KAROL (E. Finnegan).

In the vicinity of the 1400 metres PERPETUAL BLISS (D. Tourneur) shifted in as the pace slackened inconveniencing CLAREMONT KID (T. Pannell) for several strides. D. Tourneur was severely reprimanded and advised to take greater care when shifting ground in future.

CLAREMONT KID (T. Pannell) was inclined to hang out throughout the event.

At the entrance to the straight COME ON KAROL (E. Finnegan) was obliged to alter course to the inside of CLAREMONT KID (T. Pannell), which continued to hang out.

DAJEBONY RO (L. Stojakovic) was inclined to hang in at the entrance to the straight.

READY AGAIN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr L. Kennewell, the Trainer of READY AGAIN was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## RACE 6: MORRIS INDUSTRIES / SABOIS + RATING 0-62 HANDICAP - 2200 metres

RUSTANA (D. Dunn) was inclined to over-race during the event.

Approaching the 800 metres RUSTANA (D. Dunn) improved off the heels of CLANDARBHEN (C. Lindop) and in doing so, shifted out onto STURGIS (NZ) (S. Price), which was inclined to lay in. As a result STURGIS (NZ) was obliged to be steadied.

SCARPELEENO (D. Tourneur) was held up for clear running from the entrance to the straight until inside the 400 metres, when racing behind ELEGANT RUSH (J. Kah).

ELEGANT RUSH (J. Kah) was inclined to hang out under pressure in the straight.

M. Neilson, the rider of BUSINESS DECISION, reported his mount did not feel comfortable in its action when placed under pressure. BUSINESS DECISION was examined by the Club's Veterinary Surgeon who reported the horse to be lame in both hind legs. Mr J. Smith, the Trainer of BUSINESS DECISION was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## RACE 7: CASE IH AGRICULTURE CLASS 2 HANDICAP - 1200 metres

QUIET CHAT (R. Stewart) jumped away awkwardly and shifted out onto WINE LOVER (D. Dunn).

In the vicinity of the 600 metres TIPSY ON RED (C. Lindop) was obliged to be checked as the gelding improved onto the heels of QUIET CHAT (R. Stewart). As a result TIPSY ON RED lost its position and was awkwardly placed for a number of strides. TIPSY ON RED was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CALL ME PENNY (A. Doyle) was held up for clear running from inside the 600 metres until approaching the 200 metres when racing behind LADY HEDERAJ (J. Kah) and inside STARDUST ONE (E. Finnegan).

Z. Spain, the rider of JENNYFROMTHEBLOCK, was reminded of his obligations to ride his mounts out to the finish line in future.

## RACE 8: IJF AUSTRALIA RATING 0-62 HANDICAP - 1400 metres

The start of this event was delayed by approximately two minutes owing to FIELLO having to be examined by the Club's Veterinary Surgeon on arrival at the start, as that gelding's rider had concerns with its action. FIELLO was ruled fit to race.

ASH ROAD (T. Pannell) jumped away awkwardly and shifted out onto MRS MARIELLA (J. Kah) taking that mare out onto THE FASTNET (A. Patterson), which was taken out onto KEEP IT A SECRET (M. Henderson), which was taken out onto GO GIRLFRIEND (J. Holder), which was taken out onto ZIPNOTIZED (J. Toeroek), which lost its position. At the same time HAPPYENDO (L. Stojakovic) was taken in by KOOMA BLAZE (K. Brooks), which jumped away awkwardly and shifted in.

Approaching the 600 metres FIELLO (D. Dunn) had to be steadied off the heels of ZIPNOTIZED (J. Toeroek). As a result FIELLO shifted out inconveniencing USCHRIKE (D. Tourneur).

## RACE 8: IJF AUSTRALIA RATING 0-62 HANDICAP - 1400 metres (Cont'd)

GO GIRLFRIEND (J. Holder) has held up for clear running from in the vicinity of the 500 metres until in the vicinity of the 400 metres when racing behind THE FASTNET (A. Patterson.

In the vicinity of the 200 metres GO GIRLFRIEND (J. Holder) shifted out off the heels of MONSOON POON (A. Herrmann), which was weakening. As a result THE FASTNET (A. Patterson) was taken out onto BOSSY MISS MOSSY (C. Lindop). As a consequence ZIPNOTIZED (J. Toeroek), which was racing behind BOSSY MISS MOSSY was obliged to be steadied and alter course to the outside of HAPPYENDO (L. Stojakovic), which was laying in. J. Holder was severely reprimanded and reminded of his obligations when shifting ground in future.

ZIPNOTIZED was examined by the Club's Veterinary Surgeon who reported no visible abnormalities
