#### Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 1 November 2014

# WEATHER: Fine/Windy

## **<u>RAIL</u>**: Out 12 metres 1200m to Winning Post, 7 metres remainder.

#### RACE 1 : SPORTINGBET HANDICAP - 1100 metres

Apprentice J. Childs, who was unable to claim down to his minimum riding weight, was permitted to claim 2 kg when no other apprentice rider was available. J. Childs was reprimanded under AR92(12) and advised future breaches of this Rule may result in a penalty being imposed.

BOKARA ROAD (K. Cross) jumped away awkwardly.

J. Toeroek, the rider of ALCOBRO, was spoken to regarding the use of his whip with reference to raising his arm above shoulder height. His attention was drawn to AR137A(4)(b).

ILLUSTRIOUS LAD lost its near fore plate during the event.

ECLAIR CHOICE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 2 : STAMFORD GRAND HANDICAP - 1600 metres

CATON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RING ME NOT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3 : GUY SEBASTIAN LIVE @ MORPHETVILLE 4/11 HANDICAP - 1600 metres

STIMULATTE (A. Herrmann) and SUPER SILKS (NZ) (J. Matthews) brushed on jumping away.

LIGHTNING DREW (J. Toeroek) jumped away awkwardly.

SERBIAN CROWN (C. Lindop) raced wide without cover in the early stages of the event.

SUPER SILKS (NZ) (J. Matthews) raced keenly in the early stages of the event.

STIMULATTE (A. Herrmann) raced wide without cover throughout the event.

# RACE 3 : GUY SEBASTIAN LIVE @ MORPHETVILLE 4/11 HANDICAP - 1600 metres (Cont'd)

In the vicinity of the 500 metres MAJESTIC MOMENT (M. Neilson) shifted out to improve and hampered STIMULATTE (A. Herrmann), which had to be steadied to avoid the heels of that gelding. M. Neilson was severely reprimanded and advised to take greater care when shifting ground in future.

EFFCEE (S. Westover) laid out in the straight.

In the vicinity of the 200 metres SUPER SILKS (NZ) (J. Matthews) was disappointed for clear running between ASTRO DAMUS (R. Stewart) and SERBIAN CROWN (C. Lindop), which both shifted ground marginally, and was obliged to alter course to the outside of ASTRO DAMUS to obtain clear running.

S. Cahill, the rider of EXALTED MOMENT, explained his mount was slow into stride and as a consequence he was unable to take up a more forward position as intended.

EXALTED MOMENT lost its off fore plate during the event.

LIGHTNING DREW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KING USAIN (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Ms. P. Trenwith, the Trainer of KING USAIN (NZ), was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

# RACE 4 : BREEZAIR SUPERCOOL HANDICAP - 2044 metres

AMALGAMATE (E. Boyd) raced wide without cover throughout the event.

GO DREAMING, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. G. Kluske, the Trainer of GO DREAMING, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

POWER TO POSSESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 5 : SARAH GROUP HANDICAP - 1050 metres

The start of this race was delayed approximately two minutes owing to MEMORABLE MOMENT proving very difficult to load. Mr. M. Whittle, the Trainer of MEMORABLE MOMENT, was advised the gelding would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

Approaching the 800 metres REAL FANTASY (C. Lindop) was obliged to steady off the heels of MEMORABLE MOMENT (A. Herrmann) as REAL FANTASY rolled out.

REAL FANTASY (C. Lindop) was held up for clear running from in the vicinity of the 500 metres when racing behind MEMORABLE MOMENT (A. Herrmann) and near the entrance to the straight, when being restrained, inconvenienced ST FRASER (D. Dunn), which was following and obliged to alter course to the outside of REAL FANTASY.

PURREALY SOLVED (S. Vella) was held up from the 500 metres until shortly after straightening when racing behind SON SENORAS (S. Cahill).

# RACE 5 : SARAH GROUP HANDICAP - 1050 metres (Cont'd)

Inside the 200 metres LEAHONE (M. Neilson) shifted in and inconvenienced MEMORABLE MOMENT (A. Herrmann), which had to be steadied when awkwardly placed on the heels of SWINGING ARMS (J. Toeroek).

S. Cahill, the rider of SON SENORAS, reported the mare did not respond to his riding in the straight and was disappointing.

LEAHONE was examined by the Club's Veterinary Surgeon who reported a near eye corneal lesion. First Aid was administered.

# RACE 6 : ADELAIDE GALVANISING HANDICAP - 1200 metres

On arrival on course BARIGAN BOY was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

TILDY LAD (H. McKechnie) jumped away awkwardly, shifted out and tightened RIVER'S LANE (J. Childs) onto GOLD BUNDLE (M. Neilson), which was tightened onto BARIGAN BOY (J. Toeroek), which shifted in. As a consequence BARIGAN BOY was taken out onto EKIBUUKA (C. Lindop), which was inconvenienced.

Near the 700 metres WISE AND HAPPY (S. Carr) shifted out and away from STAR ACT (A. Herrmann) and contacted the hindquarters of RIVER'S LANE (J. Childs), which in turn was taken out onto EKIBUUKA (C. Lindop), turning that gelding's hindquarters.

## RACE 7 : DAVID LOY HANDICAP - 1536 metres

Mr. M. Shepherdson, representing Mr. T. McEvoy, the Trainer of AMARACHI, advised Stewards Jockey M. Neilson would be instructed to attempt to be more positive in the early stages today.

ATLANTA DREAM (J. Childs) jumped away awkwardly, shifted out and contacted BARELY A BEAT (R. Hurdle), which was tightened onto MERMAID RUN (S. Price).

SPRAY TAN (A. Herrmann) jumped away awkwardly and was slow to begin.

SPRAY TAN (A. Herrmann) raced wide without cover throughout the event.

SWINGING SOLDIER (D. Dunn) laid in, in the straight.

BARELY A BEAT (R. Hurdle) laid out under pressure over the concluding stages.

HIGH VALUE lost its near hind plate during the event.

SWINGING SOLDIER and TIPPERARY LIL were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 8 : MAC JUST OVER? DON'T DRIVE HANDICAP - 1200 metres

On arrival at the start, MISS JOOLIA, which was unruly en route to the barriers, was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

MISS JOOLIA (H. McKechnie) jumped away awkwardly, shifted out and tightened CANON DIABLO (M. Neilson) onto AZNA (A. Patterson), which was tightened onto TOO DEADLY (J. Cartwright), resulting in that gelding becoming unbalanced. As a consequence CANON DIABLO lost its position.

# RACE 8 : MAC JUST OVER? DON'T DRIVE HANDICAP - 1200 metres (Cont'd)

In the vicinity of the 1100 metres DEBEERSONUS (K. Cross) shifted in and away from SANDHILL FLASH (A. Herrmann) onto GRAND BRITANNIA (E. Boyd), which was inconvenienced when taken in.

Approaching the 900 metres CANON DIABLO (M. Neilson) shifted in and inconvenienced DOUBLE POCKETS (D. Dunn), which had to be steadied. Shortly thereafter DOUBLE POCKETS commenced to over-race and became awkward on the heels of MISS JOOLIA (H. McKechnie). M. Neilson was reprimanded and advised to take greater care when shifting ground in future.

Inside the 200 metres DEBEERSONUS (K. Cross) was unable to obtain clear running between CANON DIABLO (M. Neilson) and HEART REEF (R. Hurdle), which had commenced to roll in, and was obliged to alter course to the outside of HEART REEF in the vicinity of the 100 metres.

M. Neilson, the rider of CANON DIABLO, reported his mount hung out in the straight. CANON DIABLO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

R. Hurdle, the rider of HEART REEF, was spoken to regarding the use of his whip forward of his mount's shoulder.

DOUBLE POCKETS and TOO DEADLY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. K. Bourke, the Trainer of TOO DEADLY, which was presented to race in buckled reins, was advised to ensure he does not present his horses to race in buckled reins in South Australia in future.
