# Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Tuesday, 4 November 2014

### RACE 1 : ANGELAKIS BROS MAIDEN PLATE - 1050 metres

On arrival on course MUBAKKIR, which had shifted both hind plates, required Farrier attention. MUBAKKIR was examined by the Club's Veterinary Surgeon and ruled fit to race.

MADAM DE POMPADOUR (T. Baker) jumped away awkwardly, shifted out and contacted the hindquarters of JESSIE'S OWN (J. Holder), which was inconvenienced.

ROUSSANNE (B. Hoppo) and CORONA SHAW (J. Matthews) contacted on jumping away when both horses shifted ground.

Approaching the 700 metres CORONA SHAW (J. Matthews) shifted in and inconvenienced HITCH (K. Cross), which had to be steadied. J. Matthews was reprimanded and advised to take greater care when shifting ground in future.

HIGHWAY STAR, which weakened over the concluding stages and shifted ground both ways, was examined by the Club's Veterinary Surgeon who reported atrial fibrillation. Mr. G. Searle, the Trainer of HIGHWAY STAR, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

JESSIE'S OWN was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. J. O'Loughlin, the Trainer of JESSIE'S OWN, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

#### RACE 2: ROYAL SOCIETY FOR THE BLIND MAIDEN PLATE - 1050 metres

The start of this race was delayed slightly owing to BOMDIDILLY getting its near hind leg up in the barrier stall. BOMDIDILLY was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

CRAYZED (M. Vance) jumped away awkwardly, shifted in and contacted SHEEZE HECTIC (J. Toeroek), which was tightened onto RIKISHI (S. Carr), which in turn contacted BOMDIDILLY (J. Holder).

SHEEZE HECTIC (J. Toeroek) raced greenly throughout the event.

SWEDISH BITTERS (E. Boyd) raced wide with cover throughout and greenly in the straight.

- J. Holder, the rider of BOMDIDILLY, was reminded of his obligations in riding his mounts to the line.
- K. Cross, the rider of LOS RIOS, explained her instructions were to take up a forward position in running and the filly travelled well in the early stages but was inclined to lay away from other runners between the 600 metres and the 400 metres and after entering the straight, was under pressure and finished the race off in a disappointing manner. LOS RIOS was examined by the Club's Veterinary Surgeon who reported a suspected lung infection. Mr. R. Jolly, the Trainer of LOS RIOS, was advised the results of a full respiratory examination (results of endoscopic examination and scan included) would be required prior to presenting the filly for a future trial or race.

### RACE 3: MOET & CHANDON MAIDEN PLATE - 1050 metres

NEW BALLS PLEASE (S. Cahill) jumped away awkwardly and shortly after the start was inconvenienced when HARREBS TIME (R. Stewart), which jumped away awkwardly, shifted in abruptly.

DUBAI (NZ) (T. Baker) and NEW BALLS PLEASE (S. Cahill) pulled very hard in the early stages of the event.

Approaching the 900 metres NEW BALLS PLEASE (S. Cahill) became ungenerous and shifted in onto TRENTPARK (J. Maund), which was hampered for several strides.

TRENTPARK (J. Maund) raced greenly throughout the event and in the vicinity of the 400 metres became awkwardly placed on the heels of NEW BALLS PLEASE (S. Cahill).

Correct Weight for this event was delayed to allow T. Baker, the rider of the third placegetter DUBAI (NZ), to view the official footage shortly after the start.

### RACE 4: HAPPY 90TH LAUREL WILLIAMS MAIDEN PLATE - 1600 metres

SANDHILL FLYER (K. Cross) jumped away awkwardly, shifted out, contacted CHOSEN FRIEND (E. Boyd) and thereafter was slow into stride.

Approaching the 400 metres MONTOYAS (S. Cahill) became held up for clear running for a number of strides when racing behind KHAZNEH (R. Stewart) and inside BLARNEY CASTLE (NZ) (D. Dunn).

SANDHILL FLYER (K. Cross) hung out from in the vicinity of the 500 metres. SANDHILL FLYER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 4: HAPPY 90TH LAUREL WILLIAMS MAIDEN PLATE - 1600 metres (Cont'd)

S. Carr, the rider of DONERAILE, who returned to Scale in excess of half a kilogram over the weight at which she weighed out, pleaded guilty to a charge under AR145 and was fined \$300.

CHOSEN FRIEND and REGAL MAGNUS were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 5: BURNSIDE VILLAGE HANDICAP - 1050 metres

The start of this race was delayed approximately seven minutes owing to ZANDERCAN becoming fractious when being presented to load due to ARDERE becoming fractious in its barrier stall. ZANDERCAN dislodged its rider J. Matthews and galloped riderless for some distance before being secured by the Clerk of the Course. ZANDERCAN was ruled unfit to race by the Club's Veterinary Surgeon. Acting on that advice, Stewards withdrew ZANDERCAN at 2.56 pm.

TENNESSEE GROOM (NZ) (S. Carr) became fractious in its barrier stall just prior to the start being effected.

SHIP'S CAPTAIN (J. Toeroek) jumped away awkwardly and shifted out onto FIDEL ASTRO (M. Neilson), which was inconvenienced when taken out onto MASTER BLACK (R. Hurdle), which lost its position when tightened onto ALBANY GREY (B. Claridge).

ONEHUNDREDCLICKS (NZ) (K. Cross) jumped away awkwardly.

TENNESSEE GROOM (NZ) (S. Carr) jumped away very awkwardly.

TEQUILA RED (R. Stewart) and MIDNIGHT SONG (J. Holder) contacted on jumping away.

MIDNIGHT SONG (J. Holder) was held up for clear running from in the vicinity of the 300 metres until in the vicinity of the 200 metres and thereafter, inside the 100 metres, became awkward on the heels of TEQUILA RED (R. Stewart) and was obliged to alter course to that gelding's outside.

TENNESSEE GROOM (NZ) (S. Carr) improved onto and clipped the heels of TEQUILA RED (R. Stewart) shortly after passing the winning post and stumbled. TENNESSEE GROOM (NZ) was examined by the Club's Veterinary Surgeon who reported minor bruising over the left eye.

SHIP'S CAPTAIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 6: WILLIAM BUCK ACCOUNTANTS SPRING STAYERS' SERIES FINAL - 2600 metres

Stewards gave permission for M. Vance to ride OUTRAGEOUS MAN 1kg overweight when no other rider was available at or nearer the allotted weight.

Apprentice S. Carr, who was unable to claim down to her minimum riding weight, was permitted to ride DITCHED  $\frac{1}{2}$  kg overweight when no other rider was available. S. Carr was fined \$200 under AR92(12).

BELLE OF THE SOUTH (A. Herrmann) became held up rounding the home turn when racing behind OUTRAGEOUS MAN (M. Vance) and was obliged to shift out to obtain clear running.

In the vicinity of the 400 metres DITCHED (S. Carr) rolled in and inconvenienced STURGIS (NZ) (K. Cross), which was obliged to be steadied and altered course to that mare's outside.

# RACE 6: WILLIAM BUCK ACCOUNTANTS SPRING STAYERS' SERIES FINAL - 2600 metres (Cont'd)

In the vicinity of the 200 metres STURGIS (NZ) (K. Cross) raced in restricted room for a short distance between DOUBLY SURE (NZ) (R. Hurdle) and BELLE OF THE SOUTH (A. Herrmann), which rolled out.

Correct Weight for this event was delayed to allow K. Cross, the rider of the sixth placegetter STURGIS (NZ), to view the official footage rounding the home turn. After doing so K. Cross lodged an objection against DITCHED (S. Carr) being declared the fifth placegetter on the grounds of alleged interference rounding the home turn. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* K. Cross' objection.

SCARPELEENO lost its off fore plate during the event.

REMORSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 7: ADELAIDE CASINO HANDICAP - 1200 metres

GOODFUN GIRL (C. Lindop) over-raced in the early stages of the event.

#### RACE 8 : SCHWEPPES HANDICAP - 1200 metres

Apprentice S. Carr, who was unable to claim down to her minimum riding weight, was permitted to claim only 2½ kg on MISS WRITTEN. S. Carr was fined \$200 under AR92(12).

BIG WEEKEND, which was fractious in the barriers after being loaded, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

SANDHILL HERO (A. Herrmann) was slow to begin, losing three to four lengths.

Correct Weight for this event was delayed to allow Stewards to review the official footage of the start.

M. Neilson, the rider of ALWAYS MAGIC, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200.

ALWAYS MAGIC was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 9: MAC JUST OVER? DON'T DRIVE HANDICAP - 1800 metres

Mr. P. Hardacre, the Trainer of AFFLECK, advised Stewards he would instruct Apprentice K. Cross to attempt to obtain a more forward position today.

WICKED TYCOON (S. Carr) jumped away very awkwardly, shifted out abruptly and tightened ZAYAK (C. Lindop) onto RICH PRIDE (A. Herrmann), resulting in ZAYAK losing its position.

TRY YOUR BEST (NZ) (D. Dunn) jumped away very awkwardly.

### RACE 9: MAC JUST OVER? DON'T DRIVE HANDICAP - 1800 metres (Cont'd)

DE LAGO HERIZ (J. Holder) jumped away awkwardly and was then tightened between TSITSIKAMMA (E. Boyd) and WHERE'S THAT (M. Vance) when TSITSIKAMMA shifted out.

AFFLECK (K. Cross) was slow to begin.

Approaching the 700 metres TRY YOUR BEST (NZ) (D. Dunn) improved onto the heels of ZAYAK (C. Lindop), became awkward and was obliged to steady for several strides.

At the entrance to the straight GO GIRLFRIEND (T. Baker) shifted out to improve and inconvenienced RICH PRIDE (A. Herrmann), which had to be steadied. T. Baker was severely reprimanded and advised to only shift ground when entitled to do so in future.

In the vicinity of the 200 metres LOOKING THROUGH (M. Neilson) was momentarily held up for clear ground when racing behind WHERE'S THAT (M. Vance).

Inside the 200 metres TRY YOUR BEST (NZ) (D. Dunn) improved onto the heels of DE LAGO HERIZ (J. Holder) and was obliged to alter course to that filly's outside to obtain clear running.

SOUTHERN INVASION was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mrs. M. Ruberry, the Trainer of SOUTHERN INVASION, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
