THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 8 November 2014

RACE 1 : SPORTINGBET HANDICAP - 1250 metres

In the vicinity of the 900 metres CELEBRITY TYCOON (R. Hurdle) became awkwardly placed on the heels of TRAFFIC DODGER (S. Cahill) as that gelding slowed the pace after taking up a forward position. As a result THE ULTIMATUM (C. Lindop) became awkward on the heels of CELEBRITY TYCOON, had to be restrained and shifted out onto MAGIC BOY (S. Carr), which was taken wider. As a consequence PATCH HERO (J. Toeroek), which was following, became awkwardly placed on the heels of MAGIC BOY, was hampered and obliged to race very wide for several strides. Thereafter PATCH HERO, when being restrained, commenced to race very ungenerously, raced wide without cover for some distance and did not settle until inside the 600 metres.

- J. Toeroek, the rider of PATCH HERO, explained that after the filly commenced to race ungenerously, he was obliged to race without cover and rounding the home turn was unable to hold MAGIC BOY (S. Carr), which improved to his inside. He added PATCH HERO finished the race off in a disappointing manner. PATCH HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Cahill, the rider of TRAFFIC DODGER, explained his instructions were to allow the horse to settle where it was comfortable, however, if there was not sufficient pace in the event, given that the gelding was fitted with blinkers for the first time, rather than being trapped wide, to take up a forward position. He further explained that when making the turn near the 900 metres, after obtaining a forward position due to an apparent lack of pace to his inside, he restrained his mount in an attempt to allow the gelding to settle and as a consequence TRAFFIC DODGER commenced to race a little strongly. Stewards advised S. Cahill that in the circumstances, his slowing the pace in that part of the event did not amount to excessively slowing or checking the pace, but nevertheless reminded him of his obligations under AR137(d). Stewards confirmed the instructions in respect of TRAFFIC DODGER with the horse's Trainer Mr D. Clarken.

TRAFFIC DODGER lost its near hind plate during the event.

RACE 2: PURA MILK HANDICAP - 1250 metres

The start of this race was delayed approximately one minute owing to HIGHNESS proving a little difficult to load.

RACE 2: PURA MILK HANDICAP - 1250 metres (Cont'd)

HIGHNESS (E. Boyd) hung out from in the vicinity of the 500 metres.

C. Jones, the rider of CONIDEL, was spoken to regarding riding her mounts to the line.

FINE APPROACH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: NHP HANDICAP - 1000 metres

EXODUS (D. Dunn) was slow into stride and unable to maintain contact with the field in the early stages of the event.

C. Lindop, the rider of OUTSIDE, reported on return to scale the gelding did not feel comfortable in its action on pulling up. OUTSIDE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. M. Wayman, the Trainer of OUTSIDE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

KUAIMA lost its near fore plate during the event.

EXODUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: THE RSL & ASC POPPY WEEK HANDICAP - 1950 metres

Approaching the 500 metres EXALTED MOMENT (S. Cahill) shifted out to improve and inconvenienced BAKLAVA BOY (NZ) (J. Frew), which had to be steadied. S. Cahill was severely reprimanded and advised to take greater care when shifting ground in future.

EXALTED MOMENT lost its off fore plate during the event.

JASPERS GLEN was examined by the Club's Veterinary Surgeon who reported minor lacerations to this horse's near fore shoulder.

RACE 5: NEED IT DONE? JIM'S THE ONE HANDICAP - 1250 metres

Mr. L. Macdonald, the Co-Trainer of MAGLISSA, advised Stewards prior to the event that he would instruct Jockey C. Lindop to attempt to settle the mare with cover.

MAGLISSA (C. Lindop) over-raced in the early and middle stages and was obliged to race wide without cover throughout the event.

YOU ARE MY WORLD (FR) (R. Stewart) was held up for clear running from in the vicinity of the 600 metres until shortly after the entrance to the straight where it was obliged to alter course to the inside of AKBAR MAHAL (D. Dunn) to obtain clear ground. Thereafter YOU ARE MY WORLD (FR) laid in for the remainder of the event.

C. Lindop, the rider of MAGLISSA, explained that while she attempted to comply with her instructions to settle the mare with cover in the early stages of the event, she was unable to do so due to the mare's racing manners.

WHO YOU KNOW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

YOU ARE MY WORLD (FR) was examined by the Club's Veterinary Surgeon who reported the mare had shifted its near fore plate with no other visible abnormalities.

RACE 6: JIM'S CLEANING HANDICAP - 1250 metres

JACKS JOURNEY (E. Boyd) and CON NOW (A. Patterson) contacted at the start and shortly thereafter FLOW METER (S. Carr) shifted out and contacted JACKS JOURNEY.

LUCKY ON BLACK (C. Lindop) raced keenly in the early stages of the event.

VIOLETS ARE BLUE (J. Holder) became held up for clear running from in the vicinity of the 500 metres until shortly after entering the straight. VIOLETS ARE BLUE then shifted out and improved to the outside of AZZCOOL (J. Toeroek) and brushed with JACKS JOURNEY (E. Boyd), which shifted sout and away from that mare onto CON NOW (A. Patterson), resulting in that mare's hindquarters being turned and it shifting out into the running of LUCKY ON BLACK (C. Lindop), which was hampered and had to be steadied. J. Holder was reminded of his obligations when his mounts commence to shift ground.

VIOLETS ARE BLUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : JIM'S CARPET CLEANING HANDICAP - 1400 metres

On arrival at the barriers ASH ROAD was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

ASH ROAD (B. Claridge) jumped away awkwardly and shifted out onto TENERE (J. Matthews), which was tightened onto GRAND BRITANNIA (S. Cahill). As a consequence TENERE lost its position.

MEADOWS ANGEL (C. Lindop) raced wide without cover in the early stages of the event.

In the vicinity of the 500 metres SUPER SILKS (NZ) (A. Patterson) improved onto and became awkward on the heels of REWIND TIME (R. Stewart) for a short distance.

REWIND TIME (R. Stewart) was held up for clear running from in the vicinity of the 500 metres when racing behind NIMASAEL (J. Maund) and to the inside of MEADOWS ANGEL (C. Lindop) until shortly after the entrance to the straight where it was obliged to shift out to obtain clear running.

In the vicinity of the 200 metres ASH ROAD (B. Claridge) was momentarily inconvenienced after initially being taken out by REWIND TIME (R. Stewart) and being crossed by HOUSE OF WAX (S. Westover), which shifted in slightly.

MOONLIGHT FOREST was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. D. Jolly, the Trainer of MOONLIGHT FOREST, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 8: JIM'S WINDOW CLEANING HANDICAP - 1400 metres

SEASON OF FORTUNE (C. Jones) and BARIGAN BOY (J. Toeroek) contacted shortly after the start when SEASON OF FORTUNE, which was inclined to lay in, rolled in.

EXCLUDED (NZ) (S. Carr) over-raced in the early stages of the event.

In the vicinity of the 800 metres GENEROUS BEAU (D. Dunn) became awkward on the heels of EXCLUDED (NZ), which rolled out, and thereafter became very ungenerous when being restrained and was reluctant to settle and raced ungenerously for some distance before becoming awkward on the heels of BARIGAN BOY (J. Toeroek) in the vicinity of the 600 metres.

RACE 8: JIM'S WINDOW CLEANING HANDICAP - 1400 metres (Cont'd)

At the entrance to the straight GENEROUS BEAU (D. Dunn) again became awkwardly placed on the heels of BARIGAN BOY (J. Toeroek) and was obliged to alter course to the inside of that gelding to obtain clear running.

QADIR (J. Holder) was held up for clear running from shortly after the entrance to the straight when racing behind GET PRONTO (E. Boyd) before being obliged to alter course to the outside of that gelding to obtain clear running.

GENEROUS BEAU, SEASON OF FORTUNE and QADIR were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
