Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 15 November 2014

RACE 1 : MYER TWO-YEAR-OLD PLATE - 1000 metres

The start of this race was delayed approximately three minutes owing to TAMAZOJ (NZ) being presented to race in work shoes, which were removed by the Farrier on arrival at the barriers. TAMAZOJ (NZ) was examined by the Club's Veterinary Surgeon and ruled fit to race. Stewards permitted the filly race unshod. Mr. D. Hayes and Mr. T. Dabernig, the Co-Trainers of TAMAZOJ (NZ), pleaded guilty to a charge under AR141A(1) and were fined \$1000.

HAZY LANE (J. Toeroek) jumped away awkwardly and was slow to begin.

HAZY LANE (J. Toeroek) raced keenly in the early and middle stages and in the vicinity of the 700 metres rolled in and inconvenienced TAMAZOJ (NZ) (D. Tourneur) at the same time as COUNTER PULSE (C. Lindop) shifted out to avoid the heels of AMERITAR (M. Vance), which shifted in. As a result TAMAZOJ (NZ) was forced to be steadied. M. Vance was severely reprimanded and advised to ensure she was sufficiently clear when shifting ground in future.

From approaching the 400 metres until the vicinity of the 200 metres TAMAZOJ (NZ) (D. Tourneur) was held up when racing behind AMERITAR (M. Vance) and inside COUNTER PULSE (C. Lindop).

Subsequent to the event TAMAZOJ (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HAZY LANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: SPORTINGBET HANDICAP - 1000 metres

RUGGED ANGEL (J. Holder) jumped away awkwardly and was slow into stride.

I AM GYPSY (M. Vance) over-raced and was inclined to lay out in the early and middle stages of the event.

ECLAIR CHOICE (D. Dunn) was inclined to lay in under pressure in the straight.

RACE 3: MEDALLION HOMES MAIDEN PLATE - 1300 metres

NEW BALLS PLEASE (S. Cahill) jumped away awkwardly.

BRIDGEY FLYER (C. Lindop) knuckled on jumping away.

ROOBOY (T. Baker) raced wide without cover throughout the event.

EXALTED BLOOM (D. Tourneur) rolled out slightly making the turn in the vicinity of the 1000 metres and when shifting back in, took NEW BALLS PLEASE (S. Cahill), which had improved quickly to its inside, in onto ZIP DELICIOUS (R. Hurdle), which had to be eased momentarily.

B. Claridge, the rider of ISLES OF WONDER, reported the filly was coughing on pulling up. ISLES OF WONDER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : ADELAIDE GALVANISING HANDICAP - 1400 metres

SHADE OF GREEN (A. Herrmann) jumped away awkwardly and shifted in, brushing BARELY A BEAT (R. Hurdle).

GOODFUN GIRL (C. Lindop) raced three wide without cover throughout the event.

In the vicinity of the 1300 metres TIPPERARY LIL (J. Toeroek) shifted in onto GOODFUN GIRL (C. Lindop), which got its head up and raced fiercely for a number of strides. J. Toeroek was severely reprimanded and advised to take greater care when shifting ground in future.

In the vicinity of the 1200 metres TIPPERARY LIL (J. Toeroek) shifted in onto ANNANDALE LASS (A. Patterson), which was forced to race in restricted room when awkwardly placed inside the heels of TIPPERARY LIL and had to be steadied near the 1100 metres. J. Toeroek pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 19 November and to conclude at midnight on Sunday, 23 November 2014; a period of three (3) meetings.

J. Toeroek, the rider of TIPPERARY LIL, reported his mount was inclined to lay out under pressure in the straight.

RACE 5: BOBBY MUSKER HANDICAP - 2400 metres

When the Thoroughbred Identification Card was unavailable for NOBLE TWOSTEP and Stewards were able to identify the mare from computer records held by them, the mare was permitted to start. Mr. G. Young, the Trainer of NOBLE TWOSTEP, pleaded guilty to a charge under AR59A for failing to produce the TIC for the mare and was fined \$50.

RACE 5: BOBBY MUSKER HANDICAP - 2400 metres (Cont'd)

Mr. R. Laing, the Trainer of ROWLAND, advised Stewards he would instruct Apprentice R. Hurdle to attempt to settle forward of mid-field if possible today.

SUDDEN MOMENT (C. Lindop) jumped away awkwardly and shortly after was inconvenienced when tightened between SCARPELEENO (D. Tourneur), which shifted out, and HIOCTDANE (J. Toeroek), which shifted in.

THE WILD THING (T. Baker) and NOBLE TWOSTEP (A. Herrmann) were slow to begin.

NOBLE TWOSTEP (A. Herrmann) raced keenly in the early and middle stages of the event.

SCARPELEENO (D. Tourneur) was held up from in the vicinity of the 600 metres until inside the 400 metres when racing behind BAKLAVA BOY (NZ) (B. Claridge) and inside HIOCTDANE (J. Toeroek).

J. Toeroek, the rider of HIOCTDANE, reported in his opinion the gelding became short in its action and appeared not to travel comfortably in the underfoot conditions and for that reason he eased HIOCTDANE out of the event in the straight. HIOCTDANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WAR IS OVER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. J. Hyam, the Trainer of WAR IS OVER, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

NOBLE TWOSTEP lost its off hind plate during the event.

RACE 6 : CAMP GALLIPOLI HANDICAP - 1550 metres

ALCHEMY'S EIGHT (R. Hurdle) was slow to begin.

SPUN DRY (D. Tourneur) jumped away awkwardly.

KING USAIN (NZ) (C. Lindop) raced three wide without cover throughout the event.

KING USAIN (NZ) (C. Lindop) was eased out of the event from in the vicinity of the 200 metres.

C. Lindop, the rider of KING USAIN (NZ), reported the gelding hung out in the early stages of the event, felt awkward in its action in the straight and as a consequence she eased KING USAIN (NZ) out of the event. KING USAIN (NZ) was examined by the Club's Veterinary Surgeon who reported a poor respiratory recovery with injected oral mucous membranes consistent with airway obstruction in the run. Ms. P. Trenwith, the Trainer of KING USAIN (NZ), was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SKY RAIDER lost its off hind plate during the event.

RACE 7: CHRISTMAS TWIGHLIGHT RACES 19/12 HANDICAP - 1000 metres

Mr. J. Cornell, representing Mr. T. McEvoy, the Trainer of OH GEORGE, advised Stewards Jockey D. Tourneur would be instructed to be more patient and ride the gelding quietly today.

RACE 7: CHRISTMAS TWIGHLIGHT RACES 19/12 HANDICAP - 1000 metres (Cont'd)

The start of this race was delayed approximately three minutes owing to STRAVINSKY CODE proving reluctant to proceed to the barriers. On arrival at the barriers STRAVINSKY CODE was examined by the Club's Veterinary Surgeon and ruled fit to race. Mr. J. Hyam, the Trainer of STRAVINSKY CODE, was advised the gelding would be required to proceed to the barriers without delay in an Official Barrier Trial prior to accepting for a future race.

STRAVINSKY CODE (S. Carr) jumped away awkwardly.

ARDERE (J. Toeroek) reared on jumping away.

MARBLE RYE (J. Cartwright) and MISS WRITTEN (B. Claridge) were slow to begin.

OH GEORGE (D. Tourneur) shifted in on jumping away inconveniencing NORTH BEACH (J. Frew), which was tightened onto ALPHA MAN (S. Cahill).

Correct Weight for this event was delayed to allow A. Herrmann, the rider of the third placegetter SANDHILL FLASH, and that gelding's Trainer, Mr. S. Turner, to view the official footage of the start and also in the straight. After doing so, A. Herrmann lodged an objection against ALABAMA MISSILE (J. Holder) being declared the winner on the grounds of alleged interference from the 350 metres to the winning post. After taking evidence from all parties, on viewing the official footage and acting on their own observations, Stewards *dismissed* A. Hermann's objection.

- D. Tourneur, the rider of OH GEORGE, was questioned regarding his instructions and riding of the gelding in today's event. He explained he had been instructed to attempt to obtain cover, however, the gelding had jumped away extremely well and he had made an assessment that it would be detrimental to attempt to restrain OH GEORGE to comply with the instructions. Stewards confirmed the instructions provided with Mr. T. McEvoy, the Trainer of OH GEORGE, who was satisfied with the options available to and exercised by D. Tourneur.
- S. Carr, the rider of STRAVINSKY CODE, was questioned regarding her use of the whip, striking it on the near hindquarter whilst dismounted when the gelding proved difficult en route to the barriers. She pleaded guilty to a charge under AR137A(3) and was fined \$200.

TUFFENUP PRINCESS lost both front plates during the event.

SPIRIT OF FLATLEY was examined by the Club's Veterinary Surgeon who reported a small cut to the near hind fetlock otherwise no visible abnormalities.

The track was downgraded to Dead 5 at 4.14 pm, retrospective to Race 7.

RACE 8: HOLDFAST INSURANCE BROKERS HANDICAP - 1300 metres

STELLA LANTE, which struck a fence in the mounting enclose, was examined by the Club's Veterinary Surgeon on arrival at the start and ruled fit to race.

NATURAL DISASTER (A. Patterson) was inclined to rear on jumping away.

DOUBLE POCKETS (A. Herrmann) raced three wide without cover throughout the event.

GOLD BUNDLE (T. Baker) raced fiercely in the early and middle stages of the event.

DYLANSON, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9: MAC JUST OVER? JUST DON'T DRIVE HANDICAP - 1300 metres

The start of this race was delayed approximately three minutes owing to a flock of birds having to be removed from the vicinity of the home turn.

SCANTY (D. Tourneur) jumped away awkwardly.

SANDHILL HERO (A. Herrmann) was slow to begin.

Shortly after the start NISHIAZABU (D. Dunn) strode awkwardly, got its head up and struck D. Dunn, who became unbalanced momentarily.

FASTCAR (J. Holder) laid in under pressure in the straight and inside the 100 metres, shifted in and brushed MYSTERY TOUR (S. Cahill).

R. Hurdle, the rider of DEBEERSONUS, accidentally dropped his whip in the vicinity of the 50 metres. R. Hurdle was reprimanded for carelessness in dropping his whip and advised that future instances of carelessness may result in a penalty being imposed.

SANDHILL HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
