**RACE 1 : SPORTINGBET MAIDEN PLATE - 1050 metres**

MAGISUE (O. Ridge) jumped away awkwardly, shifted in and contacted KURTEOUS CAT (J. Kah), which was inconvenienced.

KURTEOUS CAT (J. Kah) laid out from in the vicinity of the 600 metres until the entrance to the straight.

YEN was examined by the Club's Veterinary Surgeon who reported a poor recovery with associated injected mucous membranes.

KURTEOUS CAT was examined by the Club's Veterinary Surgeon who reported a minor laceration to the near corner of the mouth.

**RACE 2 : JIM'S CLEANING THREE-YEAR-OLD FILLIES MAIDEN PLATE - 1100 metres**

ONE PERCENTA (J. Frew) jumped away awkwardly, shifted out and tightened BEAUTIFUL GIRL (J. Kah) onto TEMPTING FAITH (C. Lindop).

INNOVATIVE JILL (B. Shinn) and LILLYFOOT (S. Carr) jumped away awkwardly.

TRINKET LADY (M. Neilson), ONE PERCENTA (J. Frew) and BEAUTIFUL GIRL (J. Kah) raced keenly in the early stages of the event.

In the vicinity of the 700 metres, when the pace slackened, INNOVATIVE JILL (B. Shinn) improved onto the heels of LETHAL LILY (K. Brooks) and TRINKET LADY (M. Neilson) and when being restrained, shifted out abruptly tightening ONE PERCENTA (J. Frew) onto TEMPTING FAITH (C. Lindop), resulting in the hindquarters of TEMPTING FAITH being turned and ONE PERCENTA being hampered for several strides before losing its position. As a consequence BEAUTIFUL GIRL (J. Kah), which was following TEMPTING FAITH, was inconvenienced and obliged to shift wider on the track.

ISLES OF WONDER (B. Claridge) and JUST DEMANDING (A. Herrmann) came together over the concluding stages and made contact on several occasions.

**RACE 2 : JIM'S CLEANING THREE-YEAR-OLD FILLIES MAIDEN PLATE - 1100 metres**  
**(Cont'd)**

When questioned regarding his riding of INNOVATIVE JILL B. Shinn explained he had been instructed to take benefit from his barrier position and allow the filly to settle in a more forward position. He added that Mr. D. Jolly, the Trainer of INNOVATIVE JILL, advised he should avoid exposing the filly too early in the straight. He stated that when the pace slackened in the vicinity of the 700 metres, he became awkward on heels of runners and was obliged to shift out to obtain clear ground. He further stated that after straightening he allowed INNOVATIVE JILL to balance up. He was conscious of his instructions and in his view, in the vicinity of the 200 metres the filly was accidentally struck by the whip of A. Herrmann, the rider of JUST DEMANDING. He added that in the vicinity of the 100 metres he commenced to ride the filly in a vigorous fashion but in his opinion it had already peaked and did not accelerate over the concluding stages. When further questioned regarding his riding style in the straight, B. Shinn explained the manner he rode the filly is consistent with his riding style generally. Mr. D. Jolly, the Trainer of INNOVATIVE JILL, confirmed the instructions provided and made particular reference to the fact the filly only has a short sprint and added he was satisfied with the manner B. Shinn had ridden INNOVATIVE JILL in the straight. B. Shinn's explanation was noted.

**RACE 3 : ATLAS MCNEIL THREE-YEAR-OLD COLTS & GELDINGS MAIDEN PLATE - 1100 metres**

DUBAI (NZ) (T. Baker) and BAY ROAD (J. Toeroek) contacted on jumping away.

DARK IMAGE (S. Cahill) jumped away awkwardly and was slow into stride.

In the vicinity of the 200 metres DUBAI (NZ) (T. Baker) shifted out to improve and crossed the running of TYCOON CHESTER (R. Stewart), which had to be checked. T. Baker pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 27 December 2014 and to conclude at midnight on Saturday, 3 January 2015; a period of four (4) meetings.

**RACE 4 : 'APERITIF' BAR THREE-YEAR-OLD MAIDEN PLATE - 1540 metres**

RENEUTRALIZE (NZ) (B. Shinn), which jumped away awkwardly, was hampered shortly after the start between CUELLEN (T. Pannell) and ATLANTIS (K. Cross), which both jumped away awkwardly and shifted ground.

In the vicinity of the 1200 metres CUELLEN (T. Pannell), which was racing ungenerously, was obliged to be checked and lost its position when racing between RENEUTRALIZE (NZ) (B. Shinn) and MR SHOWDOWN (S. Cahill).

CUELLEN (T. Pannell) laid out rounding the home turn.

EKAMAI PHOM (C. Lindop) was held up for clear running from shortly after entering the straight when racing behind MY HOLLYWOOD (J. Toeroek) and between ATLANTIS (K. Cross) and SELANTE (M. Neilson) and was obliged to alter course to the outside of SELANTE approaching the 200 metres.

RENEUTRALIZE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

VELVET GOLDMINE was examined by the Club's Veterinary Surgeon who reported atrial fibrillation. Mr. G. Searle, the Trainer of VELVET GOLDMINE, was advised the results of an ECG and a Veterinary Certificate of Fitness are to be forwarded to the TRSA Veterinary Surgeon prior to the filly performing satisfactorily in an Official Barrier Trial.

### **RACE 5 : ADELAIDE CASINO MARES 0-68 HANDICAP - 1540 metres**

TIDY PROPHET (T. Pannell) laid in over the concluding stages of the event. TIDY PROPHET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Toeroek, the rider of CARMEN OVER BABY, reported the mare laid in, in the straight.

### **RACE 6 : TDR ELECTRICAL CLASS 1 HANDICAP - 1200 metres**

WILLY THE RABBIT (A. Herrmann) jumped away awkwardly and shifted in, tightening SHELBY APPLES (J. Toeroek) onto GLENYKI (T. Baker).

BRIDGEY FLYER (C. Lindop) was held up for clear running from in the vicinity of the 500 metres to the 400 metres.

Shortly after the entrance to the straight TIMES LIKE THESE (NZ) (M. Neilson), which was inclined to lay out, rolled out and contacted HOSTABLE (R. Hurdle), which shifted in under pressure. Thereafter TIMES LIKE THESE (NZ) laid out in the straight.

ONWARD (J. Frew) and GLENYKI (T. Baker) laid in, in the straight.

SHELBY APPLES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 7 : DRINK DRIVING? GROW UP RATING 0-68 HANDICAP - 2052 metres**

The start of this race was delayed approximately one minute owing to TURRET HILL (NZ) requiring its bridle to be adjusted on arrival at the barriers.

STYRIA'S GEM and SHADY JADE were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

B. Shinn, the rider of PADLOT (IRE), explained the gelding travelled comfortably until in the vicinity of the 800 metres but when asked for an effort, was off the bridle, under pressure and failed to finish the race off in the manner he expected. PADLOT (IRE) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TURRET HILL (NZ) was examined by the Club's Veterinary Surgeon who reported low grade tying up in the hindquarters. First Aid was administered.

### **RACE 8 : 1800 ROOF RAIL RATING 0-68 HANDICAP- 1050 metres**

The start of this race was delayed approximately three minutes owing to MARCO POLO, which lost its off fore plate en route to the barriers, requiring Farrier attention. MARCO POLO was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

WINE LOVER (R. Bell) was slow to begin.

Shortly after the start MARCO POLO (T. Pannell) and ZANDERCAN (J. Matthews) came together and contacted. Shortly thereafter ZANDERCAN got its head up, raced very keenly and was difficult to restrain. Thereafter, in the vicinity of the 700 metres, ZANDERCAN, which had continued to race keenly, was tightened for several strides when racing between SORISAM (J. Maund), which shifted in, and SHISO (J. Toeroek), which rolled out and away from TUFFENUP PRINCESS (S. Cahill), which rolled out marginally.

**RACE 8 : 1800 ROOF RAIL RATING 0-68 HANDICAP- 1050 metres (Cont'd)**

As a consequence SHISO, SORISAM and ZANDERCAN contacted, resulting in the hindquarters of SHISO and SORISAM being turned and ZANDERCAN being severely hampered and checked, losing its position. As a consequence ZANDERCAN clipped the heels of SORISAM and stumbled and OUR BELVOIR (C. Lindop), which was following, had to be steadied. J. Maund was reminded of his obligations when shifting ground in future.

DREAMTIME BABY (T. Baker) laid in, in the straight.

MALUTI was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr. L. Kennewell, the Trainer of MALUTI, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

TUFFENUP PRINCESS was examined by the Club's Veterinary Surgeon who reported a poor respiratory and cardiac recovery. Mrs. H. Lehmann, the Trainer of TUFFENUP PRINCESS, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon together with a Veterinary Certificate of Fitness prior to presenting the mare for a future trial or race. Mrs. Lehmann advised the mare may now be retired.
