RACE 1 : THE NARACOORTE HERALD / SABOIS MAIDEN PLATE - 1430 metres

DOOMSDAY PREPPER (A. Patterson) was very slow to begin.

DERONIMO (E. Finnegan) was slow to begin.

In the vicinity of the 900 metres WHO'S CHARLIE (C. Hall) laid out severely inconveniencing IT'S MARTINI TIME (C. Puls) and LOVE MOSCHINO (A. Herrmann) which were taken wider.

WHO'S CHARLIE (C. Hall) was inclined to lay out severely throughout the event. WHO'S CHARLIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr D. Edwards representing Trainer Ms K. Edwards was advised the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

TARZ, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : NARACOORTE RECYCABLES RATING 0-58 HANDICAP - 1200 metres

Acting on a confirmed telephone conversation with Trainer Mr B. Cerchi that BEAUMARIS had suffered a colic attack; Stewards withdrew BEAUMARIS at 12.36 pm.

BAREMEHTER (E. Finnegan) was slow to begin.

From the vicinity of the 300 metres to the vicinity of the 200 metres CASH AT DAWN (M. Munday) was held up for clear running when racing on the heels of DADDY'S LITTLELADY (A. Herrmann).

DADDY'S LITTLELADY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : NARACOORTE RECYCABLES RATING 0-58 HANDICAP - 1200 metres
(Cont'd)

Approaching the winning post LETMEDOWNGENTLY (C. Puls) was struck on its head accidentally struck on the head by the whip of D. Tourneur, the rider of KIRVIC, on two occasions.

Correct Weight for this event was delayed to allow C. Puls, the rider of the fourth placegetter LETMEDOWNGENTLY and that gelding's Trainer, Ms S. Jaensch, to view the official footage in the straight. After doing so C. Puls lodged an objection against KIRVIC (D. Tourneur) being declared the second placegetter on the grounds on alleged interference from the vicinity of the 30 metres. After considering submissions by the parties, on viewing the official footage and acting on their own observations, Stewards dismissed the protest.

RACE 3 : HANSEN DESIGN & PRINT BENCHMARK 72 HANDICAP - 1200 metres

HASTA LA SHAMER (P. Marks) jumped away awkwardly and shifted in, bumping HENRY'S QUEST (K. Bishop).

STATUE OF GLORY (A. Herrmann) raced keenly in the early and middle stages of the event.

Approaching the 100 metres CELTIC SWALLOW (R. Stewart) was momentarily held up for clear running when racing on the heels of HASTA LA SHAMER (P. Marks) and to the outside of STATUE OF GLORY (A. Herrmann).

CELTIC SWALLOW, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : FINNS FINE FOODS / SABOIS MAIDEN PLATE - 1000 metres

PETA PETA (R. Stewart) stood flat footed and was very slow to begin and as a result trailed the field throughout. PETA PETA was examined by the Club's Veterinary Surgeon who reported the mare to be shin sore. Mr R. Daniel, the Trainer of PETA PETA was advised the mare would now be required to jump away with the field in an Official Barrier Trial or Official Approval Jump Out before next being allowed to start in a race.

FAITH SEEKER (J. Frew) jumped away awkwardly and shifted out bumping ALPHABETIC (K. Bishop).

Shortly after the start DELAGO JACK (C. Puls) was momentarily inconvenienced when PRIME LASS (D. Tourneur) shifted out.

In the vicinity of the 800 metres SPLITENZ (M. Munday) rolled in marginally, momentarily inconveniencing ROMANEE VINCE (NZ) (A. Patterson).

From the vicinity of the 800 metres to the finish HASTA LA DUKE (P. Marks) was inclined to lay out. HASTA LA DUKE was examined by the Club's Veterinary Surgeon who reported speedy cuts to the near hind leg.

RACE 5 : ENVIRO TEC SE RATING 0-68 HANDICAP - 2000 metres

BERNIE'S BOY (C. Hall) and SPRAY TAN (C. Puls) brushed on jumping away,

Approaching the winning post on the first occasion WANNA THRILL (M. Munday) shifted in and away from GREAT MEMORIES (R. Stewart). As a consequence BERNIE'S BOY (C. Hall), which was racing to the inside of GREAT MEMORIES was inconvenienced when taken in. As a result LADY DYSON (K. Bishop), which was following, was momentarily inconvenienced.

RACE 5 : ENVIRO TEC SE RATING 0-68 HANDICAP - 2000 metres (Cont'd)

From approaching the 400 metres to the vicinity of the 250 metres BERNIE'S BOY (C. Hall) was held up for clear running when racing on the heels of BELLE OF THE SOUTH (A. Herrmann).

BERNIE'S BOY (C. Hall) laid in under pressure in the straight.

RACE 6 : MUNRO & GRIGG AUTO REPAIRS RATING 0-68 HANDICAP - 1000 metres

In the vicinity of the 900 metres CASH JOB (A. Herrmann) and ROYAL SPINNER (D. Tourneur) bumped on a number of occasions.

MAGIC NIELLO (E. Finnegan) laid in under pressure in the straight. MAGIC NIELLO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : MCDONALDS NARACOORTE RATING 0-58 HANDICAP - 1430 metres

The start of this event was delayed approximately four minutes when PAM ANN proved difficult to load. The start was further delayed when PAM ANN, READY REX and FRAAR MANDY proved fractious in the barriers. M. Munday was dislodged from READY REX. M. Munday was examined by the First Care Medical Personnel and ruled unfit to fulfil his engagement. READY REX was withdrawn by Stewards at 5.05 pm. Mr D. Dodson, the Trainer of FRAAR MANDY and Ms T. Cottier, the Trainer of READY REX were advised a warning had been placed on their runners with regard to their barrier manners. Mr C. Stewart, the Trainer of PAM ANN was advised a warning had been placed on the mare with regard to it being difficult to load and fractious in the barriers.

NAVAN LASS (A. Doyle) was slow to begin.

NIGHT NEWS (E. Finnegan) laid out rounding the home turn.

RUBYTOO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the mare to have minor lacerations to the near foreleg and over the near eye.

PAM ANN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
