**RACE 1 : TATSBET ADELAIDE CUP 9TH MARCH PLATE - 1000 metres**

INVINCIBLE JULES (D. Tourneur) knuckled severely on jumping away.

SILENT SNIPER (J. Kah) laid out throughout the event. SILENT SNIPER was examined by the Club's Veterinary Surgeon who reported the filly had an elevated heart rate.

D. Tourneur, the rider of INVINCIBLE JULES, explained his instructions were to attempt to obtain cover and despite knuckling severely at the start, he was able to obtain cover shortly thereafter. He stated the filly travelled well until after entering the straight where it appeared reluctant to improve and let down between runners. D. Tourneur added the filly felt normal in its action and breathing but did not finish the race off as expected. INVINCIBLE JULES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : HOLDFAST INSURANCE BROKERS HANDICAP - 1400 metres**

BON ELISE (J. Maund) jumped away awkwardly and was slow into stride.

GOODFUN GIRL (C. Lindop) over-raced in the early stages of the event and in the vicinity of the 700 metres became awkward on the heels of TEAR GAS (NZ) (D. Tourneur) for several strides and had to be steadied.

SOPHISTICATED LASS (J. Cartwright) raced wide without cover throughout the event.

OUR EXCHANGE (J. Toeroek) was held up for clear running for a short distance approaching the 400 metres when racing behind CON NOW (R. Hurdle).

## **RACE 2 : HOLDFAST INSURANCE BROKERS HANDICAP - 1400 metres (cont.)**

When questioned about his riding of SOPHISTICATED LASS, J. Cartwright explained the mare did not travel at any stage during the event and did not feel comfortable in its action, particularly in the straight, and he became concerned with its action and for that reason did not ride SOPHISTICATED LASS out from in the vicinity of the 200 metres. J. Cartwright was reminded of his obligations under AR140(b) in reporting any matter to Stewards as soon as practicable. SOPHISTICATED LASS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TEAR GAS (NZ) and CLAIRWOOD were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : EVRIGHT THREE-YEAR-OLD MAIDEN PLATE - 1300 metres**

On arrival on course DUBAI (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding had a nasal discharge and was unfit to race. Acting on that advice, Stewards withdrew DUBAI (NZ) at 12.14 pm.

In the vicinity of the 1200 metres HADDA COUPLE (C. Robertson) shifted in and tightened MR INQUISITIVE (C. Lindop), which had to be steadied to avoid the heels of YOUDINI (J. Holder). C. Robertson was severely reprimanded and advised to ensure he is sufficiently clear when shifting ground in future.

## **RACE 4 : SPORTINGBET HANDICAP - 1950 metres**

OCSMEPOP (A. Herrmann) and DOTTY KAY (A. Patterson) were slow to begin.

BABY BOY (D. Tourneur) over-raced in the early stages of the event.

GENEROUS BEAU (T. Pannell) laid out in the straight.

BABY BOY (D. Tourneur) which laid in, in the straight, was examined by the Club's Veterinary Surgeon who reported the gelding had an abrasion to its near fore pastern.

DOTTY KAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 5 : SCHWEPPE HANDICAP - 2400 metres**

HALAYR JET was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

MAJESTIC MOMENT (J. Toeroek) was held up for clear running from in the vicinity of the 500 metres until near the entrance to the straight when racing behind HALAYR JET (J. Cartwright) and inside SKY RAIDER (B. Claridge).

T. Pannell, the rider of NISHIAZABU, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

NISHIAZABU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : JAMES BOAG'S PREMIUM HANDICAP - 1300 metres**

REBEL TRUCE (J. Cartwright) laid in approaching the 600 metres and contacted the inside running rail for several strides.

JIMMY THE BUTCH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 7 : EXPRESS COLOUR PRINTING HANDICAP - 1950 metres**

LATE NIGHT DRINK (D. Tourneur) became awkwardly placed on the heels of WICKED TYCOON (S. Carr) for a number of strides near the 1700 metres when that gelding crossed and slackened the pace slightly.

PIERREMONT ROCKS (T. Pannell) raced wide without cover throughout the event.

EXALTED TOBY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 8 : HINDMARSH PLUMBING HANDICAP - 1250 metres**

On jumping away MAGLISSA (C. Lindop) shifted out and brushed with BRINKLEY BLISS (J. Frew), which shifted out and contacted HERENOA (C. Robertson), which was tightened onto RED MAGNET (S. Carr). As a consequence, HERENOA had to be checked and lost its position.

CAPODECINA (J. Cartwright) was slow to begin.

COUNTER SPIN (J. Holder), MAGLISSA (C. Lindop) and HERENOA (C. Robertson) all over-raced in the early stages of the event.

LUCKY ON BLACK (J. Kah) raced wide without cover throughout the event.

C. Robertson, the rider of HERENOA, explained that after receiving interference at the start and losing his position, the gelding balanced up evenly shortly thereafter and he was able to take up a comfortable position in running and whilst the gelding was inclined to over-race slightly, he considered it had settled very well in the run, but thereafter, in the vicinity of the 600 metres, was off the bridle. He added that rounding the home turn he managed to bridle up again and was able to obtain clear running shortly after entering the straight and had every opportunity to finish the event off, however, HERENOA did not quicken in the manner he expected, raced in a dour fashion and in his opinion may be suited to racing over more ground. HERENOA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 9 : DRINK DRIVING? GROW UP HANDICAP - 1000 metres**

BLUE MAGNATE required resaddling on arrival at the barriers.

CASHED (J. Cartwright) jumped away awkwardly.

SOUTHERN SUNDAY (C. Robertson) jumped away awkwardly and thereafter, approaching the 600 metres, became very awkwardly placed on the heels of BLUE MAGNATE (M. Vance) and when being restrained, shifted out abruptly onto CASHED (J. Cartwright), which was taken out onto SPOILSPOT (T. Pannell), resulting in both these horses being hampered when taken wider.

**RACE 9 : DRINK DRIVING? GROW UP HANDICAP - 1000 metres (cont.)**

At the entrance to the straight BLUE MAGNATE (M. Vance) shifted out to improve and brushed with DREAMTIME BABY (J. Toeroek), which was taken wider.

Near the 300 metres SOUTHERN SUNDAY (C. Robertson) was inconvenienced and had to be steadied when BLUE MAGNATE (M. Vance) rolled in. Thereafter SOUTHERN SUNDAY raced very greenly and erratically and shifted ground both ways for some distance in the straight. SOUTHERN SUNDAY was examined by the Club's Veterinary Surgeon who reported the horse to be lame in the off foreleg. Mr. P. Cannon, the Trainer of SOUTHERN SUNDAY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

J. Toeroek, the rider of DREAMTIME BABY, reported the mare laid in, in the straight.

TARCO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DREAMTIME BABY lost its off fore plate and ARDERE lost its near fore plate during the event.

**RACE 4 : SPORTINGBET HANDICAP - 1950 metres**

Mr. R. Daniel, the Trainer of BABY BOY, reported on return to his stable the gelding had filling in its off fore tendon.
