Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 24 December 2014

RACE 1 : MEMBERSHIP TODAY FOR HALF PRICE / SABOIS FILLIES & MARES
MAIDEN PLATE - 1111 metres

Mr. C. Binnie, the Co-Trainer of EVERDEEN, advised Stewards, in an attempt to allow the mare to finish off its race better, he would instruct Jockey T. Pannell to attempt to settle back and get cover in today's event.

On arrival at the barriers the tongue tie on EVERDEEN required adjustment.

WHITE PIRANHA (E. Finnegan) jumped away awkwardly and shifted out and as a result was slow to begin.

From the vicinity of the 400 metres PITCH DARK (K. Bishop) was held up on the heels of COBBY GIRL (B. Claridge) and was obliged to shift out to obtain clear ground in the vicinity of the 300 metres.

JESSIE'S OWN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : MERRY XMAS FROM GBJC / SABOIS DISTANCE MAIDEN PLATE – 2122 metres

FIORISTA (A. Patterson) jumped away awkwardly and as a result was slow to begin.

MARRIED FOR MONEY (R. Stewart) was inclined to rear on jumping away.

TEMPORARY HOME (J. Kah) shifted in on jumping away and brushed with ASPOTON (S. Cahill).

GOTHIC FICTION (T. Pannell) jumped away awkwardly.

From the vicinity of the 700 metres CUTS BOTH WAYS (E. Boyd) commenced to give ground. CUTS BOTH WAYS was examined by the Club's Veterinary Surgeon who reported an abnormal respiratory noise and a slow recovery. Mr. S. Schrader, the Trainer of CUTS BOTH WAYS, was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 2 : MERRY XMAS FROM GBJC / SABOIS DISTANCE MAIDEN PLATE – 2122 metres
(Cont'd)

In the vicinity of the 500 metres ASPOTON (S. Cahill) improved into a tight run between MARRIED FOR MONEY (R. Stewart) and GOTHIC FICTION (T. Pannell) and shifted in and away from MARRIED FOR MONEY, making contact with GOTHIC FICTION, which was unbalanced. As a result DESTINY GOLD (J. Frew), which was following, was obliged to be steadied off the heels of GOTHIC FICTION.

Approaching the 200 metres ASPOTON (S. Cahill) became awkwardly placed inside MARRIED FOR MONEY (R. Stewart) and on the heels of KHAZNEH (E. Finnegan) and was obliged to shift in to obtain clear running.

J. Toeroek, the rider of CHIAZZA, reported the filly had pulled hard in the early stages. CHIAZZA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : FAMILY FUN DAY 7 JANUARY / SABOIS MAIDEN PLATE - 1511 metres

On jumping away SINAWEH (A. Doyle) was tightened between SCOOTER HOOTER (O. Ridge), which shifted in, and DOWNUNDER PRINCE (S. Cahill), which shifted out.

DESERT LADY (B. Claridge) jumped away awkwardly.

SINAWEH (A. Doyle) raced keenly in the early and middle stages of the event.

In the vicinity of the 1100 metres DOWNUNDER PRINCE (S. Cahill) was inclined to get its head up and raced keenly for a short distance.

SCENIC GREY (J. Holder) was inclined to lay in under pressure in the straight.

VASOJEVKA (T. Zanker) raced greenly in the straight.

E. Boyd, the rider of DANISH TEST, reported in her opinion the gelding was making an abnormal respiratory noise. DANISH TEST was examined by the Club's Veterinary Surgeon who reported an abnormal upper respiratory noise. Mr. D. Egan, the Trainer of DANISH TEST, was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SINAWEH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : JACOBS CREEK ST HUGO FOUR-YEARS-OLD & OVER CLASS TWO
HANDICAP - 1714 metres

As the Thoroughbred Identification Card for HEREFORD was not available, Stewards inspected the gelding from their own records. Stewards accepted Trainer Ms. P. Trenwith's, explanation and permitted the gelding to race.

On jumping away KNIGHTLINE (A. Herrmann) became tightened between FLYING CASINO (J. Holder), which shifted in, and CALIGO (B. Claridge), which shifted out.

RED BEGONIA (R. Stewart) raced keenly in the middle stages of the event for some distance.

HEREFORD (A. Patterson) and RED BEGONIA (R. Stewart) laid in under pressure in the straight.

RACE 5 : BUNG FRITZ CUP DAY 21 JANUARY MAIDEN PLATE - 1211 metres

The start of this race was delayed approximately seven minutes owing to JUICY FRUIT, which had become fractious in the mounting yard and contacted the gate on two occasions, resulting in the mare's bridle breaking. The bridle was replaced and on arrival at the barriers JUICY FRUIT was examined by the Club's Veterinary Surgeon who ruled the mare fit to race. Mr. J. Stephens, the Trainer of JUICY FRUIT, was advised a warning had been placed on the mare in relation to its pre-race behaviour.

On jumping away SHADOWS ABOVE (J. Toeroek) became tightened between JUICY FRUIT (J. Kah), which shifted out, and BEL SORBET (J. Holder), which shifted in.

HIGHWAY STAR (J. Matthews) raced keenly in the early stages of the event.

GWYDIR (A. Doyle) raced wide without cover in the middle stages of the event.

In the vicinity of the 300 metres HIGHWAY STAR (J. Matthews) shifted out when insufficiently clear of SCATHACH (M. Vance), making contact with that mare and taking it out onto SHADOWS ABOVE (J. Toeroek), which was tightened onto BEL SORBET (J. Holder). As a result SHADOWS ABOVE was obliged to be checked, losing its position, becoming unbalanced and shifting out, brushing with MOMENTARY SONG (S. Cahill). J. Matthews was found guilty of a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 28 December 2014 and to conclude at midnight on Thursday, 8 January 2015; a period of five (5) meetings.

RACE 6 : COOPERS SPARKLING ALE FOUR-YEARS-OLD & OVER 0-62 HANDICAP - 1211 metres

EXPORT QUALITY (A. Patterson) jumped away awkwardly.

From the entrance to the straight until inside the 200 metres INCANDESCENT (C. Lindop) was held up when racing on the heels of SUPER SILKS (NZ) (E. Finnegan).

EXPORT QUALITY (A. Patterson) was inclined to lay in under pressure from the vicinity of the 150 metres for the remainder of the event.

INCANDESCENT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

A. Herrmann, the rider of ANYTHINGTHATMOVES, reported the gelding was inclined to hang in throughout the event. ANYTHINGTHATMOVES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : TRADIES' DAY FOUR-YEARS-OLD & OVER RATING 0-58 HANDICAP - 1111 metres

No report.

RACE 8 : SPORTSBET FOUR-YEARS-OLD & OVER RATING 0-58 HANDICAP - 1511 metres

SON OF LETO (R. Hurdle) jumped away awkwardly.

1511 metres (Cont'd)**

In the vicinity of the 500 metres RIP APART (A. Herrmann) shifted in, hampering MR BEE GEE (T. Zanker), which was taken in onto CHESTER DOWNS (J. Toeroek). As a result, SOLITARY BIRD (K. Bishop), which was following, was obliged to be eased.

RIP APART (A. Herrmann) was held up for clear ground from the entrance to the straight when racing behind LOUVRE LADY (R. Stewart) and in the vicinity of the 300 metres became awkwardly placed between the heels of LOUVRE LADY and WARRASIDE (A. Patterson) until the vicinity of the 100 metres where WARRASIDE commenced to weaken and rolled out.

J. Frew, the rider of NEHRU, reported the gelding was inclined to hang out throughout the event. NEHRU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MR BEE GEE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct Weight for this event was delayed to allow the Stewards, the Official Starter and R. Hurdle, the rider of SON OF LETO, to review the official footage of the start.
