**RACE 1 : HOLLICK WINES / SABOIS MAIDEN PLATE - 1400 metres**

Shortly after the start DOOMSDAY PREPPER (Z. Spain) was momentarily inconvenienced when BONNY BLONDE (H. McKechnie) shifted out marginally.

BONNY BLONDE (H. McKechnie) raced ungenerously in the early stages of the event.

BARENTS (E. Boyd) was inclined to lay out throughout the event. BARENTS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : WHISTLE POST WINES / SABOIS MAIDEN PLATE - 1700 metres**

IT'S MARTINI TIME (H. McKechnie) laid in under pressure over the concluding stages.

K. Walters, the rider of ZEDKIAH, explained that in her opinion the gelding got its tongue over the bit during the event. ZEDKIAH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CUTS BOTH WAYS and SHE BY DEBEERS, which performed below expectations, were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : BALNAVES OF COONAWARRA / SABOIS MAIDEN PLATE - 1100 metres**

On arrival at the barriers STREAK OF LIGHT required re-saddling.

THE GREEN SASH (C. Jokic), FICKLE TIME (M. Munday), LANDLINE (J. Dertilis) and MAJESTIC RIDGE (C. Jones) were slow to begin.

From the 300 metres to the finish STREAK OF LIGHT (D. Tourneur) was held up for clear running when laying in onto the heels of MAGNUS REWARD (C. Lindop).

**RACE 3 : BALNAVES OF COONAWARRA / SABOIS MAIDEN PLATE - 1100 metres**  
(Cont'd)

STREAK OF LIGHT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Trainer Mr V. Bradley was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 4 : BLOK ESTATE COONAWARRA BENCHMARK 80 HANDICAP - 1100 metres**

MY JESSY (M. Munday) stood flat-footed and was very slow to begin.

C. Jokic, the rider of HALL OF PEACE, reported that in her opinion the mare felt awkward in its action. HALL OF PEACE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : REDMAN WINES RATING 0-62 HANDICAP - 1700 metres**

STEET GLASS (H. McKechnie) was slow to begin.

In the vicinity of the 100 metres LE GRAND ACE (C. Jokic) appeared to dip for no apparent reason.

STREET GLASS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : MAJELLA WINES RATING 0-62 HANDICAP - 1100 metres**

Mr C. Stewart, the Trainer of PORT CHAUVEL and DADDY'S LITTLELADY, put a submission to Stewards that his runners be withdrawn due to the track downgrade. Stewards acceded to this request and withdrew PORT CHAUVEL and DADDY'S LITTLELADY at 12.26 pm.

The start of this event was delayed approximately four minutes owing to SADDLE UP dislodging its rider C. Jones en route to the barriers. SADDLE UP galloped for a considerable distance before being captured. Stewards withdrew SADDLE UP at 4.15 pm. Trainer, Mr M. O' Leary was advised a warning had been placed on the gelding's manners. C. Jones was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

PETREL COVE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : COONAWARRA VIGNERONS CUP - 1700 metres**

SANDHILL CHIEF (A. Herrmann) and RICHARD THE (C. Puls) bumped shortly after the start.

WELCOME NED, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : BOWEN ESTATE RATING 0-68 HANDICAP - 1400 metres**

MR SCHILLER (J. Dertilis) was slow into stride.

**RACE 8 : BOWEN ESTATE RATING 0-68 HANDICAP - 1400 metres (Cont'd)**

Approaching the 100 metres AUTUMN SUNSET (E. Boyd) had to be steadied and lost its position when CREON (C. Jokic) shifted in. C. Jokic was reprimanded and advised to take greater care when shifting ground in future. Shortly thereafter AUTUMN SUNSET shifted out bumping TULLY PLENTY (D. Tourneur) for a short distance.
