STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 10 January 2015

TRACK: Soft 5 (*Downgraded to Soft 6 at 11.15 am*)

WEATHER: Showery

RAIL: Out 3 metres entire circuit.

RACE 1 : SPORTINGBET HANDICAP - 1550 metres

BRINKLEY BREEZE (J. Frew) jumped away awkwardly, shifted out and inconvenienced CUELLEN (T. Pannell).

SELANTE (M. Neilson) jumped away awkwardly.

CUELLEN (T. Pannell) raced wide without cover in the early and middle stages and was inclined to lay out in the vicinity of the 1000 metres.

BLACK CAESAR (J. Cartwright) was inclined to lay out rounding the home turn and then laid in at various stages in the straight.

Inside the 100 metres BLACK CAESAR (J. Cartwright) initially shifted out and away from CHU CHU CHARLIE (D. Tourneur) and thereafter continued to shift out of its own accord and brushed the hindquarters of SELANTE (M. Neilson).

J. Cartwright, the rider of BLACK CAESAR, explained in his opinion the gelding may not have been suited to the step up in distance and appeared reluctant in the underfoot conditions. BLACK CAESAR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. G. Richards, the Trainer of BLACK CAESAR, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

CUELLEN, which commenced to weaken from inside the 600 metres, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : HOLDFAST INSURANCE BROKERS HANDICAP - 1250 metres

CREANCE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ACTION AGAIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: SCHWEPPE'S PLATE - 1000 metres

The start of this race was delayed approximately two minutes owing to LIL DIAMOND proving fractious and difficult to load. Mr. S. Dodd, the Trainer of LIL DIAMOND, was advised the filly would be required to prove it can load without delay in an Approval to Race Jump Out or an Official Barrier Trial prior to accepting for a future race.

SILENT SNIPER (R. Hurdle) shifted out on jumping away and inconvenienced BOUNDARY GIRL (J. Holder).

At the entrance to the straight KARLOVASI (J. Toeroek) shifted out, taking GUNGASTRUCK (J. Kah) wider on the track.

MANHATTAN BLUES (M. Neilson) laid out throughout in the straight.

COMPRENDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TORCHLIGHT, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. In view of the filly's performance, Trainer Mr. M. Whittle was advised TORCHLIGHT would be required to prove competitive in an Official Barrier Trial prior to accepting for a future race.

RACE 4 : JOHN SHANAHAN HANDICAP - 1000 metres

CLAIR (J. Holder) jumped away awkwardly and was then inconvenienced by NOT A SINGLE SHOUT (J. Cartwright), which shifted out.

CLAIR (J. Holder) raced keenly in the early stages of the event.

CAPTAIN PUNCH (J. Toeroek) hung out form in the vicinity of the 500 metres. CAPTAIN PUNCH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Cartwright, the rider of NOT A SINGLE SHOUT, reported in his opinion, the filly was not suited to the track conditions.

CLAIR, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : EXPRESS COLOUR PRINTING HANDICAP - 1250 metres

On arrival at the barriers CON NOW and ATLANTA DREAM required resaddling.

MACCY FIELDS (J. Kah) raced keenly in the early stages, got its head up and raced ungenerously in the vicinity of the 900 metres and became awkwardly placed on the heels of ALABAMA MISSILE (J. Toeroek) for a number of strides.

M. Neilson, the rider of CON NOW, reported the mare never felt comfortable in its action and he became concerned with its action inside the 600 metres when placed under pressure and for that reason he did not ride CON NOW in his normal manner to the finish. CON NOW was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

DUBLE BARREL DAISY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : EXPRESS COLOUR PRINTING HANDICAP - 1250 metres (Cont'd)

ATLANTA DREAM was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Mr. R. Maund, the Trainer of ATLANTA DREAM, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 6 : MITTYS HANDICAP - 1950 metres

The start of this race was delayed approximately two minutes to avoid a clash with an interstate race.

D. Tourneur, the rider of SIX FOOT, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

M. Neilson, the rider of REBELLE, reported the mare was short in its action over the concluding stages. REBELLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : CAMP GALLIPOLI HANDICAP - 1000 metres

Stewards acceded to a request from Ms. K. Johnson, the Trainer of SPOILSPOT, to scratch the gelding owing to the track downgrade and withdrew SPOILSPOT at 12.40 pm.

NORTH BEACH (K. Bishop) jumped away awkwardly.

TRUENO (T. Pannell) jumped away awkwardly. As a consequence A PRIVATE PARTY (C. Jones) shifted out and away from that gelding onto SECRETMENSBUSINESS (R. Stewart), which was inconvenienced when taken out onto ROCK OUT (D. Tourneur), resulting in the hindquarters of ROCK OUT being turned.

TRUENO (T. Pannell) raced in restricted room over the concluding stages between NORTH BEACH (K. Bishop), which rolled out, and A PRIVATE PARTY (C. Jones).

C. Jones, the rider of A PRIVATE PARTY, explained she had been instructed to take up a position back in the field but the gelding began better than expected and as a consequence, while she was still able to settle back of mid-field, she was obliged to race wider than intended and followed TRUENO (T. Pannell) into the straight. She added her preferred option would have been to follow DIGNITARY (M. Neilson) into the straight. A PRIVATE PARTY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SORISAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : TATSBET ADELAIDE CUP 9TH MARCH HANDICAP - 1550 metres

Stewards acceded to a request from Mr. P. Stokes, the Trainer of TENERE, to scratch the gelding owing to the track downgrade and withdrew TENERE at 1.20 pm.

OUR EXCHANGE (J. Toeroek) and RIGHT TO ROAM (B. Claridge) over-raced in the early stages of the event.

RACE 8 : TATSBET ADELAIDE CUP 9TH MARCH HANDICAP - 1550 metres (Cont'd)

R. Stewart, the rider of FLOW METER, reported his mount was inclined to lay out in the straight.

OUR PARADIGM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9 : PETER ELBERG FUNERALS HANDICAP - 1300 metres

Approaching the 1100 metres RED MAGNET (S. Carr) shifted in across the running of GEORDIE'S SECOND (B. Claridge) which, when being steadied, shifted out abruptly onto SAVA NUGGET (NZ) (J. Cartwright), which was hampered when awkwardly placed on that gelding's heels for several strides. S. Carr was severely reprimanded and advised to take greater care when shifting ground in future.

C. Jones, the rider of THE TEN BOB, reported the gelding hung out throughout the event. THE TEN BOB was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

B. Claridge, the rider of GEORDIE'S SECOND, was questioned regarding his riding of the gelding in the straight. He pleaded guilty to a charge under AR137(b) for failing to ride his mount to the finish of the race. In determining penalty, Stewards were satisfied the placings in the event were not affected and consequently fined B. Claridge \$200.

SAVA NUGGET (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL:

RACE 7 : CAMP GALLIPOLI HANDICAP - 1000 metres

Mr. R. Blacker, the Trainer of A PRIVATE PARTY, was questioned regarding his conduct towards one of the Club Veterinary Surgeons following the running of Race 7. He pleaded guilty to a charge under AR175(j) in that his behaviour towards the Official was improper and was reprimanded.
