Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Friday, 9 January 2015

RACE 1 : DEL GIORNO'S CAFÉ RESTAURANT / SABOIS MAIDEN PLATE - 1000 metres

HIGHPAR (B. Hoppo), which was slow into stride and failed to make contact with the field, was eased out in the vicinity of the 800 metres. B. Hoppo reported that he was concerned with the filly's action. HIGHPAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T Haddy, the Trainer of HIGHPAR, was advised the filly would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

ALL KRUPT (S. Carr) jumped away awkwardly.

CRACKERJACK QUEEN (K. Cross) jumped away awkwardly, shifted out and brushed with SUMITEE (R. Bell).

In the early stages of the event FLIGHT OF TERROR (A. Doyle) was inclined to get its head up and raced keenly for a short distance.

RAN WILDE (T. O' Donnell) was inclined to lay in, in the straight.

WHITE JADE (K. Bishop) was inclined to lay in, in the straight. WHITE JADE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Approaching the finish ALL KRUPT (S. Carr) rolled out taking WHITE JADE (K. Bishop) out onto WOTZINTHEBAG (R. Hurdle), which had to be eased off the heels of SUMITEE (R. Bell).

CRACKERJACK QUEEN lost its near fore plate during the event.

CRACKERJACK QUEEN was examined by the Club's Veterinary Surgeon who reported the filly had been galloped on and had a small laceration to the near hind bulb of the heel.

RACE 2 : KEMP REAL ESTATE / SABOIS MAIDEN PLATE - 1390 metres

STRAVINSKA (R. Hurdle) jumped away awkwardly.

JAILBREAK JIMMY (T. Pannell) and MOONLIGHT MADICA (E. Boyd) were slow to begin.

RACE 2 : KEMP REAL ESTATE / SABOIS MAIDEN PLATE - 1390 metres (Cont'd)

J. Kah, the rider of BERNAN PHIA, reported the gelding had not let down and she was concerned with its action in the straight. BERNAN PHIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr J MacMillan, the Trainer of BERNAN PHIA, reported that he would recommend to the gelding's owners that BERNAN PHIA be retired.

RACE 3 : ECO CLEAN RATING 0-68 HANDICAP - 1390 metres

T. O' Donnell, the rider of MUSTANG SCHILLER was dislodged en route to the barriers. T. O'Donnell was examined by the First Care Medical Personnel who passed her fit to ride. MUSTANG SCHILLER was examined by the Club's Veterinary Surgeon on arrival at the barriers who ruled the gelding fit to race.

The start of this event was delayed approximately three minutes owing to DOUBLE FIVE refusing to load. Stewards withdrew the gelding at 3.43 pm. Mr D McMahon, the Trainer of DOUBLE FIVE, was advised that the gelding would be required to load to the satisfaction of Stewards in an Official Barrier Trial or Approval Jump Out prior to accepting for a future race. The start was further delayed by two minutes owing to FREIGHT QUEEN becoming fractious in the barriers. FREIGHT QUEEN was examined by the Club's Veterinary Surgeon who ruled the mare unfit to race. Acting on that advice Stewards withdrew FREIGHT QUEEN at 3.45 pm.

MUSTANG SCHILLER (T. O' Donnell) and HERO TO VILLIAN (A. Doyle) were slow to begin.

THE HEADLINER (B. Claridge) was inclined to get its head up and race keenly in the middle stages of the event.

In the vicinity of the 50 metres HERO TO VILLIAN (A. Doyle) became tightened between THE HEADLINER (B. Claridge), which shifted out at the same time as LADY PHOENIX (K. Bishop) shifted in. As a result HERO TO VILLIAN was forced to check and lost its position. B. Claridge, pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 18 January and to conclude at midnight on Sunday, 25 January 2015: a period of four (4) meetings. K. Bishop pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 14 January and to conclude at midnight on Friday, 23 January 2015: a period of four (4) meetings.

Correct Weight for this event was delayed to allow A. Doyle, the rider of the fourth placegetter HERO TO VILLIAN and the gelding's Trainer Mrs A. Harder, to view the official vision in the straight. After doing so A. Doyle lodged an objection against THE HEADLINER (B. Claridge) being declared the second placegetter on the grounds of alleged interference from the 50 metres to the finish. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

RACE 4: MGA INSURANCE RATING 0-68 HANDICAP - 1390 metres

WINE LOVER (K. Bishop) was slow to begin.

FORESHORE MAK (S. Carr) and VOODOO BLACK MAGIC (A. Herrmann) came together and brushed on jumping away.

WINE LOVER (K. Bishop) raced keenly in the early stages of the event.

In the vicinity of the 200 metres CAPTAIN PERCY (S. Westover) dipped for no apparent reason.

RACE 4: MGA INSURANCE RATING 0-68 HANDICAP - 1390 metres (Cont'd)

E. Boyd, the rider of JUST PURE FUN, reported the mare was off the bridle in the vicinity of the 800 metres and had not finished the event off as she had expected. JUST PURE FUN was examined by the Club's Veterinary Surgeon who reported a superficial laceration to the off hind fetlock.

RACE 5: PORT LINCOLN REAL ESTATE BENCHMARK 80 HANDICAP - 1750 metres

The start of this event was delayed approximately three minutes owing to SOUTHERN ALLIANCE refusing to load. SOUTHERN ALLIANCE was withdrawn by Stewards at 5.02 pm. Mr S. Drewitt, the Trainer of SOUTHERN ALLIANCE, was advised the gelding would be required to load to the satisfaction of Stewards in an Official Barrier Trial or Approval Jump Out prior to accepting for a future race.

MOON DEVIL (B. Claridge) was slow to begin.

B. Claridge, the rider of MOON DEVIL, explained that he intended to lead today's event but had not been able to do so being slow to begin.

ALERT THE WORLD was examined by the Club's Veterinary Surgeon who reported the mare to be mildly dehydrated.

RACE 6: T & S COMMERCIAL REAL ESTATE RATING 0-62 HANDICAP - 1210 metres

JESTWIN, which was fractious in the mounting yard prior to this event, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

EASY MISS (T. O' Donnell) jumped away awkwardly and shifted in making contact with KAMPKOOKER (J. Kah).

ATOMIC HERO (K. Bishop) and MANUM PE I (R. Hurdle) came together and brushed on jumping away.

NANNA KNOWS BEST (B. Claridge) jumped away awkwardly.

EASY MISS (T. O' Donnell) raced greenly in the early stages of the event.

B. Claridge, the rider of NANNA KNOWS BEST, reported the mare had not travelled throughout the event and he was concerned with its action in the straight. NANNA KNOWS BEST was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: RSM BIRD CAMERON CHARTERED ACCOUNTANTS RATING 0-62 HANDICAP - 1210 metres

The start of this event was delayed approximately one minute owing to the bridle on MURTAJACK being re-adjusted on arrival at the barriers.

VALIK (R. Hurdle) jumped away awkwardly and shifted in, bumping with MURTAJACK (D. Tootell). As a result VALIK shifted back out at the same time as GLENROSS (J. Kah), which had jumped away awkwardly, shifted in, resulting in VALIK becoming tightened and losing its position.

HEZAFRAAR (T. Pannell) shifted in on jumping away and hampered SWEET NEVER (T. O' Donnell).

RACE 7: RSM BIRD CAMERON CHARTERED ACCOUNTANTS RATING 0-62 HANDICAP - 1210 metres (Cont'd)

Shortly after the start DON'T CALL ME MISS (K. Bishop) dipped for no apparent reason.

HE'LL TELL US (E. Boyd) travelled wide without cover throughout the event.

From the 200 metres LAMU LAD (S. Carr) was held up when attempting a tight turn between VINARD (A. Herrmann) and LEWIS STREET (A. Doyle) and in the vicinity of the 100 metres was obliged to shift out across the heels of VINARD to obtain clear running.

In the vicinity of the 100 metres LEWIS STREET (A. Doyle) shifted out abruptly for no apparent reason.

GLENROSS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : DEMPSEY'S SADDLERY & FEED SUPPLIES BENCHMARK 80 HANDICAP - 1210 metres

SPIRIT OF FLATLEY (A. Doyle) jumped away awkwardly.

In the vicinity of the 1100 metres SPIRIT OF FLATLEY (A. Doyle), which was racing keenly, rolled out taking HANK'S NEPHEW (T. O' Donnell) out onto EXTRACEED (Z. Spain), which became tightened onto BLACK BARRA (B. Claridge). As a result EXTRACEED became unbalanced for a short distance.

SPIRIT OF FLATLEY (A. Doyle) continued to race keenly for a short distance during the middle stages of the event.

BLACK BARRA (B. Claridge) raced wide without cover throughout the event.

In the vicinity of the 400 metres ACHENAR (S. Westover) dipped for no apparent reason.

In the vicinity of the 200 metres HANK'S NEPHEW (T. O' Donnell) became disappointed for a run between the heels of BLACK BARRA (B. Claridge) and SPIRIT OF FLATLEY (A. Doyle) and was obliged to shift out across the heels of BLACK BARRA to obtain clear running.

RACE 9: TWILIGHT TUNARAMA FAMILY DAY RATING 0-62 HANDICAP - 1000 metres

On arrival at the barriers, S. Westover, the rider of GOLD VINTAGE, reported he was concerned with the gelding's action. GOLD VINTAGE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

On arrival at the barriers MY BOY BRANDO required re-saddling.

FATHER TONY (A. Herrmann) and BUDDY FANTASTIC (T. Pannell) made contact on jumping away. As a result BUDDY FANTASTIC lost its position.

SON OF A GUN (A. Doyle) jumped away awkwardly.

SON OF A GUN (A. Doyle) was tightened between SLIDE OF HAND (S. Carr) and MY BOY BRANDO (B. Hoppo) on jumping away.

GOOD CONTACT (K. Bishop) raced keenly in the early stages of the event.

SON OF A GUN (A. Doyle) raced ungenerously in the early and middle stages of the event.

BELUGA GOLD (E. Boyd) was inclined to lay out in the straight.
