THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 24 January 2015

TRACK: Good 4 (Upgraded to Good 3 at 1.15 pm, retrospective to Race 2)

WEATHER: Fine

RAIL: Out 6 metres 1000m to Winning Post including 1400 metre Chute, 3 metres

RACE 1: PROGRAMMED MAINTENANCE HANDICAP - 1950 metres

CARAJILLO, which contacted the perimeter fence on leaving the mounting yard, was examined by the Club's Veterinary Surgeon on arrival at the barriers, who reported the filly had sustained a laceration to the off side hip. CARAJILLO was ruled unfit to race. Acting on that advice, CARAJILLO was withdrawn by Stewards at 12.33 pm.

AFFENDI (J. Holder) made the crossing in the vicinity of the 1700 metres awkwardly.

SELANTE (M. Neilson), which was eased out of the event approaching the 100 metres, was examined by the Club's Veterinary Surgeon who reported an abnormal upper respiratory noise. M. Neilson reported the filly, in his opinion, had breathing difficulties during the run and for that reason he had elected not to ride it out to the finish. Mr. T. McEvoy, the Trainer of SELANTE, was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 2: TATTSBET ADELAIDE CUP 9TH MARCH HANDICAP - 1400 metres

BLACK CAESAR, which contacted the inside running rail of the course proper en route to the start, was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

ALPINE EAGLE (M. Neilson) jumped away awkwardly.

BLACK CAESAR lost its off hind plate during the event.

J. Cartwright, the rider of BLACK CAESAR, reported the gelding felt flat and did not respond to his riding as he expected. BLACK CAESAR was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

SKELLIG was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following the running of this race, the track was upgraded to a Good 3 at 1.15 pm, retrospective to Race 2.

RACE 3: JAMES BOAG'S PREMIUM TWO-YEAR-OLD PLATE - 1000 metres

BEAUTIFUL FLYER (J. Potter) stood flat-footed, jumped away awkwardly and lost many lengths. BEAUTIFUL FLYER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr L. Jarvis, the Trainer of BEAUTIFUL FLYER, was advised the filly would be required to jump on terms with the field in an Official Barrier Trial prior to accepting for a future race.

BILZERIAN (T. Pannell) hung out from in the vicinity of the 700 metres until the entrance to the straight.

CERTAIN ELLIE (A. Creighton) raced greenly in the straight and rolled about over the concluding stages.

Correct Weight for this event was delayed to allow J. Holder, the rider of ABU DHABI, and D. Tourneur, the rider of ONE FOR ONE, to view the official vision over the concluding stages.

Correct Weight was further delayed when M. Neilson, the rider of STOKER, who felt unwell and dismounted on pulling up, had to be examined by the First Care medical staff. M. Neilson was ruled fit to fulfil his remaining engagements.

LAKE JACKSON and STOKER were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : SPORTINGBET HANDICAP - 1250 metres

MARBLE RYE (T. Pannell) jumped away awkwardly, shifted out and contacted GAMBLIN' GURU (J. Holder), which became severely unbalanced.

In the vicinity of the 1000 metres HANK'S NEPHEW (R. Hurdle) rolled out and inconvenienced MARBLE RYE (T. Pannell).

HANK'S NEPHEW (R. Hurdle) was held up for clear running from the entrance to the straight until near the 200 metres.

Approaching the 200 metres KILL BILL (D. Tourneur) shifted in at the same time as HANK'S NEPHEW (R. Hurdle) shifted out, resulting in BUDRIGUEZ (J. Cartwright), which was weakening, being tightened and hampered. D. Tourneur and R. Hurdle were reminded of their obligations when shifting ground in future.

GAMBLIN' GURU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BUDRIGUEZ was examined by the Club's Veterinary Surgeon who reported a laceration above the gelding's near fore knee. First Aid was administered.

RACE 5 : SCHWEPPES THREE-YEAR-OLD MAIDEN PLATE - 1250 metres

TORI'S GIFT (J. Holder) was slow to begin.

COOBER'S RUN (C. Lindop) raced wide without cover throughout the event.

MISTER TEEJAY (M. Vance) raced greenly in the straight and in the vicinity of the 50 metres shifted in under riding and crossed the running of TRENTPARK (J. Kah), which had to be steadied. M. Vance was severely reprimanded and advised to take greater care when her mounts commence to shift ground in future.

RACE 5 : SCHWEPPES THREE-YEAR-OLD MAIDEN PLATE - 1250 metres (Cont'd)

L. Meech, the rider of LENNY'S HOPE, explained in her opinion, the colt may be better suited to racing over slightly more ground. LENNY'S HOPE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: MARSH PTY LTD HANDICAP - 1950 metres

The start of this event was delayed approximately four minutes owing to BALLYPATRICK proving very difficult to load. After being loaded on the first occasion BALLYPATRICK got one of its hind legs up in the barrier stalls, had to be removed and examined by the Club's Veterinary Surgeon who ruled it fit to race. Thereafter BALLYPATRICK again proved difficult to load. Mr. S. Padman, the Trainer of BALLYPATRICK, was advised that in view of the gelding's history and behaviour, it is now stood down to either an Official Barrier Trial or an Approval to Race Jump Out during which it must prove tractable prior to accepting for a future race.

RIGHT TO ROAM (M. Neilson) raced keenly in the early stages of the event.

BALLYPATRICK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : SOCIAL EVENTS @ MORPHETTVILLE HANDICAP - 1000 metres

The start of this event was delayed approximately two minutes owing to M. Vance, the rider of RED MAGNET, being dislodged shortly after the gelding entered the course proper. M. Vance was examined by the First Care medical staff and passed fit to ride and RED MAGNET was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

COSMIC KHELEYF (R. Hurdle) jumped away awkwardly, shifted out and contacted the hindquarters of COOL MAVERICK (C. Lindop). Thereafter COSMIC KHELEYF was slow into stride.

In the vicinity of the 400 metres DIGNITARY (M. Neilson) shifted out to improve, taking COOL MAVERICK (C. Lindop) wider, and shortly thereafter COOL MAVERICK became unbalanced, shifted in and became awkward on the heels of DIGNITARY for a number of strides.

RACE 8: DRINK DRIVING? GROW UP HANDICAP - 1400 metres

The start of this event was delayed approximately two minutes owing to an adjustment required to the noseroll fitted to CREANCE.

MAHICAN (L. Meech) bucked for a short distance after the start. Mr. P. Moody, the Trainer of MAHICAN, was advised that in view of the gelding's racing manners, it would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race. As a consequence of this gelding bucking in the early stages, the saddle slipped back slightly during running, placing L. Meech at a disadvantage. L. Meech advised, as a consequence, she was obliged to settle further back than intended.

J. Holder, the rider of IT AND A BIT, reported that as a consequence of being awkward and slow to begin he was unable to take up a more forward position as intended.

Correct Weight for this event was delayed to allow Stewards to review the vision of the start in relation to IT AND A BIT (J. Holder) being awkward and slow to begin.

RACE 8: DRINK DRIVING? GROW UP HANDICAP - 1400 metres (Cont'd)

J. Kah, the rider of KING'S PARDON, reported the gelding felt sore during the event. KING'S PARDON was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Ms. M. Smith, the Trainer of KING'S PARDON, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

MAHICAN and CREANCE were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9: PETER ELBERG FUNERALS HANDICAP - 1300 metres

On arrival at the barriers it was established that MARCO POLO had lost its off fore plate, requiring the attention of the Farrier. MARCO POLO was examined by the Club's Veterinary Surgeon and ruled fit to race.

ST FRASER (K. Bishop) raced wide without cover in the early and middle stages.

HOUSE OF WAX lost its near fore plate during the running of the event.

ROUSSANNE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Race 1 – SELANTE – Not to Race – Results of endoscopic examination and Veterinary Certificate of Fitness required prior to trial or race – Upper respiratory noise.

Race 3 – BEAUTIFUL FLYER – Suspended – Must jump on terms in an Official Barrier Trial – Stood flat-footed and lost many lengths at start.

Race 6 – BALLYPATRICK – Suspended – Must prove tractable during Official Barrier Trial or Approval to Race Jump Out – Very difficult to load.

Race 8 - KING'S PARDON - Not to race - Vet Certificate of Fitness required prior to trial or race - Lame off foreleg

Race 8 - MAHICAN - Suspended - Required to perform tractably in Official Barrier Trial - Bucked after the start
