RACE 1 : BARRETT PETROLEUM / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE
- 1000 metres

The start of this event was delayed approximately one minute owing to NIKKI NIKKI NOO being examined by the Club's Veterinary Surgeon as the rider was concerned with the mare's action en route to the barriers and was passed fit to race.

VALENTINIAN (USA) (C. Lindop) jumped away awkwardly and shifted out onto GODDESS OF FORTUNE (E. Creighton), which lost its position as IRANDASNIP (C. Hall) jumped away awkwardly and shifted out.

IRANDASNIP (C. Hall) was held up for clear running from inside the 400 metres until inside the 100 metres when racing on the heels of GOT THE MUNCHIES (A. Doyle), which was inclined to lay in.

At the entrance to the straight SAGNAN SAINT (D. Tourneur) shifted in and away from NIKKI NIKKI NOO (H. McKechnie), which improved to its outside bumping GOT THE MUNCHIES (A. Doyle).

A. Doyle, the rider of GOT THE MUNCHIES, reported that his mount was inclined to lay in throughout the event. GOT THE MUNCHIES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : CAPPAMOTORS BODIES / SABOIS MAIDEN PLATE - 1430 metres

THE GREEN SASH (A. Creighton) was slow to begin.

In the vicinity of the 300 metres HASTA LA THOMAS (M. Munday) improved onto the heels of KICK ME NOT (E. Finnegan) and had to be restrained for a number of strides.

RACE 2 : CAPPA MOTORS BODIES / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)

Inside the 100 metres EMCEECEE (D. Tourneur) rolled in onto WHO'S CHARLIE (J. Frew), which was taken in onto KICK ME NOT (E. Finnegan), which was obliged to be eased for a number of strides when tightened onto HASTA LA THOMAS (M. Munday). D. Tourneur was reminded of his obligations when shifting ground in future.

RACE 3 : COOPERS CLEAR RATING 0-62 HANDICAP - 1200 metres

ON THE REBOUND (Z. Sapin) raced wide without cover throughout the event.

E. Finnegan, the rider of TONS OF DASH, explained that the gelding failed to muster any early speed, however, travelled well in the middle stages of the event and finished the race off strongly. She added that TONS OF DASH would benefit from races over a further distance. TONS OF DASH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MONDAY'S EXPERT, which performed below expectation, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : TOLL BENCHMARK 80 HANDICAP - 1200 metres

KILL BILL (B. Claridge) over-raced in the early and middle stages of the event.

CONIDEL, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MY WAY was examined by the Club's Veterinary Surgeon who reported an injury to the near fore flexor tendon. Ms S. Murphy, the Trainer of MY WAY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race. Ms S. Murphy advised Stewards that she would recommend to the owners to retire the gelding.

Correct Weight for this event was delayed to allow M. Munday, the rider of the fourth placegetter, CONSOLIDATED GLASS, to view the official photo for third place.

RACE 5 : MIDFIELD MEATS RATING 0-68 HANDICAP - 1000 metres

The start of this event was delayed approximately one minute owing to LAGELLO being examined by the Club's Veterinary Surgeon as the rider was concerned with its action en route to the barriers and was passed fit to race.

LAGELLO (E. Creighton) was slow to begin.

SHISO (E. Finnegan) jumped away awkwardly.

In the vicinity of the 200 metres SNOW JEWEL (H. McKechnie) shifted out and bumped HALF A HERO (C. Lindop), shortly thereafter HALF A HERO was obliged to be steadied as SNOW JEWEL continued to shift out. H. McKechnie was reminded of her obligations when shifting ground in future.

SHE'S ON FIRE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : MIDFIELD MEATS RATING 0-68 HANDICAP - 1000 metres (Cont'd)

LAGELLO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the mare had sustained an injury to the near fore flexor tendon. Mr R. Daniel, the Trainer of LAGELLO, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 6 : MARANA PARK RATING 0-62 HANDICAP - 2000 metres

WHAT A SAGA (A. Herrmann) was slow to begin.

LETMEDOWNGENTLY (C. Puls) over-raced in the early and middle stages of the event.

MUSEE D'MODEL (D. Tourneur) was held up for clear running from approaching the 400 metres until in the vicinity of the 200 metres when racing behind HENDY (J. Potter) and to the inside of most awesome (C. Jones).

ARRAWANOOO, performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : MINI JUMBUK NARACOORTE CUP - 2000 metres

PUZZLEMAN (K. Cross) jumped away awkwardly and shifted out onto RICHARD THE (C. Puls).

BALLYPATRICK (K. Bishop) was slow to begin.

RACE 8 : SOUTH EAST MOTOR CO RATING 0-68 HANDICAP - 1430 metres

WHERE'S PINO (J. Potter) was slow to begin.

RACE 1 : BARRETT PETROLEUM / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1000 metres

Following the running of Race 1, Stewards questioned Jockey P. Marks, in relation to samples he provided when requested prior to the event. Having regard for the circumstances and the explanation provided, Stewards determined that P. Marks be stood down from his remaining engagements on the day. P. Marks was advised that an inquiry into the circumstances surrounding the samples he provided, would be conducted at a date and time to be determined.
