Report on Race Meeting held at Kingscote Racecourse
by Kangaroo Island Racing Club on Friday, 13 February 2015

RACE 1: ISLAND PURE SHEEP DAIRY / SABOIS MAIDEN PLATE - 1008 metres

SHOW SET (A. Doyle) jumped away awkwardly and shifted out bumping ARWA (K. Bishop).

In the vicinity of the 800 metres ARWA (K. Bishop) shifted in when insufficiently clear of NOTORIOUS PRINCESS (R. Bell), which was taken in onto COCOMACOQUE (R. Hurdle), which was obliged to be checked and lose its position. K. Bishop pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period of five (5) meetings to be served cumulatively with the suspension she received at an adjourned inquiry at the TRSA offices on Monday, 9 February 2015 following an incident at the Port Lincoln race meeting on 31 December 2014. As a result her suspension will commence at midnight on Wednesday, 11 March and to conclude at midnight on Sunday, 21 March 2015.

SWINGITLIKESAYERS, which was inclined to lay in, in the straight, was examined by the Club's Veterinary Surgeon who reported the colt to be lame in the near foreleg. Mr K. Healy, the Trainer of SWINGITLIKESAYERS was advised a Veterinary Certificate of Fitness would be required prior to presenting the colt for a future trial or race.

RACE 2: CALTEX TURNER FUEL SUPPLIERS / SABOIS MAIDEN PLATE – 1360 metres

ALL THE TIME (A. Doyle) was slow to begin.

In the vicinity of the 100 metres GOLD TILLIE (R. Hurdle) shifted in when insufficiently clear of LADY CHORA (J. Potter), which was obliged to be steadied and lose its position when tightened onto LAMENTABLE (Z. Spain). R. Hurdle pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Wednesday, 18 February and to conclude at midnight on Sunday, 22 February 2015: a period of three (3) meetings.

Approaching the finish ALL THE TIME (A. Doyle) was obliged to be steadied when PIERREMONT MAGIC (K. Bishop) rolled in at the same time as LADY CHORA (J. Potter) shifted out.

**RACE 3: JOHN & CLARA ONGLEY GOLDEN WEDDING ANNIVERSARY RATING 0-58
HANDICAP - 1880 metres**

In the vicinity of the 250 metres CROSS CONSTANCE (E. Finnegan) shifted out when insufficiently clear of FRANK THE RIPPER (J. Matthews), which was obliged to be checked and lose its position when tightened onto PHOENIX EAGLE (NZ) (S. Price). E. Finnegan was found guilty of a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 21 February and to conclude at midnight on Sunday, 1 March 2015: a period of four (4) meetings.

PHOENIX EAGLE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: DUDLEY WINES BENCHMARK 80 HANDICAP - 1750 metres

NOMIS (NZ), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr G. Carter, the Trainer of NOMIS (NZ) was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 5: COCA-COLA JIM BEAN RATING 0-58 HANDICAP – 1360 metres

ATOMIC HERO (K. Bishop) was held up for clear running from in the vicinity of the 400 metres until approaching the 100 metres when racing on the heels of MALEBO MAGIC (M. Vance) and ALPHA MATE (J. Potter), which was inclined to roll about.

FANTASTIC REIGN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DEFONET which was pulled up shortly after crossing the finish line by its rider, E. Finnegan, was examined by the Club's Veterinary Surgeon who reported the gelding to have sustained a dislocation to the front fetlock. DEFONET was humanely euthanased.

RACE 6: MAXWELL COOPER MEMORIAL RATING 0-68 HANDICAP - 1008 metres

The start of this event was delayed approximately one minute owing to a power outage on course.

GOOD CONDUCT (K. Bishop) jumped away awkwardly and shifted out onto SLIDE OF HAND (Z. Spain), which was tightened onto HE'S NO SLOUCH (R. Bell), which also jumped away awkwardly and shifted in.

SAMZERO (R. Hurdle) jumped away awkwardly.

Shortly after the start LIL' STORM QUEEN (M. Vance), which had jumped away awkwardly, shifted in contacting PIXIU (K. Cross), taking that gelding in onto AIR COMET (J. Potter), which was tightened onto KING RODNEY (A. Herrmann) at the same times as HE'S NO SLOUCH (R. Bell) rolled out marginally. As a result AIR COMET lost its position.

SLIDE OF HAND (Z. Spain) raced keenly in the early and middle stages of the event.

KING RODNEY (A. Herrmann) was inclined to lay in under pressure in the straight.

SLIDE OF HAND (Z. Spain) was inclined to hang out under pressure in the straight. SLIDE OF HAND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: SEALINK RATING 0-62 HANDICAP - 1215 metres

KOODA DAWN (K. Bishop) jumped away awkwardly and shifted out onto ALERTNESS (R. Bell), which was tightened onto RED MENACE (A. Herrmann). As a result ALERTNESS lost its position.

KALO TAXITHI (E. Boyd) jumped away awkwardly.

In the vicinity of the 200 metres AKBAR MAHAL (Z. Spain) shifted out to improve around the heels of ONTHEROAD FOR GOLD (K. Brooks) and in doing so momentarily inconvenienced KOODA DAWN (K. Bishop).
