Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 14 February 2015

TRACK: Good 4 (Upgraded to Good 3 at 3.38 pm retrospective to Race 5)

WEATHER: Fine/Hot

RAIL: Out 9 metres 1200m to 600m, 5 metres remainder.

RACE 1: WILLIAM HILL HANDICAP - 2600 metres

WALTZING TO WIN (B. Claridge) jumped away awkwardly.

TOO COOL TO FOOL (NZ) (C. Lindop) raced keenly in the early stages of the event.

CALIGO, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: ADELAIDE GALVANISING HANDICAP - 1100 metres

VATICAN (S. Carr) stepped a section of the track in the vicinity of the 150 metres and became awkward in its action momentarily.

RACE 3: SCHWEPPES HANDICAP - 1050 metres

I AM GYPSY (M. Vance) was inclined to rear on jumping away and began awkwardly.

I AM GYPSY (M. Vance) was inclined to lay out over the concluding 600 metres.

TORI'S GIFT (S. Carr) laid in under pressure in the straight. TORI'S GIFT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JUST KAPPY was examined by the Club's Veterinary Surgeon who reported the gelding to be showing signs of heat stress. First Aid was administered.

RACE 4: TATTSBET ADELAIDE CUP 9TH MARCH HANDICAP - 1200 metres

MOLLY THE SNIP (R. Hurdle) shifted in on jumping away, inconveniencing ATLANTA DREAM (E. Finnegan).

MOLLY THE SNIP (R. Hurdle) raced keenly in the early stages of the event.

RACE 4: TATTSBET ADELAIDE CUP 9TH MARCH HANDICAP - 1200 metres (Cont'd)

Approaching the 200 metres SHELBY APPLES (J. Toeroek) was disappointed when attempting a tight run between MOLLY THE SNIP (R. Hurdle) and FLIRTATIOUS DREAM (M. Neilson), which rolled in slightly, resulting in SHELBY APPLES having difficulty obtaining clear ground for the remainder of the event.

J. Toeroek, the rider of SHELBY APPLES, reported that in his opinion the mare felt sore over the concluding stages and on pulling up. SHELBY APPLES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : DRINK DRIVING? GROW UP HANDICAP - 1600 metres

MR WONDERFUL (J. Cartwright) and CUPSTER (E. Finnegan) jumped away awkwardly.

OCTOBER DATE (S. Price) shifted in on jumping away and brushed ARTFUL MONTY (J. Toeroek).

ALPINE EAGLE (M. Neilson) and ARTFUL MONTY (J. Toeroek) raced keenly in the early stages of the event.

From the vicinity of the 500 metres until the entrance to the straight OCTOBER DATE (S. Price) was held up when racing behind LUCKSA (C. Lindop) and inside ALPINE EAGLE (M. Neilson).

Shortly after entering the straight BETTY BUTTERSCOTCH (D. Yendall) became awkwardly placed on the heels of ARTFUL MONTY (J. Toeroek) and was unable to obtain clear ground until inside the 300 metres.

- J. Childs, the rider of PURREAL which performed below expectations, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 500 metres, failed to respond to his riding and finished the event off poorly. PURREAL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- J. Cartwright, the rider of MR WONDERFUL which performed below expectations, explained the gelding had not travelled well throughout the event and in his opinion had raced flat. MR WONDERFUL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CUPSTER was examined by the Club's Veterinary Surgeon who reported the filly was showing signs of heat stress. First Aid was administered.

RACE 6 : SOCIAL EVENTS @ MORPHETTVILLE HANDICAP - 1600 metres

LIGHTNING DREW (J. Holder) shifted in on jumping away and bumped CAPODECINA (A. Herrmann).

In the vicinity of the 800 metres CAPODECINA (A. Herrmann) rolled out slightly onto DUMOSA (E. Finnegan), which shifted out and away, inconveniencing INSUPERABLE (NZ) (J. Toeroek), which was taken wider on the track.

Approaching the 200 metres WARATOR (M. Neilson) and INSUPERABLE (NZ) came together and brushed, resulting in INSUPERABLE (NZ) shifting out, brushing the hindquarters of VIKING STAR (C. Lindop) and turning that gelding in momentarily.

RACE 6 : SOCIAL EVENTS @ MORPHETTVILLE HANDICAP - 1600 metres (Cont'd)

- C. Lindop, the rider of VIKING STAR, dismounted from that gelding on pulling up as she was concerned with its action. VIKING STAR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. First Aid was administered. Mr. L. Macdonald and Mr. A. Gluyas, the Co-trainers of VIKING STAR, were advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
- J. Holder, the rider of LIGHTNING DREW which performed below expectations, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 400 metres, failed to respond to his riding and finished the event off poorly. LIGHTNING DREW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: HOLDFAST INSURANCE BIRTHDAY CUP HANDICAP - 2032 metres

SKY RAIDER, which struck a perimeter fence on leaving the mounting yard, was examined on arrival at the start by the Club's Veterinary Surgeon and ruled fit to race.

PRETTY BLONDE (J. Potter) and LUCKY LUCKY LUCKY (J. Holder) were slow to begin.

From the entrance to the straight until the vicinity of the 100 metres STIMULATTE (J. Cartwright) had difficulty obtaining clear ground when awkwardly placed between the heels of VIMA (D. Yendall) and GENEROUS BEAU (T. Pannell).

DYLANSON (C. Lindop) laid in under pressure over the concluding 100 metres, resulting in C. Lindop having to stop riding and straighten on a number of occasions.

B. Claridge, the rider of SKY RAIDER, reported the gelding did not feel comfortable in its action over the concluding stages. SKY RAIDER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DYLANSON and GENEROUS BEAU were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: NUTURF HANDICAP - 1200 metres

CRUZIERO was withdrawn by Stewards at 7.46 am owing to that gelding's Trainer Mr. K Healy failing to scratch by the required time. After considering his explanation, Mr Healy was fined \$200 under LR19.1.

STRAVINSKY CODE (S. Carr) jumped away awkwardly, got its head up for a number of strides and shifted in onto COUNTER SPIN (E. Finnegan), which was inconvenienced.

From the entrance to the straight DR DAPPER (C. Lindop) was unable to obtain clear ground when racing behind ZANDERCAN (J. Matthews) and inside COOL MAVERICK (C. Jones) and approaching the 100 metres improved into a tight run to the outside of ZANDERCAN, which rolled out, resulting in DR DAPPER being taken out and brushing COOL MAVERICK on a number of occasions in the vicinity of the 100 metres.

S. Carr, the rider of STRAVINSKY CODE, reported that after jumping away awkwardly the gelding had only travelled fairly in the early stages and when placed under pressure in the vicinity of the 600 metres failed to respond to her riding and finished the event off poorly. STRAVINSKY CODE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
