# RACE 1 : LOCK AG SERVICES / WUDINNA HARWARE RATING 0-58 HANDICAP - 1000 metres

BLACK JUGAH (S. Westover) jumped away awkwardly and shifted out onto EXALTED OMEGA (S. Carr) taking that mare out onto DEEP BLUE (R. Mayers).

BEE IN HER BONNET (K. Brooks) laid out from in the vicinity of the 400 metres.

S. Westover, the rider of BLACK JUGAH, was examined by the First Care Medical Personnel following the event and ruled fit to fulfil his remaining engagements.

#### RACE 2: WILSON SHEARING / SABOIS MAIDEN PLATE - 1200 metres

EPONA REBEL (A. Doyle) jumped away awkwardly and as a result was slow to begin.

In the vicinity of the 400 metres SUPERMOSA (NZ) (R. Mayers) shifted in and away from GOT TO HURRY (B. Hoppo), which rolled in. As a result SUPERMOSA (NZ) contacted the running rail. R. Mayers, the rider of SUPERMOSA (NZ), was examined by the by the First Care Medical Personnel who ruled her unfit to fulfil her remaining engagements.

BEYOND THE BATTLE (M. Henderson) was inclined to lay in, in the straight.

## RACE 3: RAMSEY BROS / MURRAY PEST CONTROL BENCHMARK 72 HANDICAP – 1200 metres

The start of this event was delayed approximately twelve minutes due to a member of the public requiring First Aid from the First Care Medical Personnel.

On jumping away CASINO EXIT (S. Westover) shifted in onto SUPERBAD (B. Hoppo) taking that gelding in onto SWEET NEVER (A. Doyle), which was tightened onto ARTIE'S ANGEL (K. Brooks). As a consequence SUPERBAD and SWEET NEVER were unable to maintain their positions.

# RACE 4 : LOCK HOTEL / WEST END / BILL HITCHCOCK MEMRIAL RATING 0-62 HANDICAP - 1400 metres

On arrival at the barriers EASY MISS, which contacted a perimeter fence in the mounting yard en route to the barriers was examined by the Club's Veterinary Surgeon who ruled the mare unfit to race. Acting on this advice, Stewards withdrew EASY MISS at 3.00 pm. Stewards ordered that all monies invested on EASY MISS be refunded and that all successful wagers be subject to the deductions of 12 cents in the dollar for a win and 12 cents in the dollar for a place.

NORTHSIDE STAR (A. Doyle) jumped away awkwardly, dipped and dislodged its rider. A. Doyle was examined the by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

Correct weight for this event was delayed to allow Stewards to take evidence from A. Doyle, the rider of NORTHSIDE STAR and the starter, Mr G. Woods and to view the vision of the start. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards declared NORTHSIDE STAR a starter.

#### RACE 5: IRON ROAD LIMITED LOCK CUP - 1900 metres

EMMOOKI'S DASH was reluctant to proceed to the barriers. Trainer Mr M. Whittle was advised a warning had been placed on the gelding regarding its pre-race behaviour.

EXCLUDED (NZ) was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed the gelding fit to race.

Inside the 400 metres JAPAN (E. Finnegan) was obliged to be steadied when tightened for room between EXCLUDED (NZ) (T. Baker), which had begun to weaken and rolled out and MONTALTO (A. Doyle), which rolled in.

T. Baker, the rider of EXCLUDED (NZ) reported that from inside the 300 metres he became concerned with the gelding's breathing and eased it out of the event. EXCLUDED (NZ) was examined by the Club's Veterinary Surgeon who reported abnormal respiratory noise. Trainer, Mr D. Carrison was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

## RACE 6: LOCK IGA / REYNOLDS DIESEL SERVICES RATING 0-58 HANDICAP - 1800 metres

On arrival at the barriers WIN FOR WILSON was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

On jumping away ROULETTE PRINCE (T. Baker) shifted out taking WIN FOR WILSON (S. Carr) out and across CAPTAIN PERCY (E. Finnegan), which was taken in by HERO TO VILLIAN (M. Henderson), which jumped away awkwardly and shifted in. As a consequence CAPTAIN PERCY was unable to maintain its position.

S. Carr, the rider of WIN FOR WILSON, reported that she became concerned with the gelding's action from in the vicinity of the 600 metres and eased it out of the event. WIN FOR WILSON was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr T. Trenowden, the Trainer of WIN FOR WILSON, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
